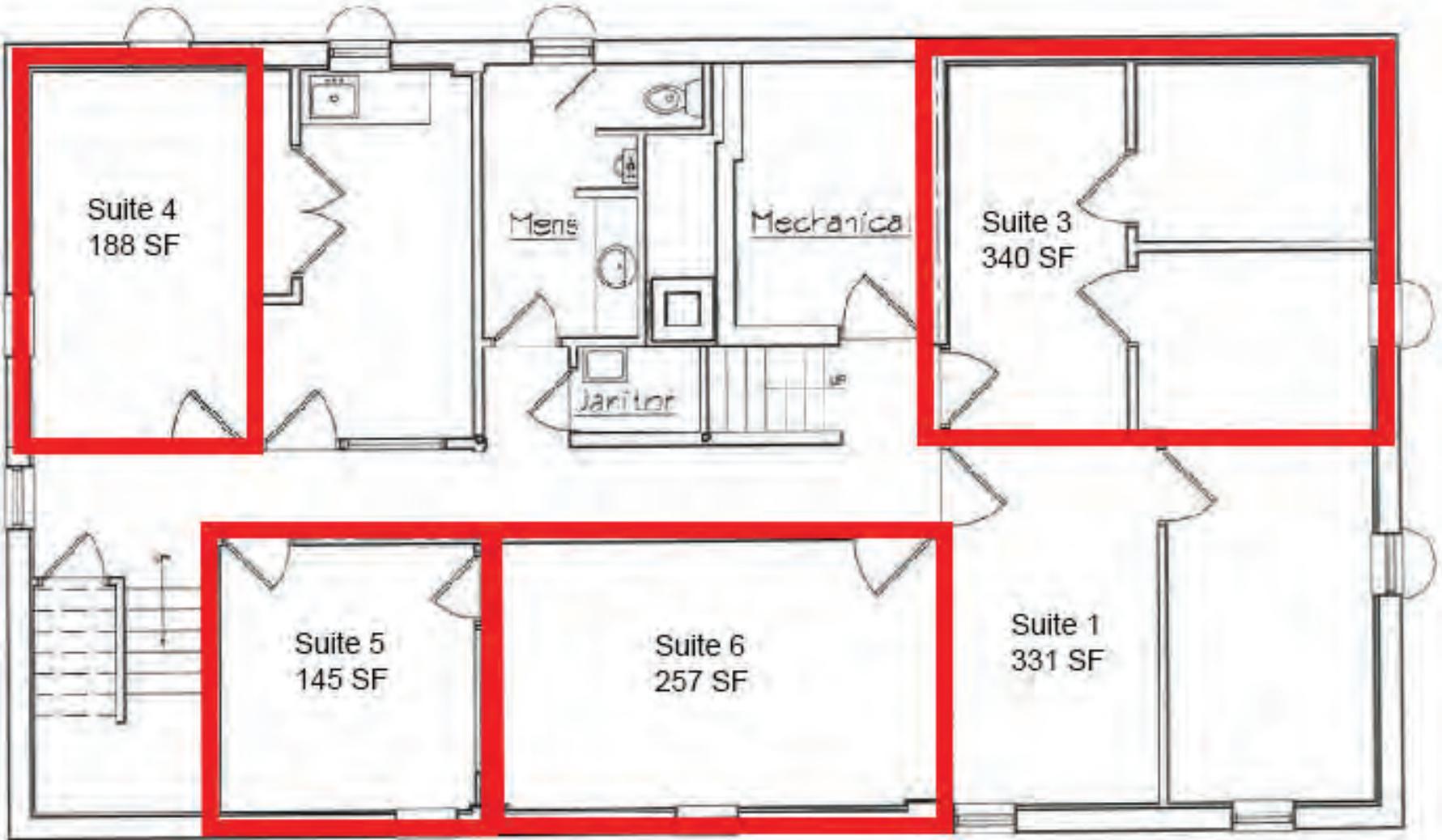

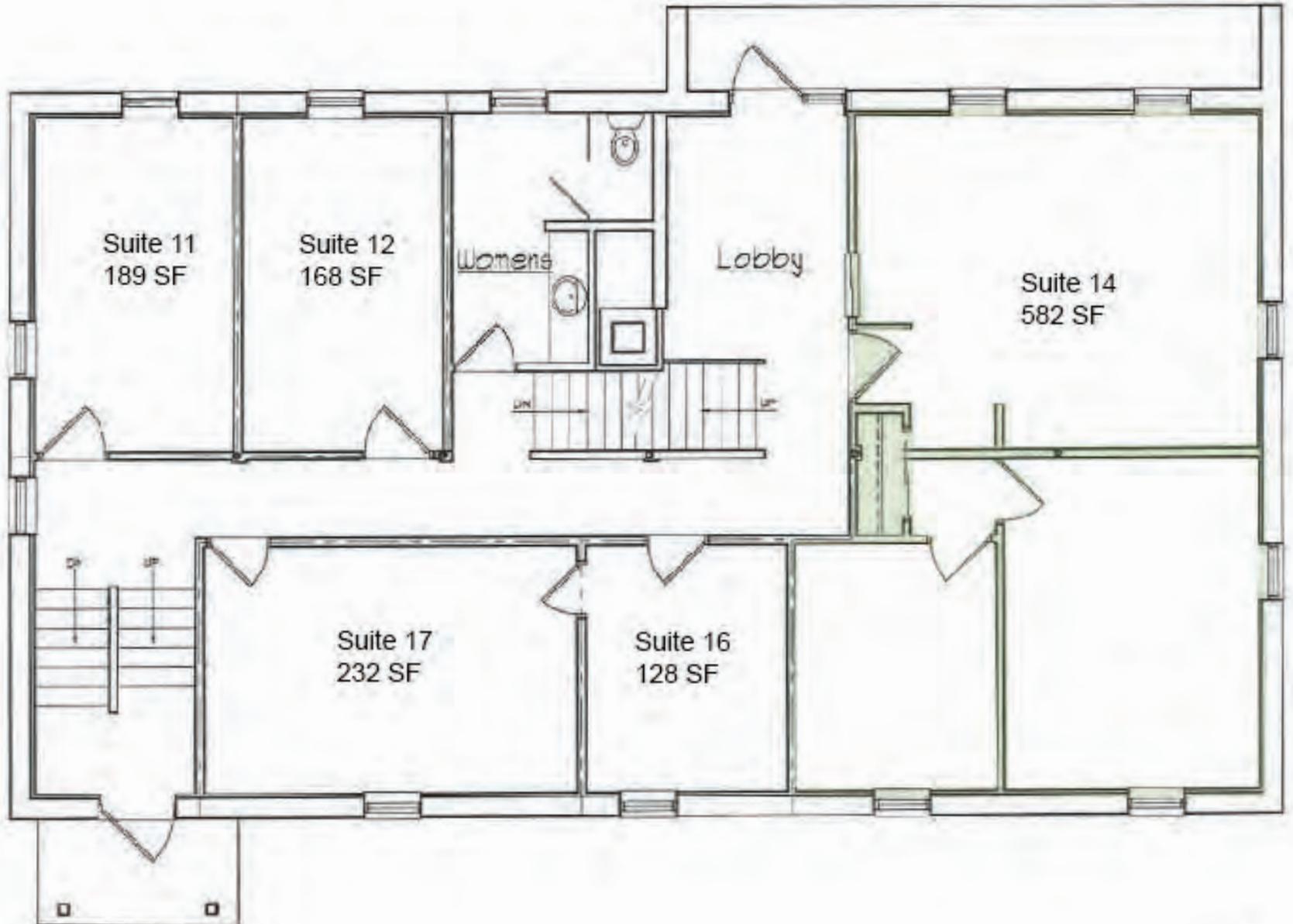

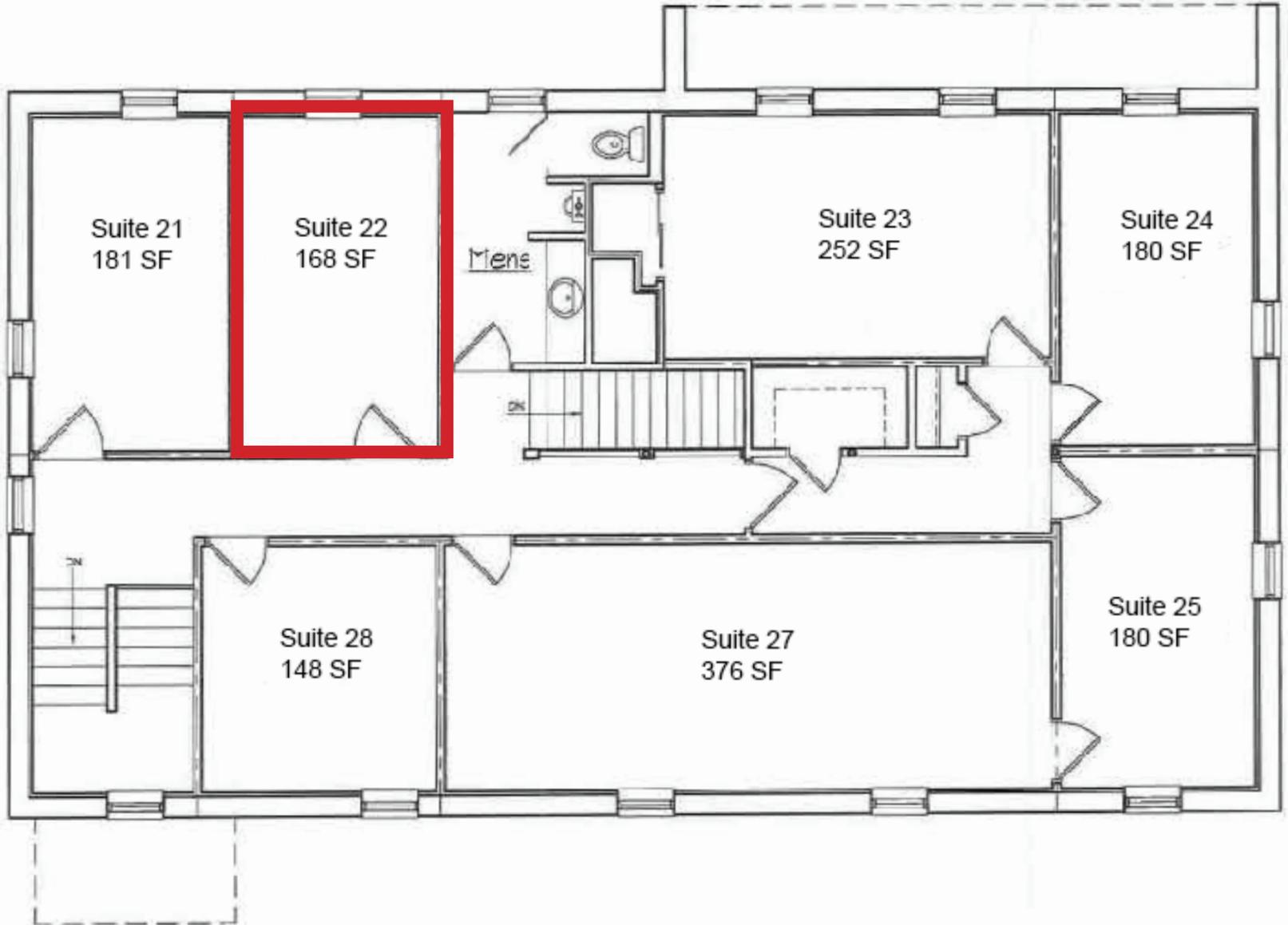
First Floor

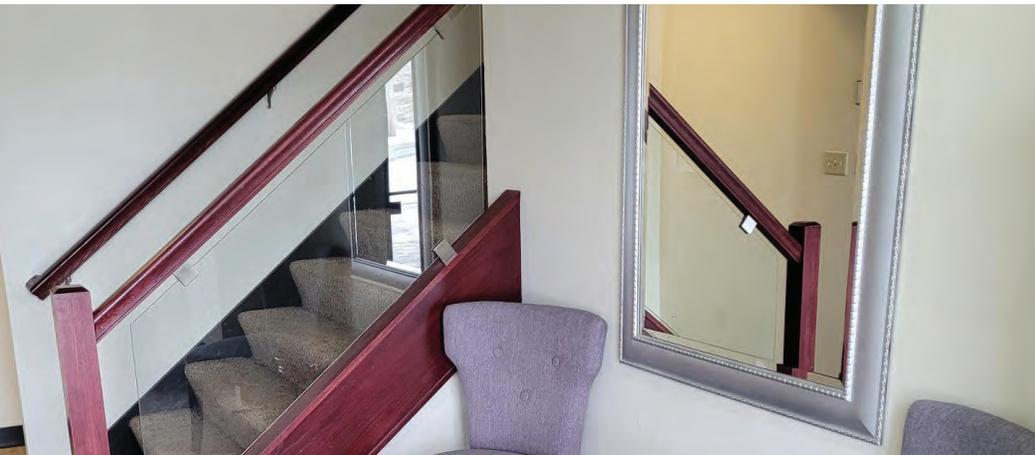

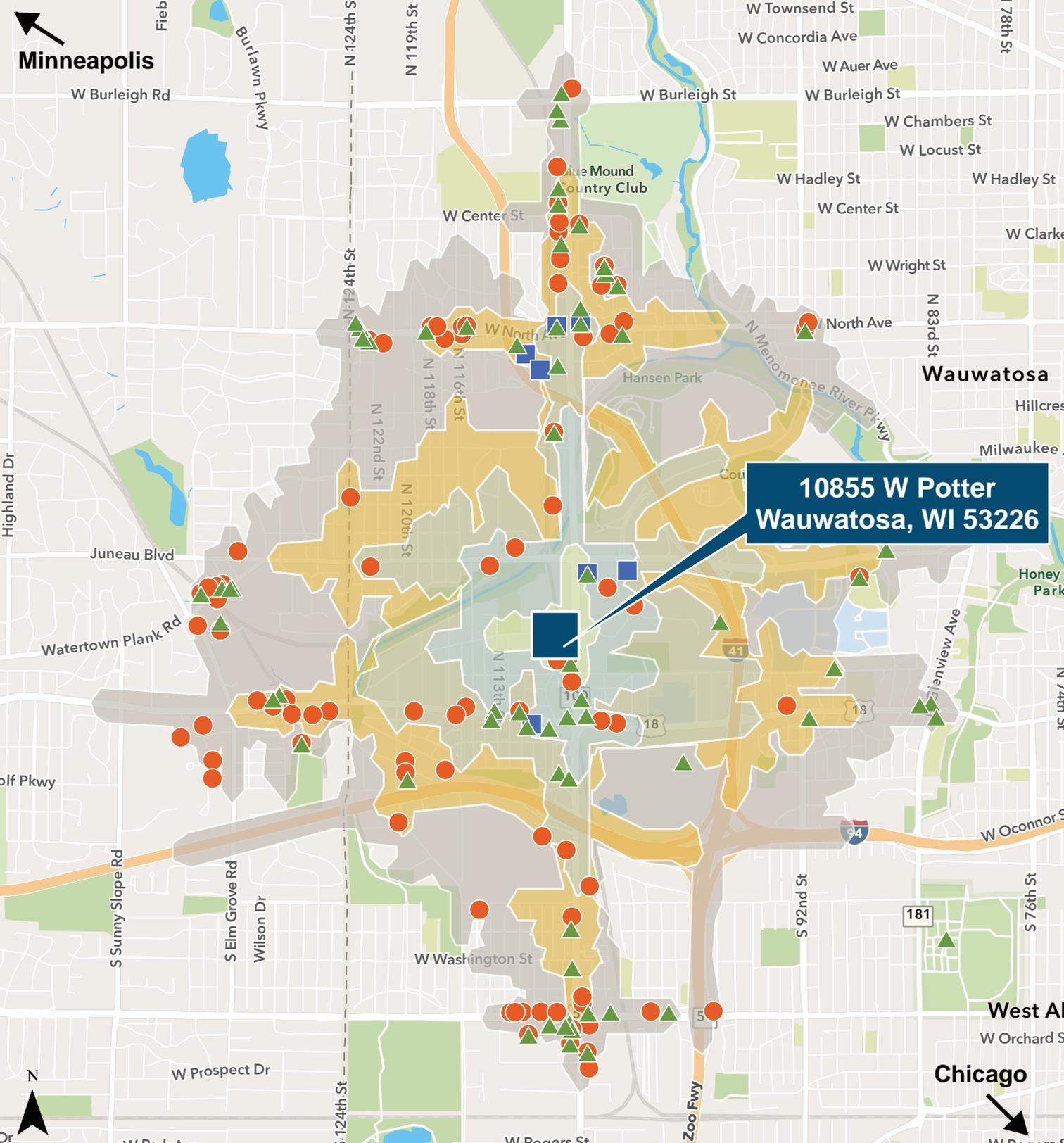

STATE OF WISCONSIN BROKER DISCLOSURE
