LOCATION MAP



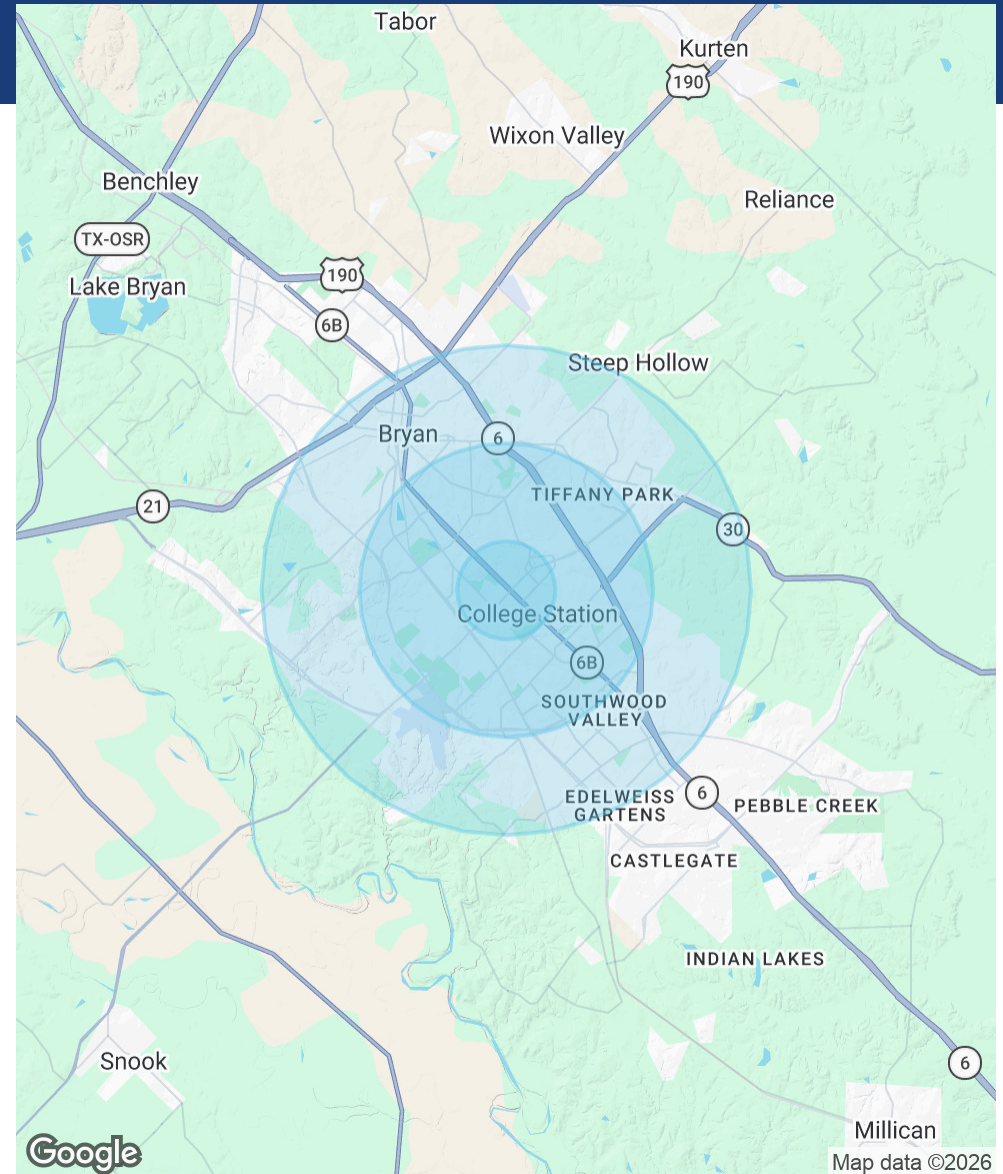
