## PROPERTY OVERVIEW

Constructed in 1966, the property features three structures including a 19,000 SF primary industrial building, a 3,744 SF maintenance/shop building, and a 484 SF tool shed. The main building is comprised of: 18' clear heights, 3 dock doors, 1 drive in door, 385 SF two story office, 600 AMP 480V 3-Phase power, and 1 restroom. The building was formally used for plant-based oil refining and received a new roof around 2016. The maintenance building features: 14'7" clear heights, heat, electricity, plumbing (no restroom), and 2 drive in doors (pass through). The tool shed is a small 22' x 22' shed on the far west of the property. The entire property is fenced with roughly 2 acres of lot/laydown yard.

The property is located off Martin Luther King Jr Dr. and E. Pythian Ave, just south of Pershing Rd. in North Decatur. The area is surrounded by a mixed use of industrial users, residential properties, and retail. Decatur IL is centrally located lying 40 miles east of Springfield (IL), 45 miles south of Bloomington-Normal, 50 miles southwest of Champaign-Urbana, 135 miles northeast of St. Louis (MO), 150 miles west of Indianapolis (IN), and 180 miles southwest of Chicago.
