THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN ORDAINS AS FOLLOWS:

Section 1. This ordinance shall be published in accordance with Government Code section 25124 and it shall take effect and be in full force on and after the 1st day of March, 2025.

Section 2. Section 7297.630 of the Kern County Ordinance Code is amended as follows:

SECTION 7297.630

C-2 PD (GENERAL COMMERCIAL - PRECISE DEVELOPMENT COMBINING) DISTRICT; located approximately at 301 & 321 Morning Drive, Bakersfield area; Assessor's Parcel Numbers: 388-211-11 and 388-211-13.

The land use or zoning map referred to in Section 7297.630 is amended as follows:

The zone district of the described property is changed from E (1/2) RS (Estate 1/2-acre minimum - Residential Suburban Combining) to C-2 PD (General Commercial - Precise Development Combining), or a more restrictive district, on approximately 0.9 acres. The property is situated in the County of Kern, State of California, and described as follows:
