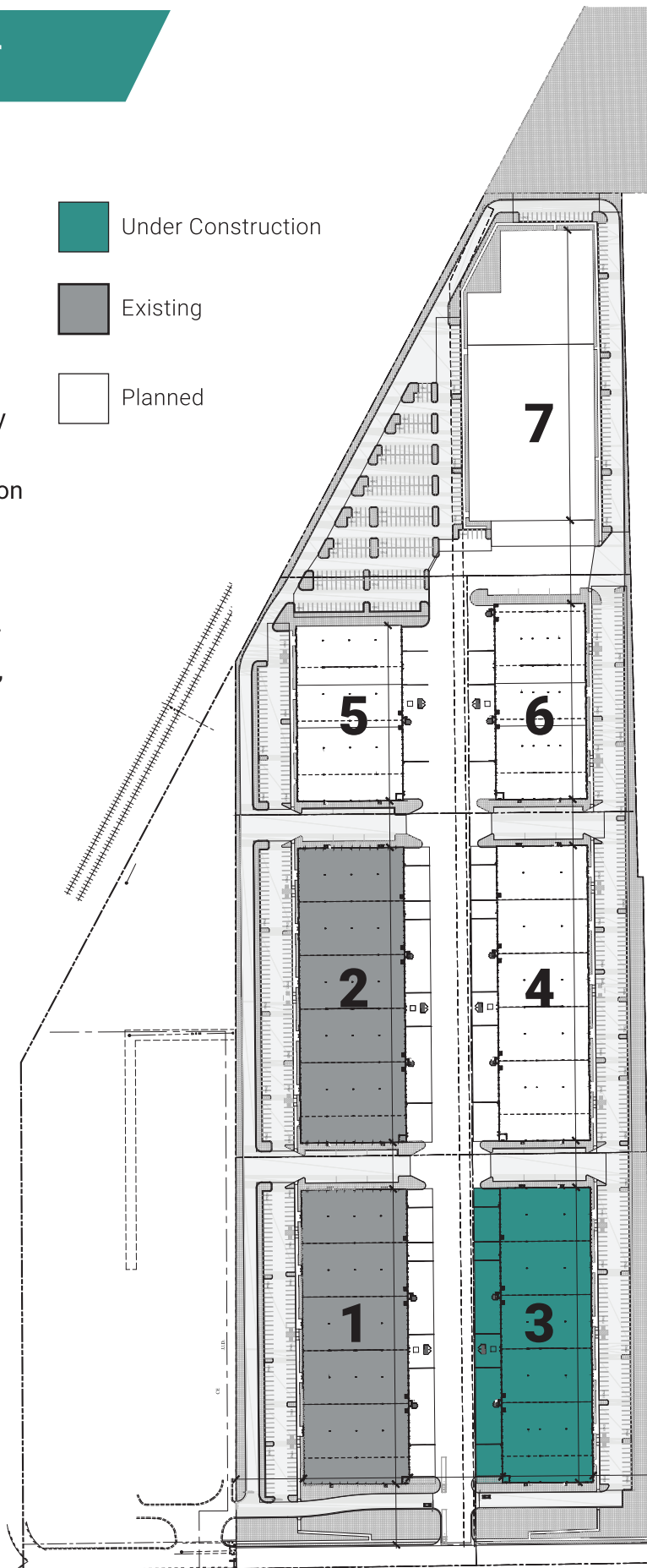
Mountain Point Business Center is strategically located in the heart of South Salt Lake County sub-market offering access to the two population centers in Utah.

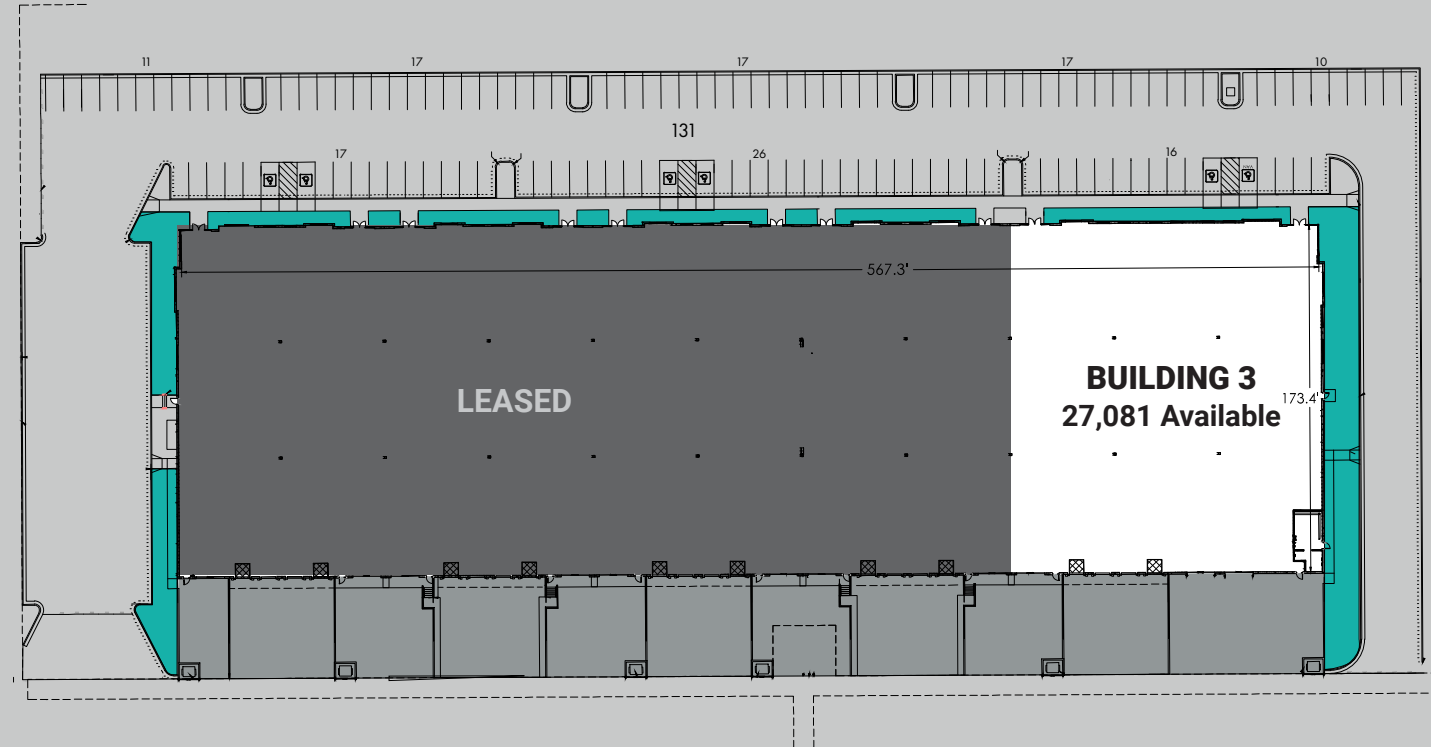
