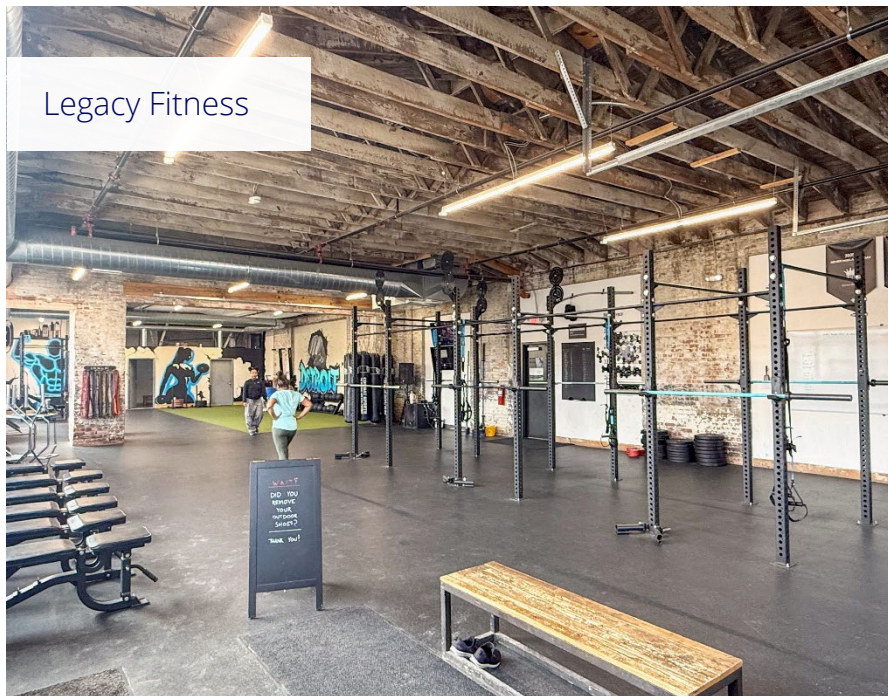

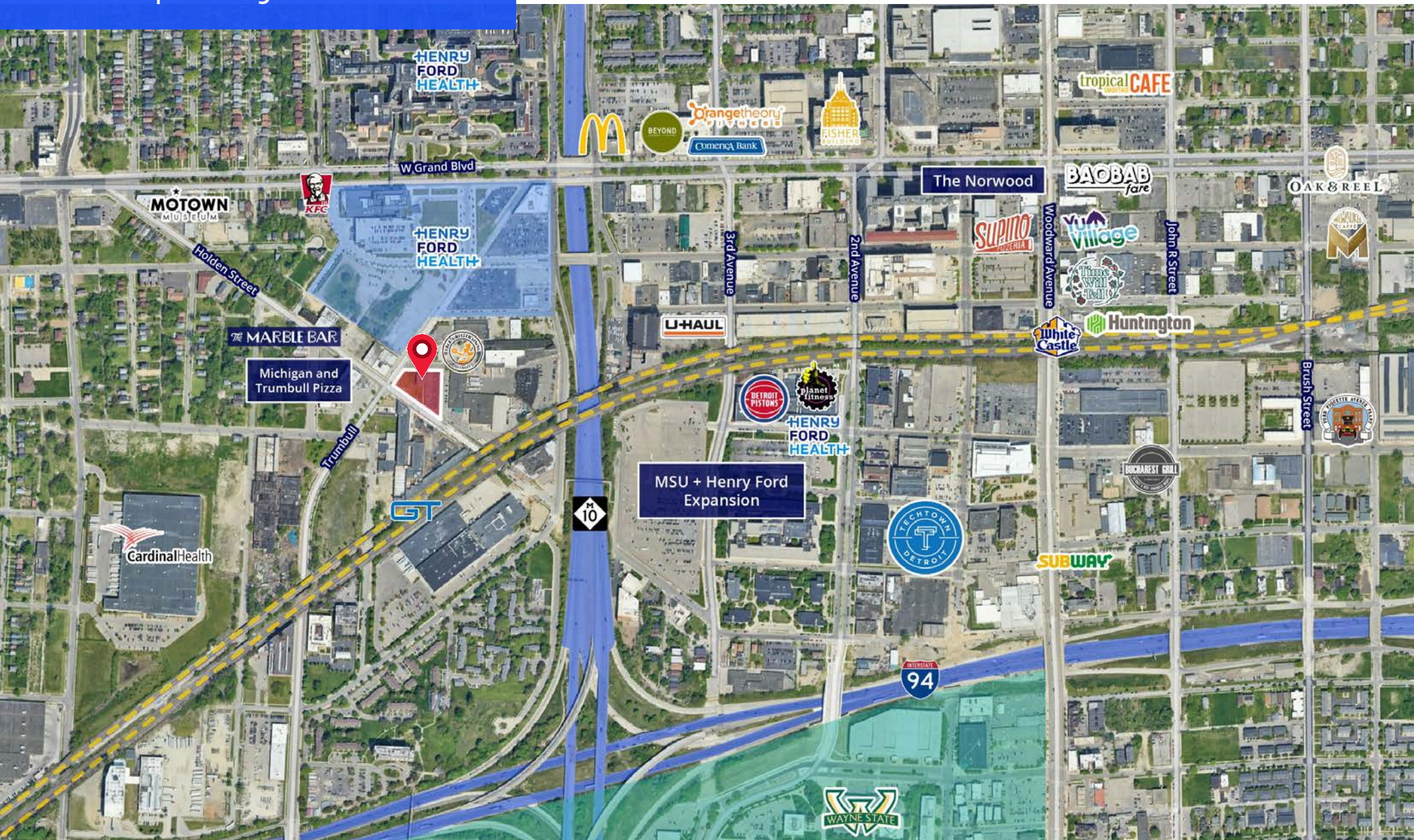

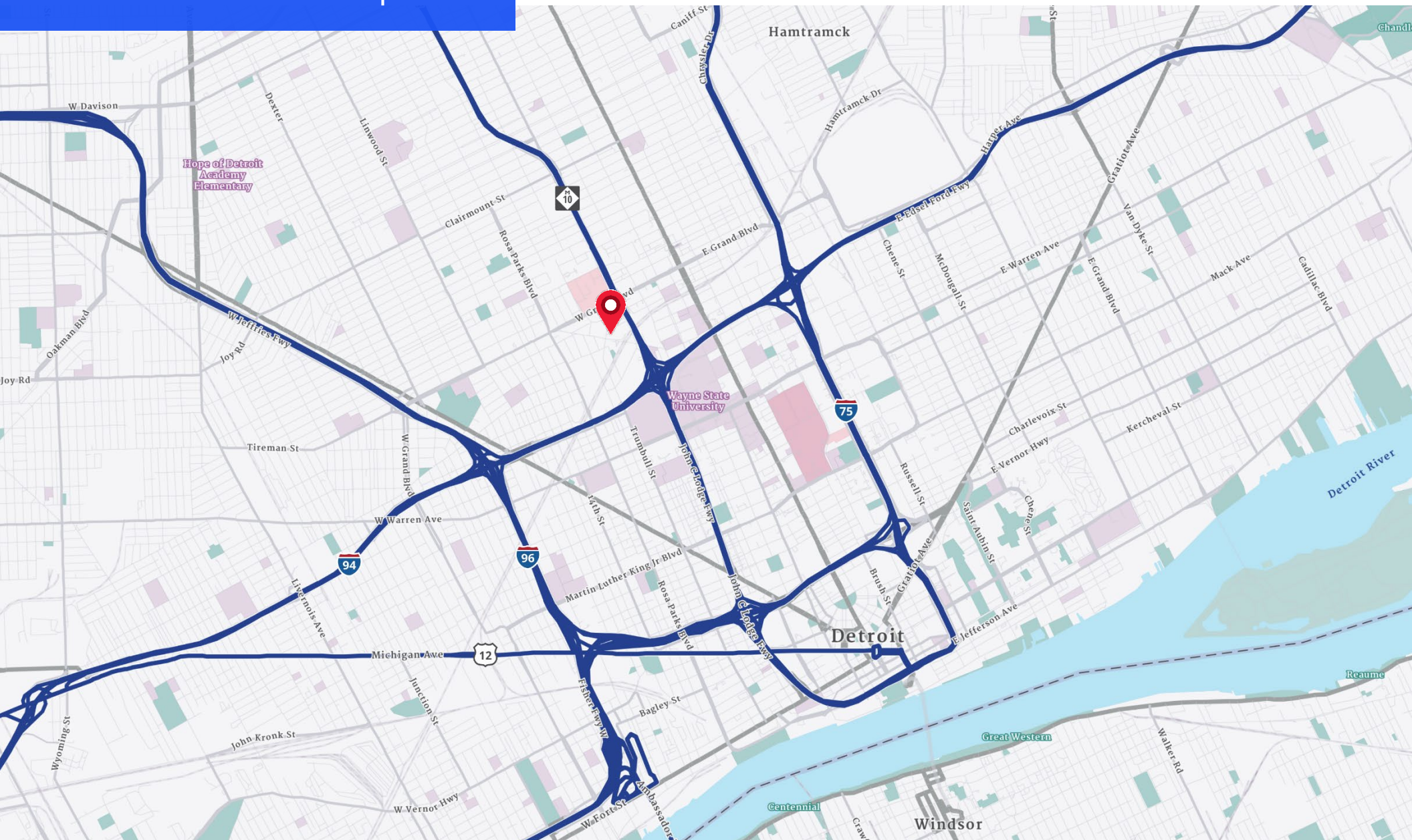
Henry Ford Expansion
