This beautiful, 3-story offering presents two stories on Riverside Drive and opens its third story to the west, where exists a quiet Serenity Garden, a pedestrian walk bridge that spans a small brook, and a large granite-block base picnic area. The stunning, professionally landscaped site also includes views of the Fox River and the Fox River Walking Trail. A 3-stall maintenance building with security cameras, as well as an additional 2-stall open storage area serve the property. A total of four paved/lighted parking lots totaling 419 stalls can be found on the north and west sides of the building.

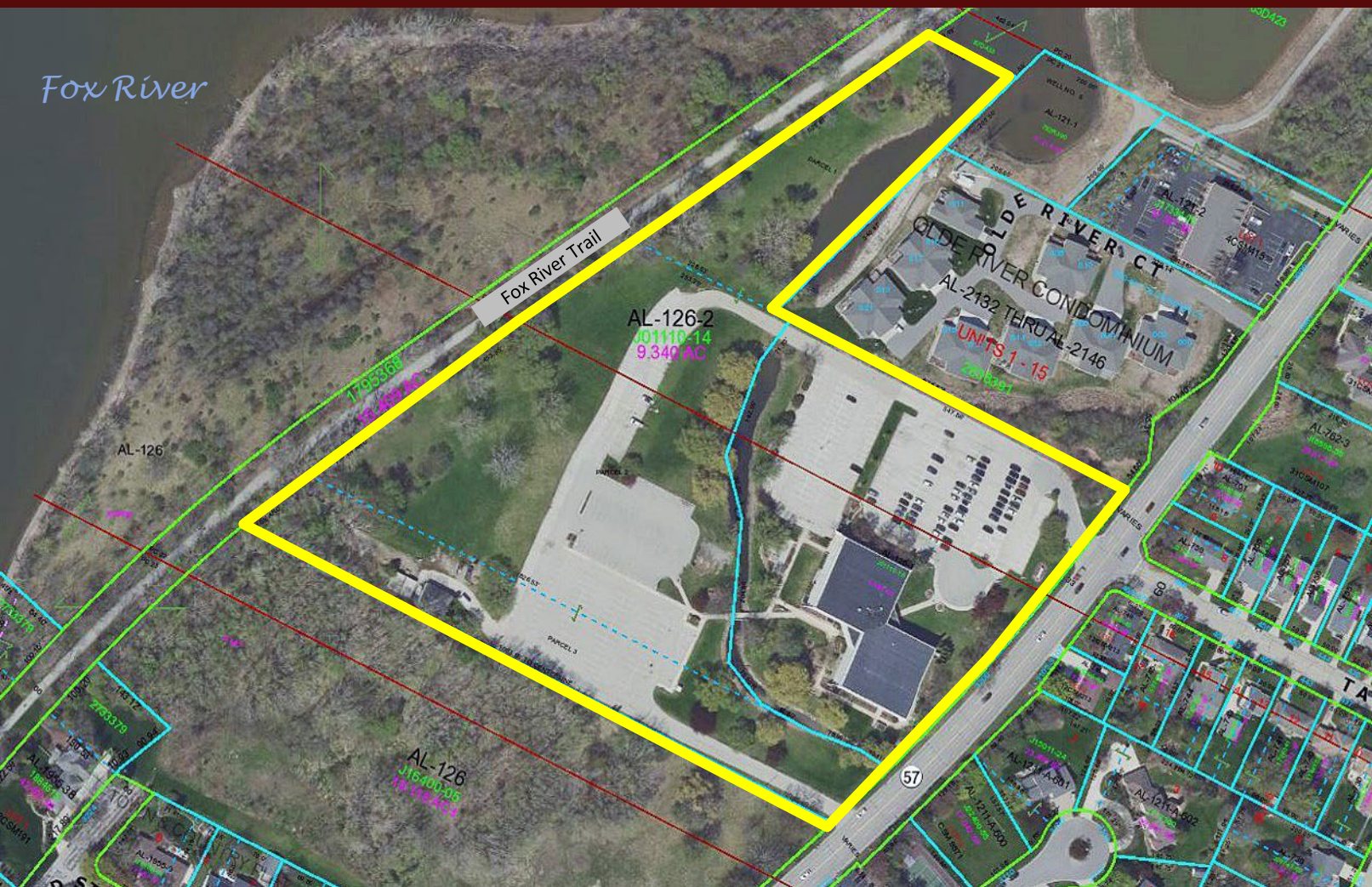

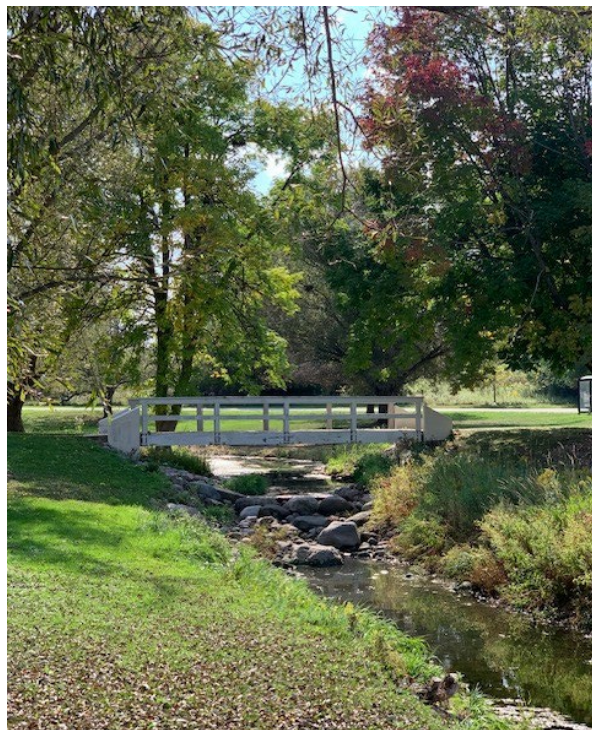
