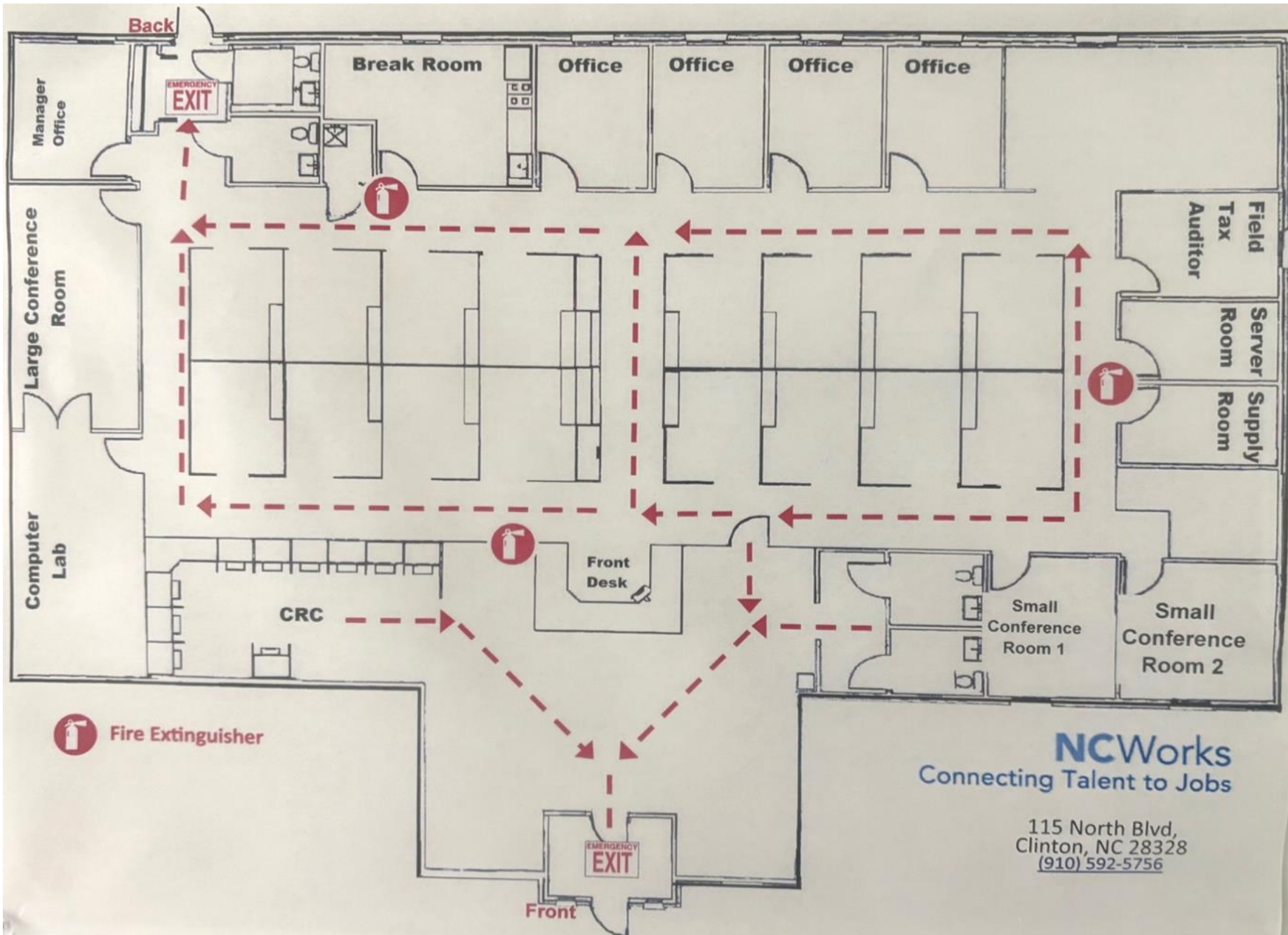

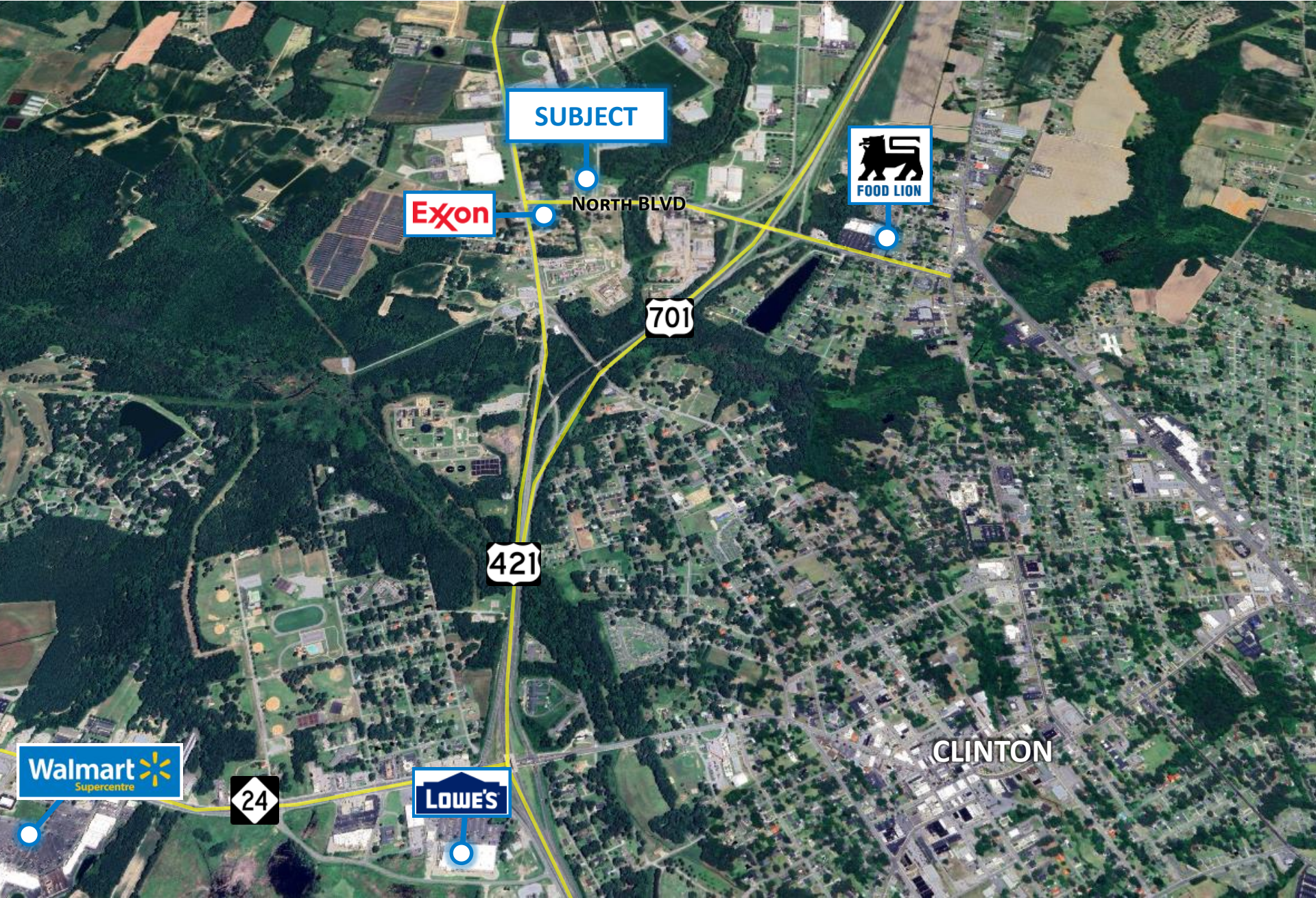
# SITE PLAN



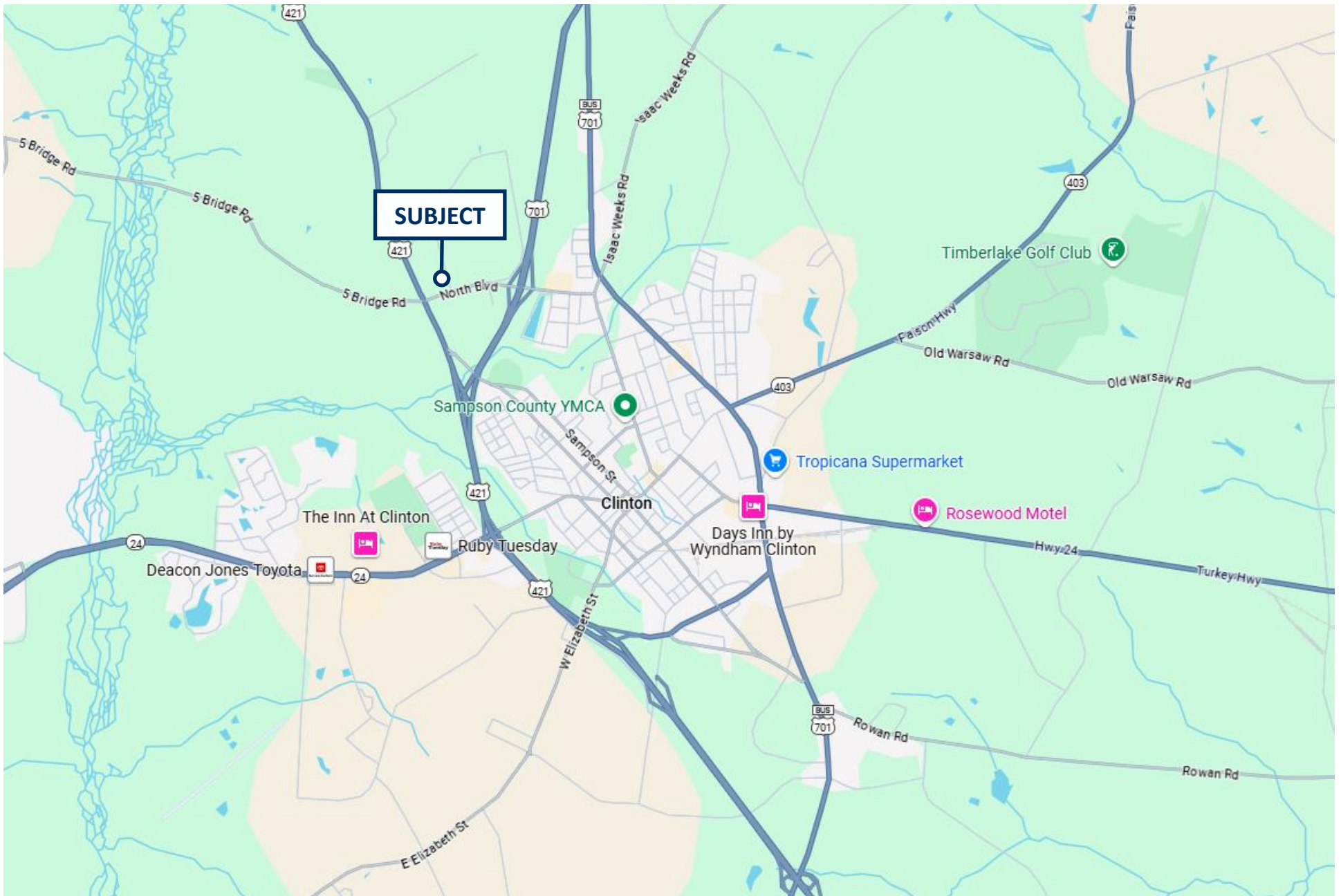
# GIS AERIAL
