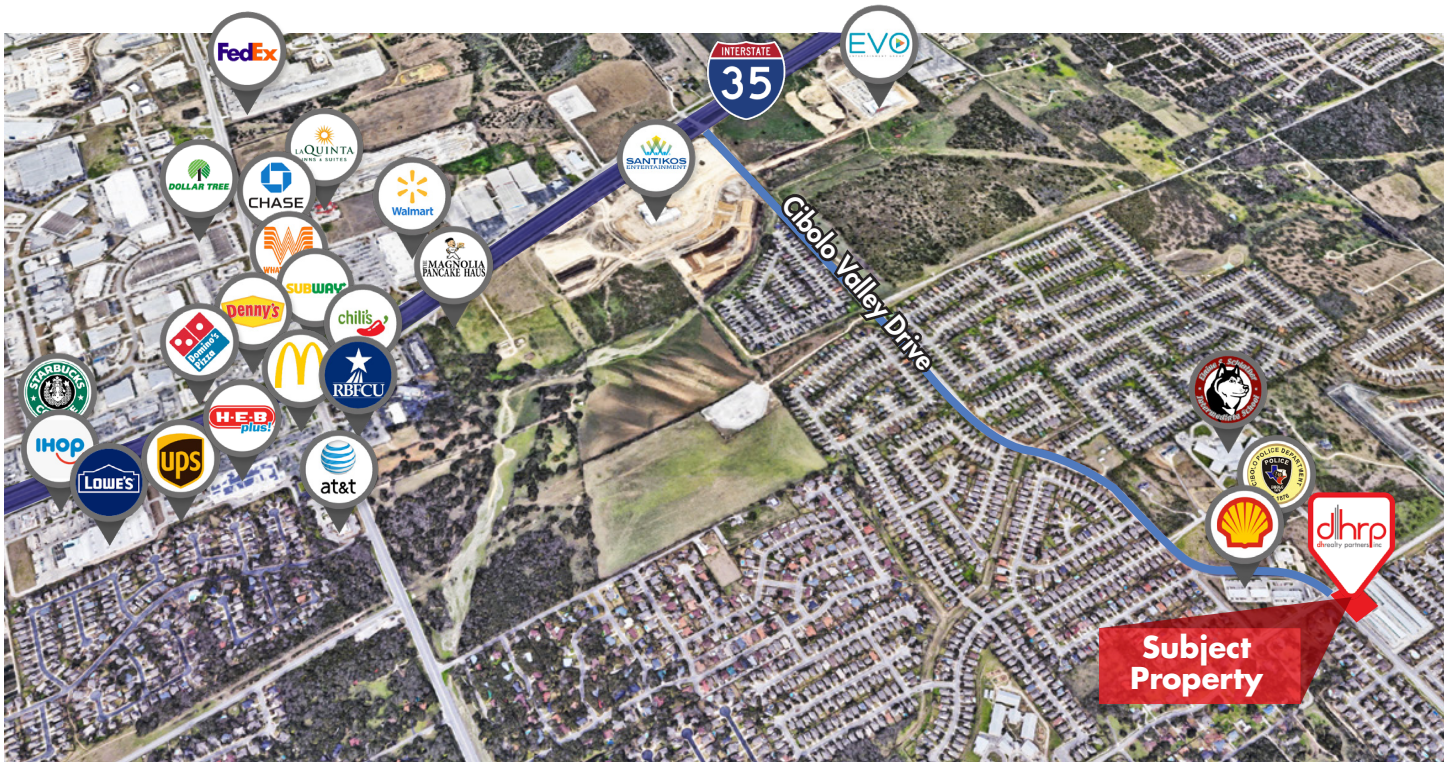

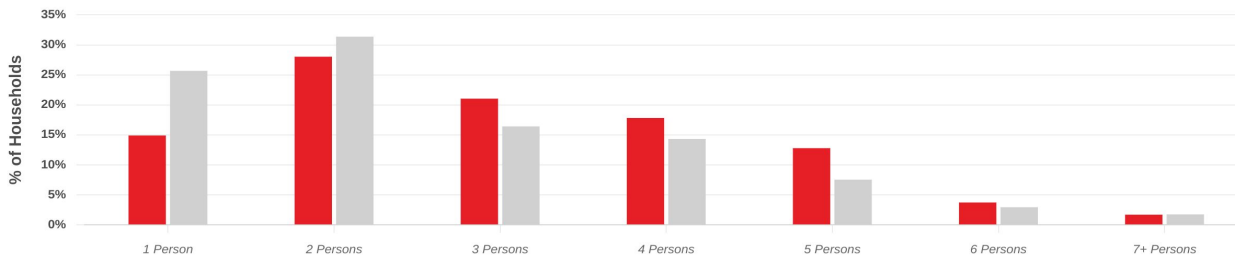

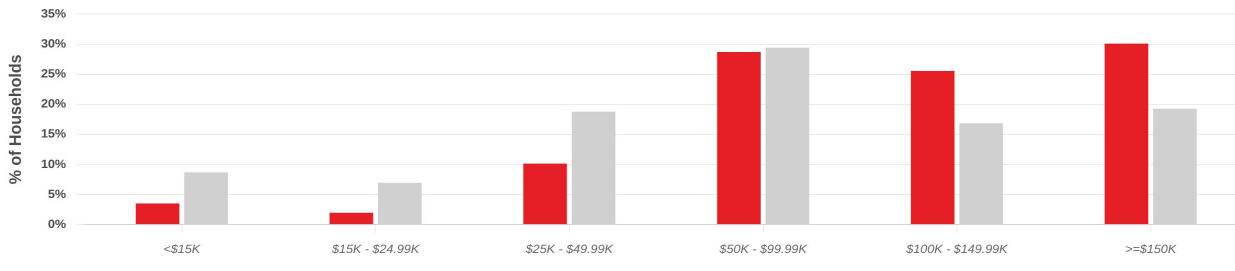

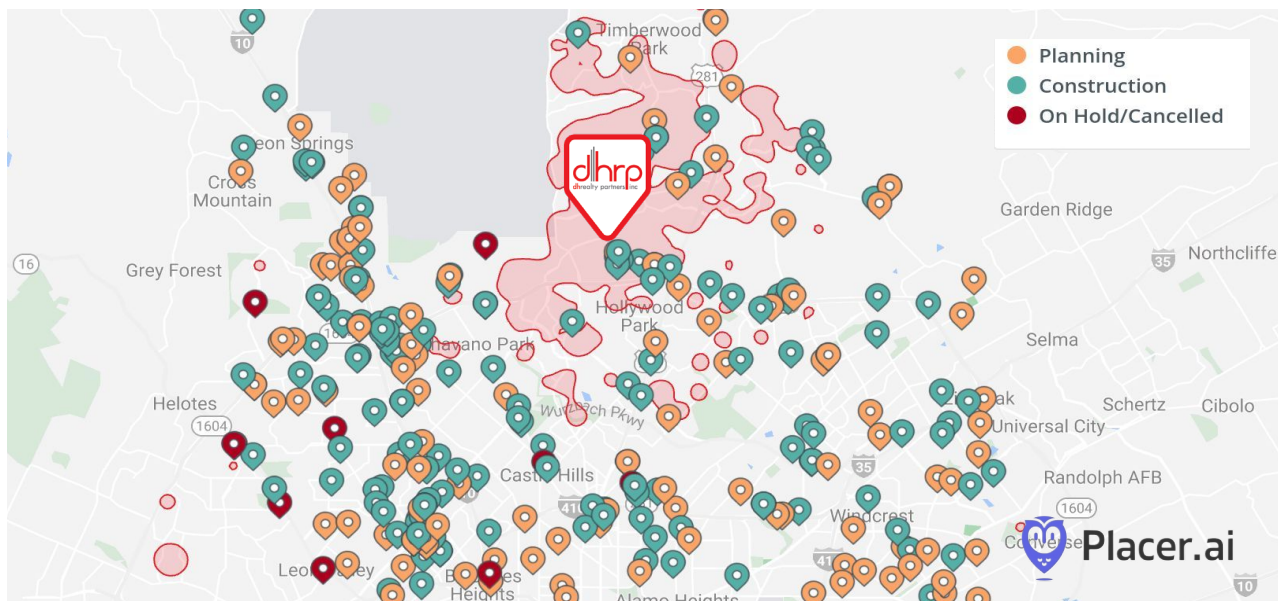

PLANNED VS. CONSTRUCTION MAP

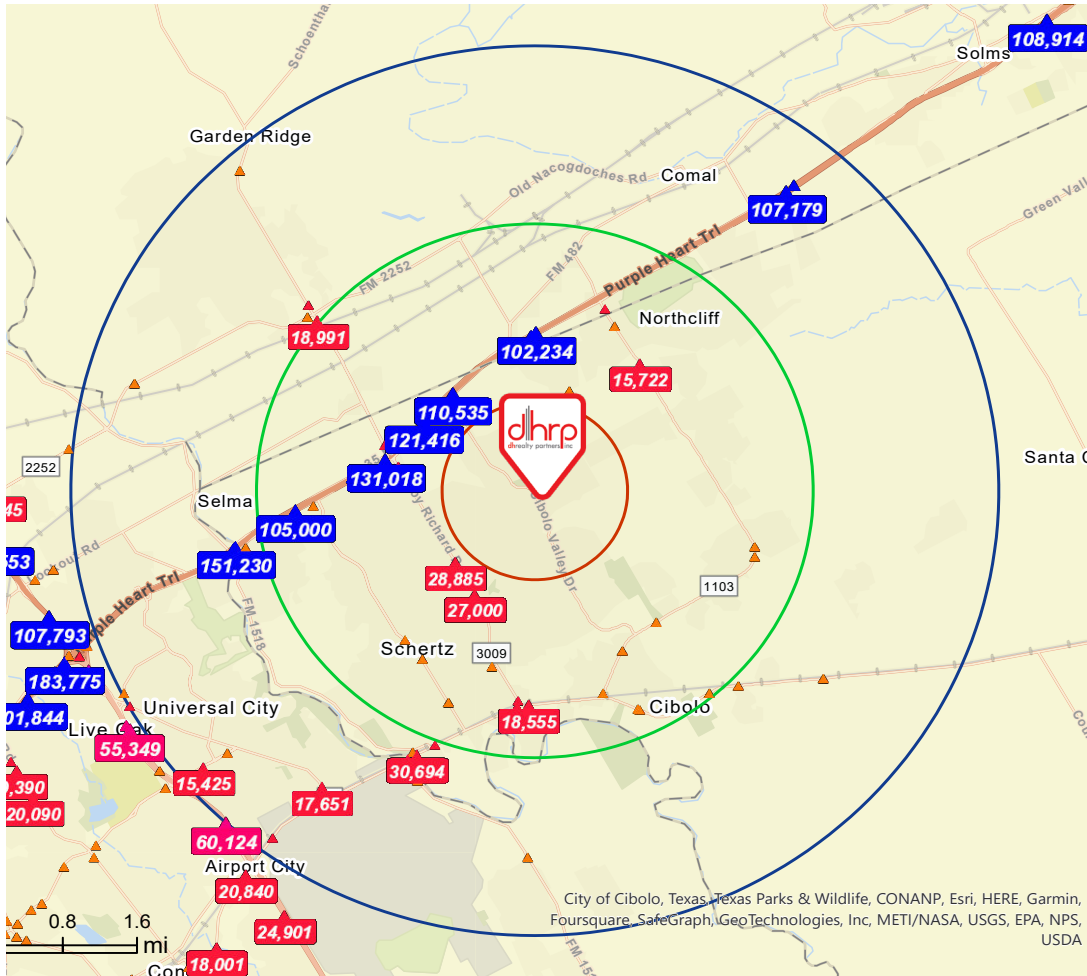
