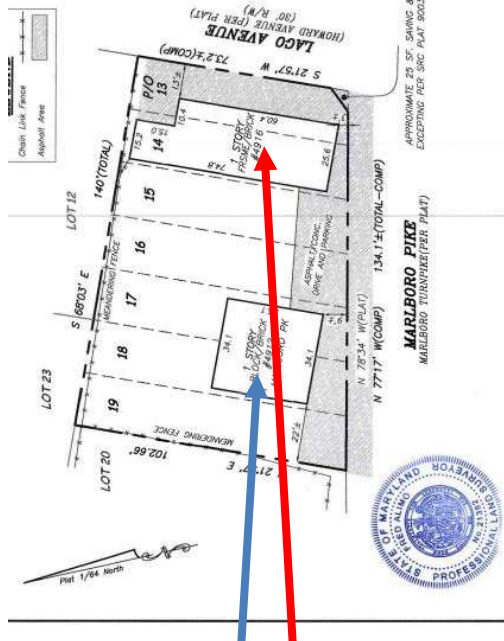

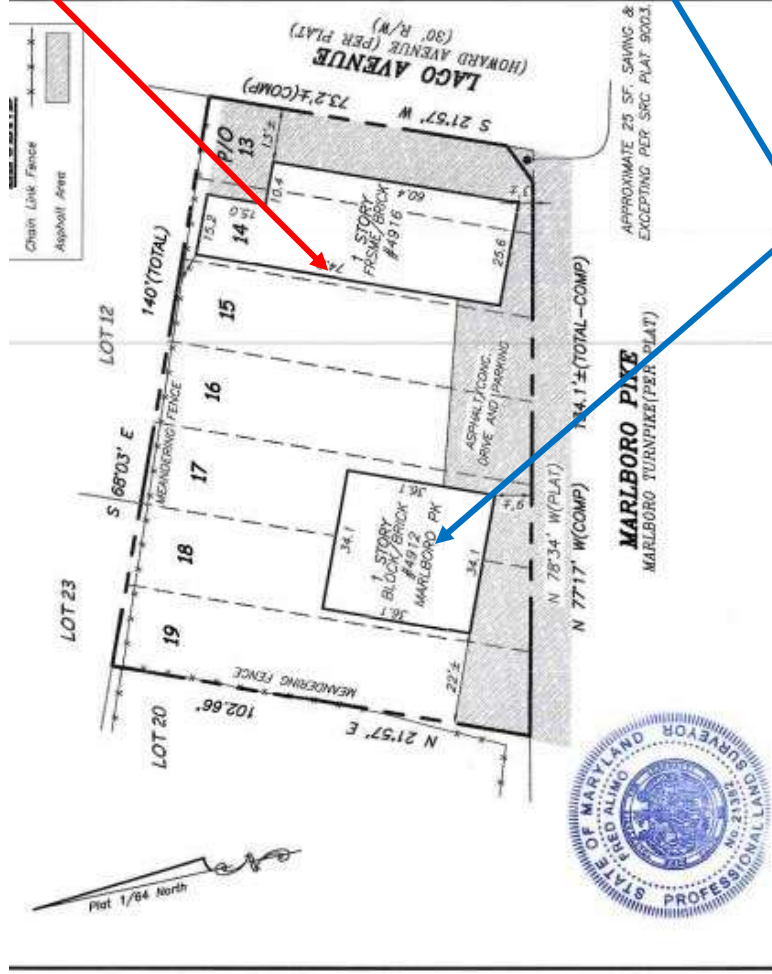

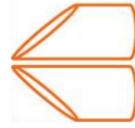

4916 (Corner) Flex Building = ~1,760 sq/ft



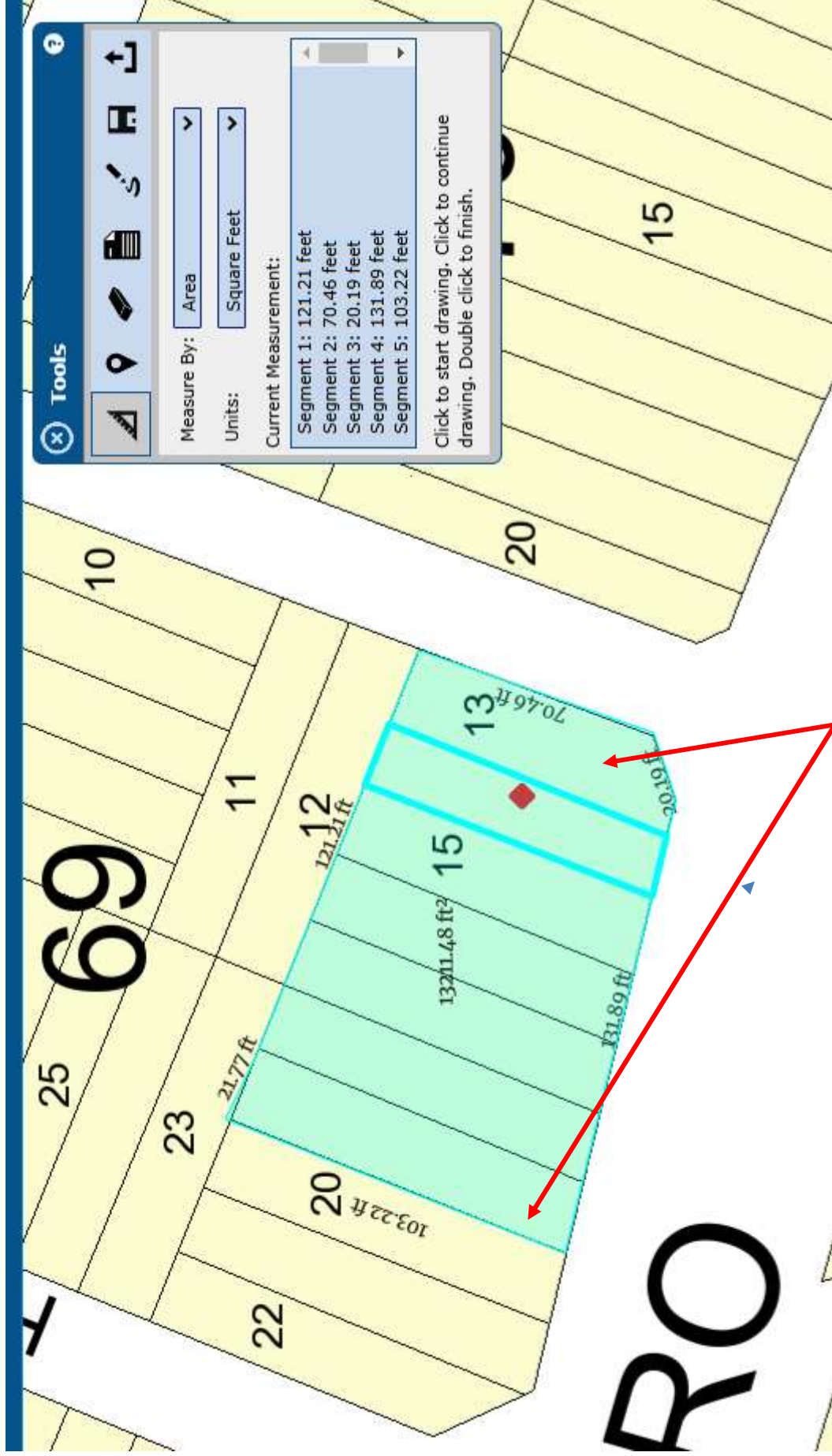
4912: Office / Retail Building = ~1,230 sq/ft

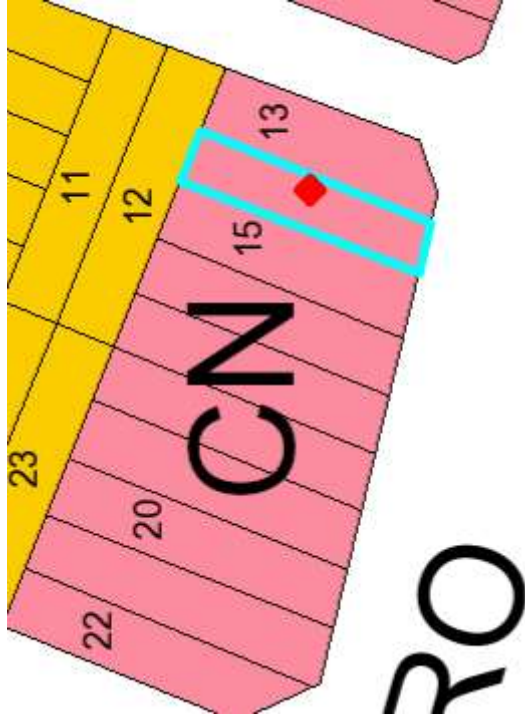

PG Atlas Lot Line Measurement

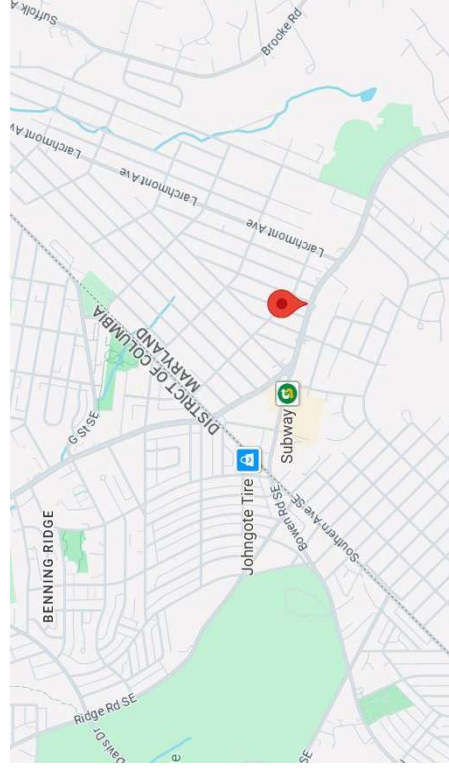

Matter of right uses within the CN zone include: Community gardens, Urban agriculture, Artists' Studios, Bed and breakfasts (as accessories to single-family dwellings), Broadcasting Studios or Newspaper Publishing, Hotels or motel, Cultural facility, Daycare, Church, Emergency services facility, Medical or dental office or lab, Art gallery, Art, photography, music, dance, yoga, pilates, or martial arts studio or schools, Manufacturing, artisan or maker, Tattoo or body piercing establishment, All other business support service uses, Restaurant (quick-service without a drive-through), Catering or food processing for off-site consumption, Contractor's office, General business, and professional office, Private Club/Lodge, Shared Kitchen, Alcohol production facility, performance art's center, Bank or ATM, C-store, Pharmacy or Grocery Store, Consumer good establishment or Food Hall.

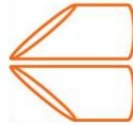
