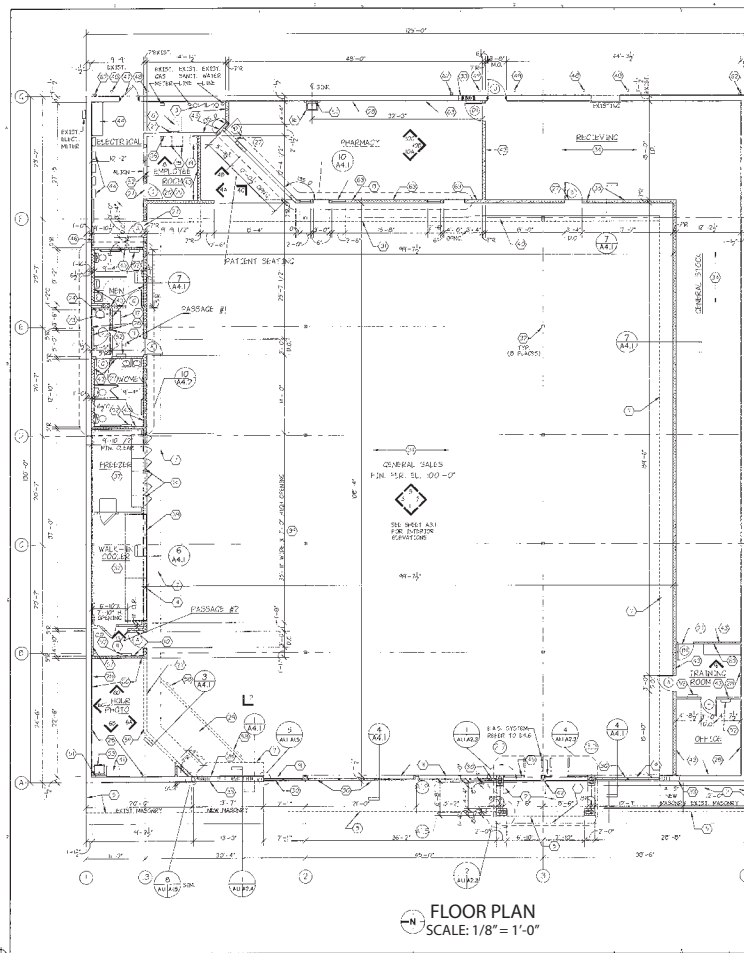

SITE PLAN

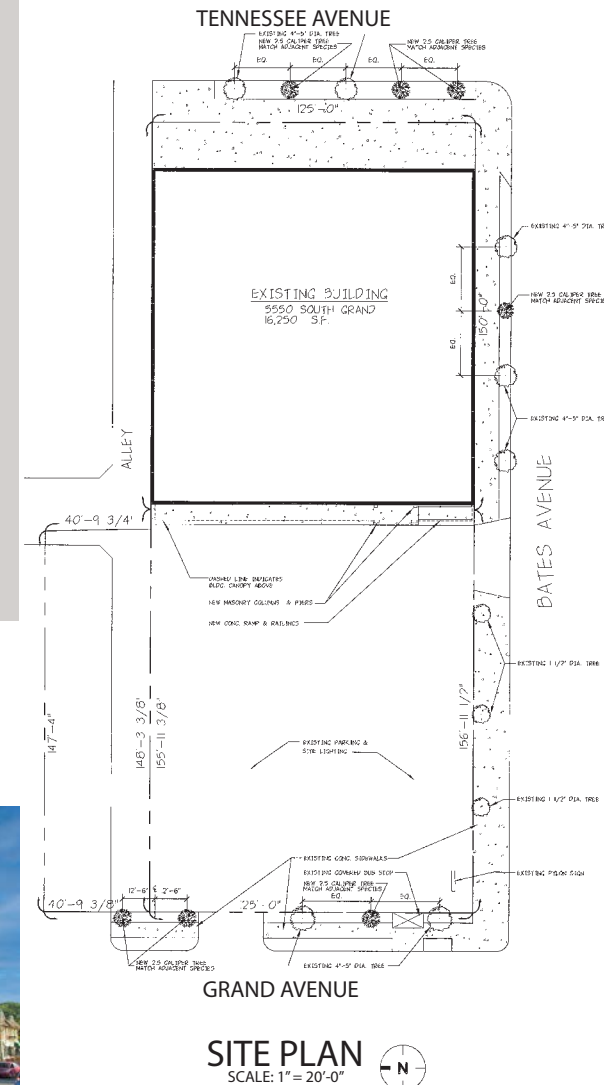
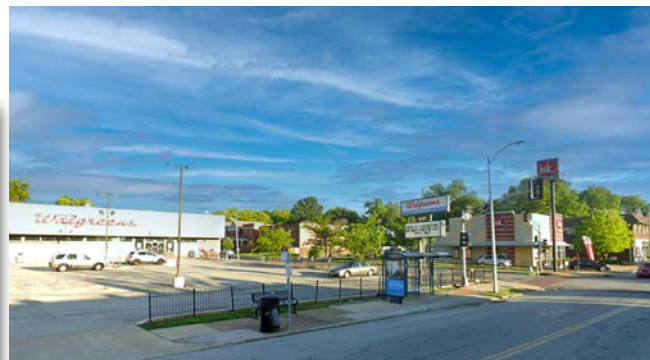
