HONDA AND LG ENERGY SOLUTION PLANT

Honda and LG Energy Solution are developing a new electric vehicle (EV) battery plant in Jeffersonville, Ohio. This joint venture, established in January 2023, represents a significant investment of \$3.5 billion, expected to rise to \$4.4 billion as the project progresses. The plant, covering over 2 million square feet, aims to be completed by the end of 2024 and is set to create approximately 2,200 jobs. The facility will focus on producing pouch-type lithium-ion batteries to support Honda's EV manufacturing operations in North America



Destination Outlets in Jeffersonville, Ohio, is a premier shopping destination featuring a variety of well-known brand stores. Destination Outlets in Jeffersonville, Ohio, previously known as Tanger Outlets, was acquired by new owners and rebranded. This acquisition was aimed at revitalizing the outlet center, which spans approximately 410,000 square feet and houses over 50 upscale designer and brand name stores. Situated conveniently at the intersection of I-71 and Route 35, Destination Outlets is well-positioned to attract a significant portion of Ohio's population, with nearly 4.4 million residents living within a 60-mile radius.
