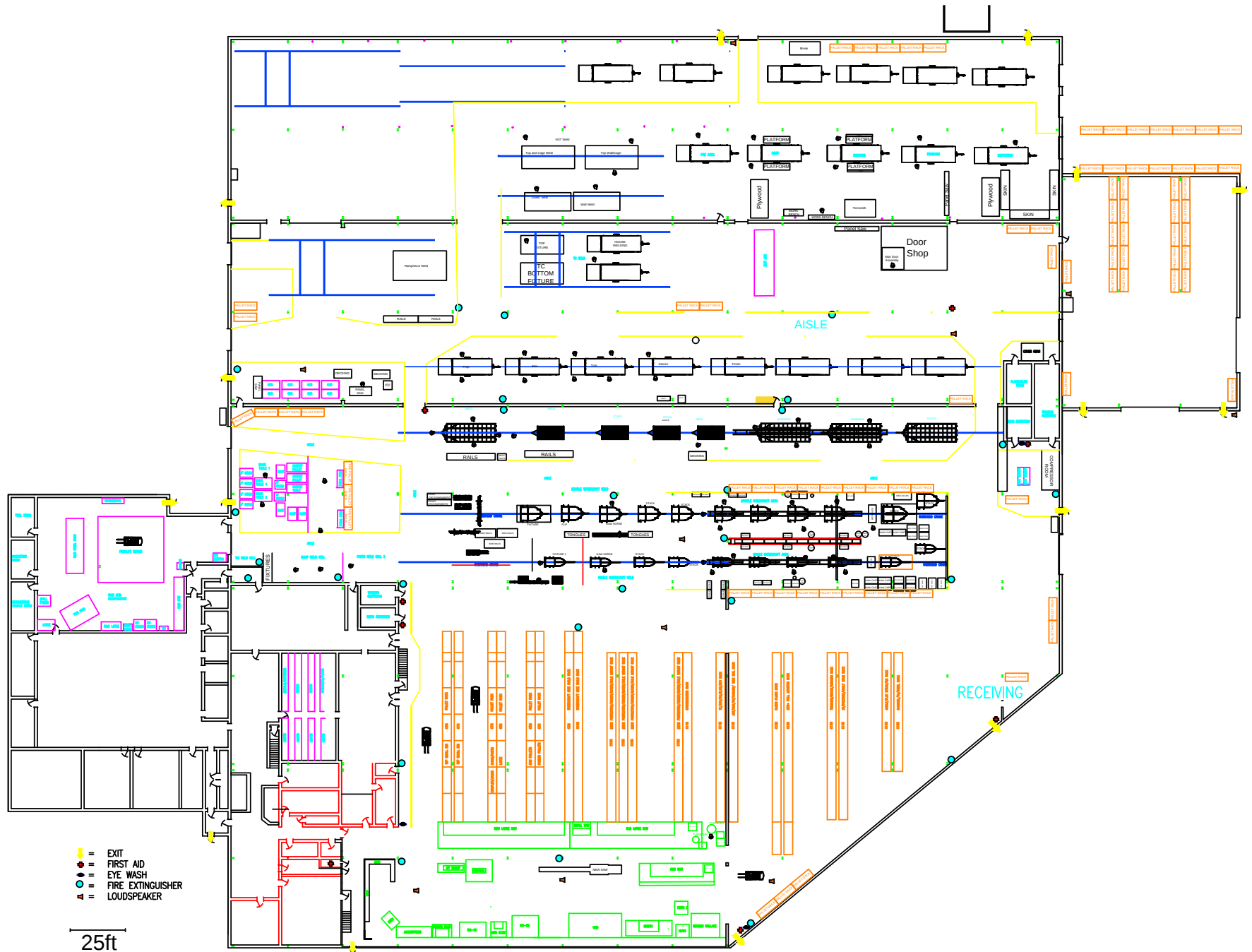

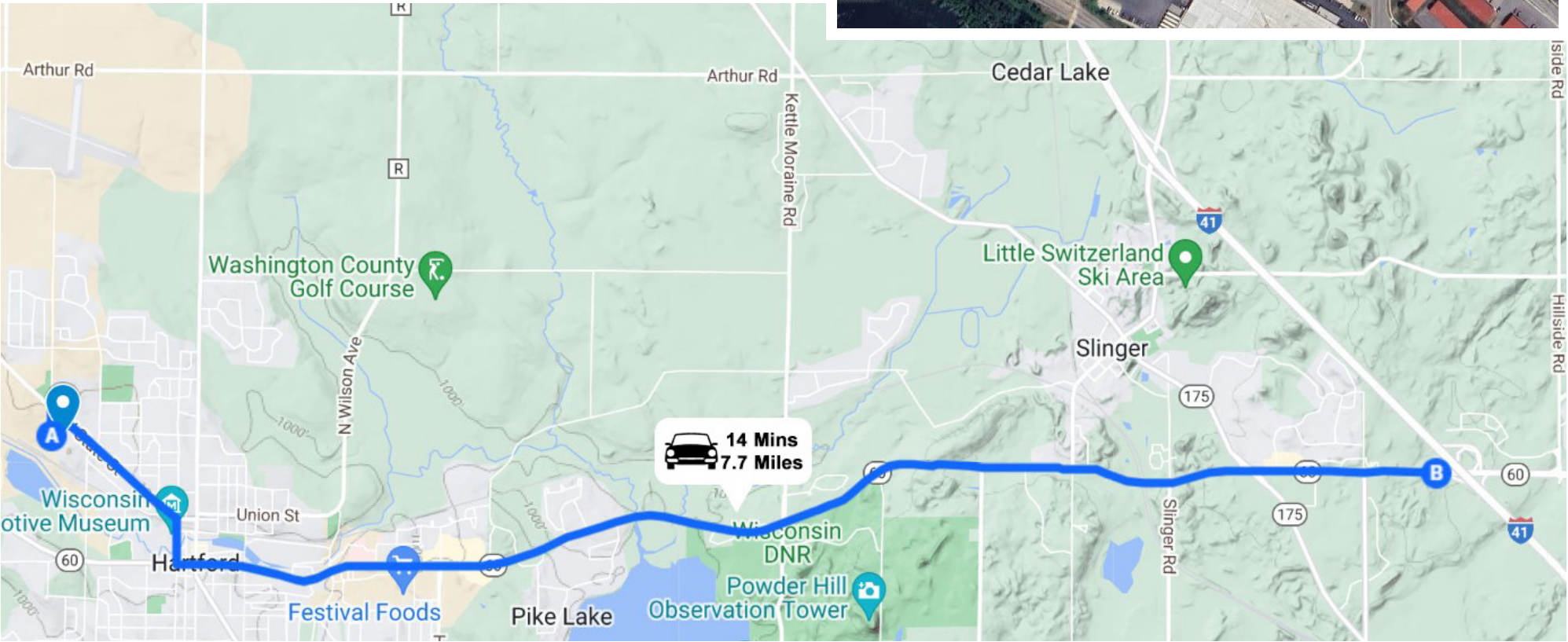
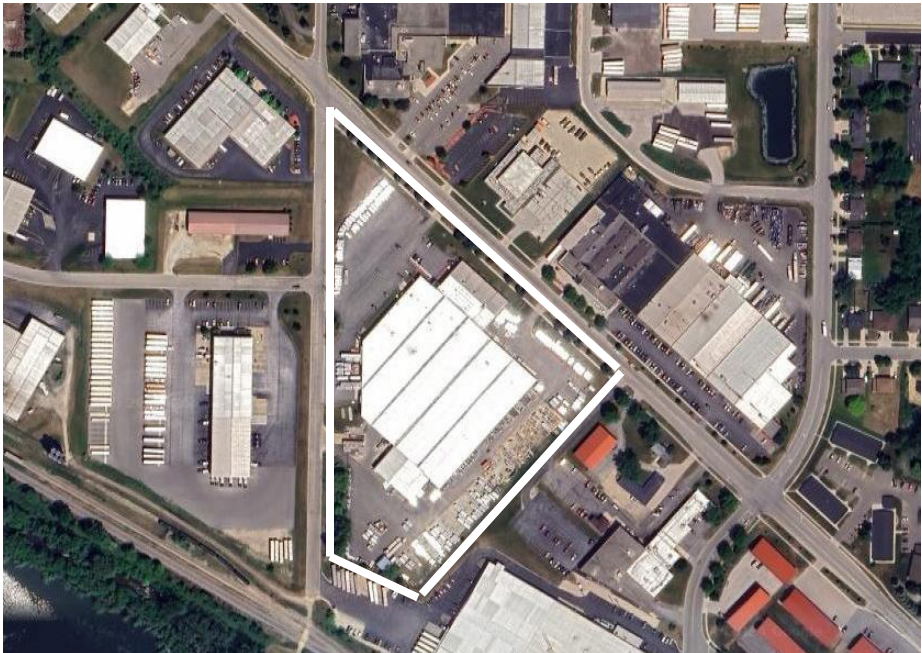
SITE PLAN
