Current rents are well below market, providing a new operator with immediate upside. Also, with an average unit size of more than 1,000 square feet, the community is comprised primarily of spacious one-bedroom layouts that offer straightforward conversion potential to two-bedroom units — creating an attractive value-add opportunity in a supply-constrained submarket.

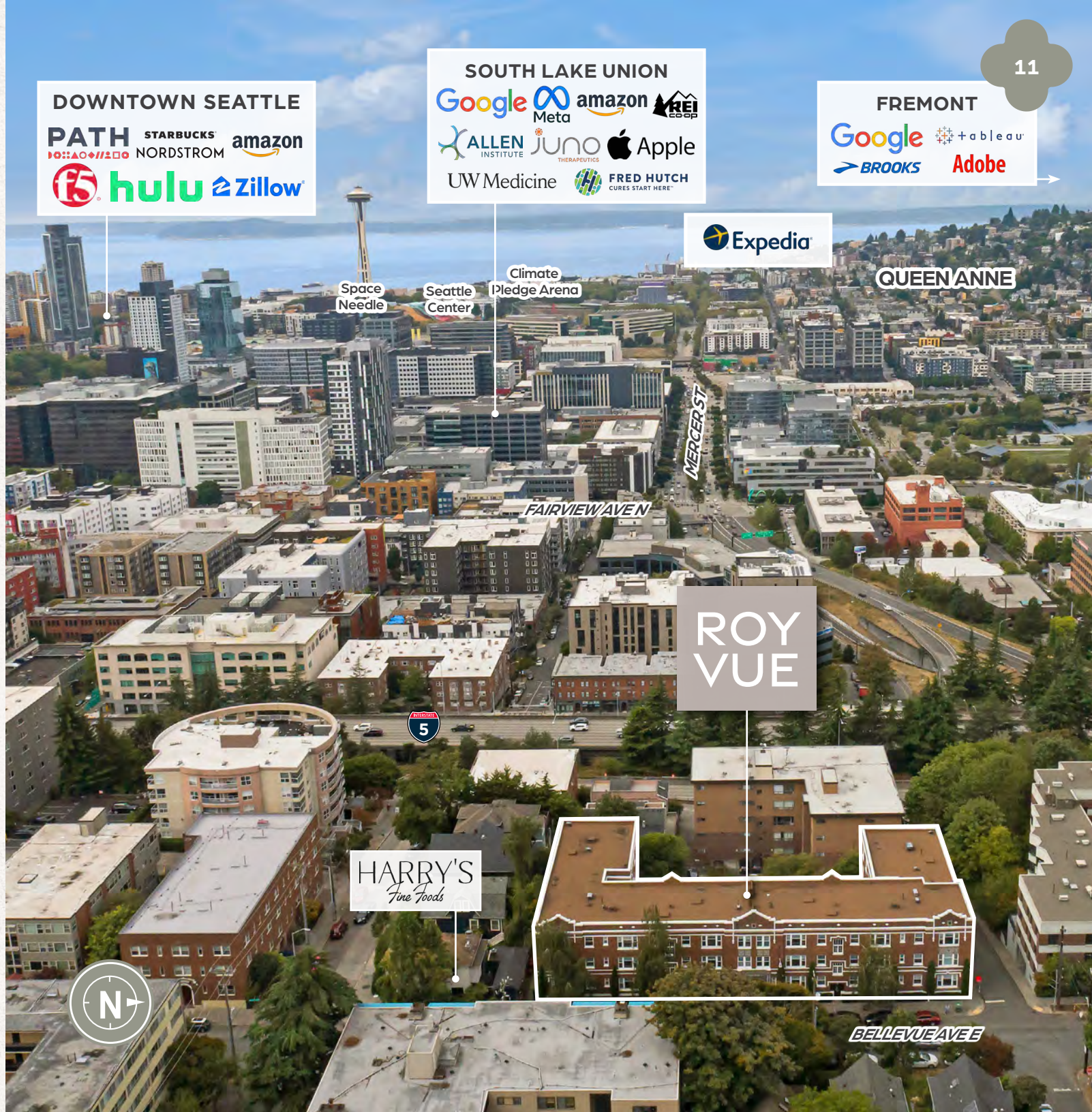
