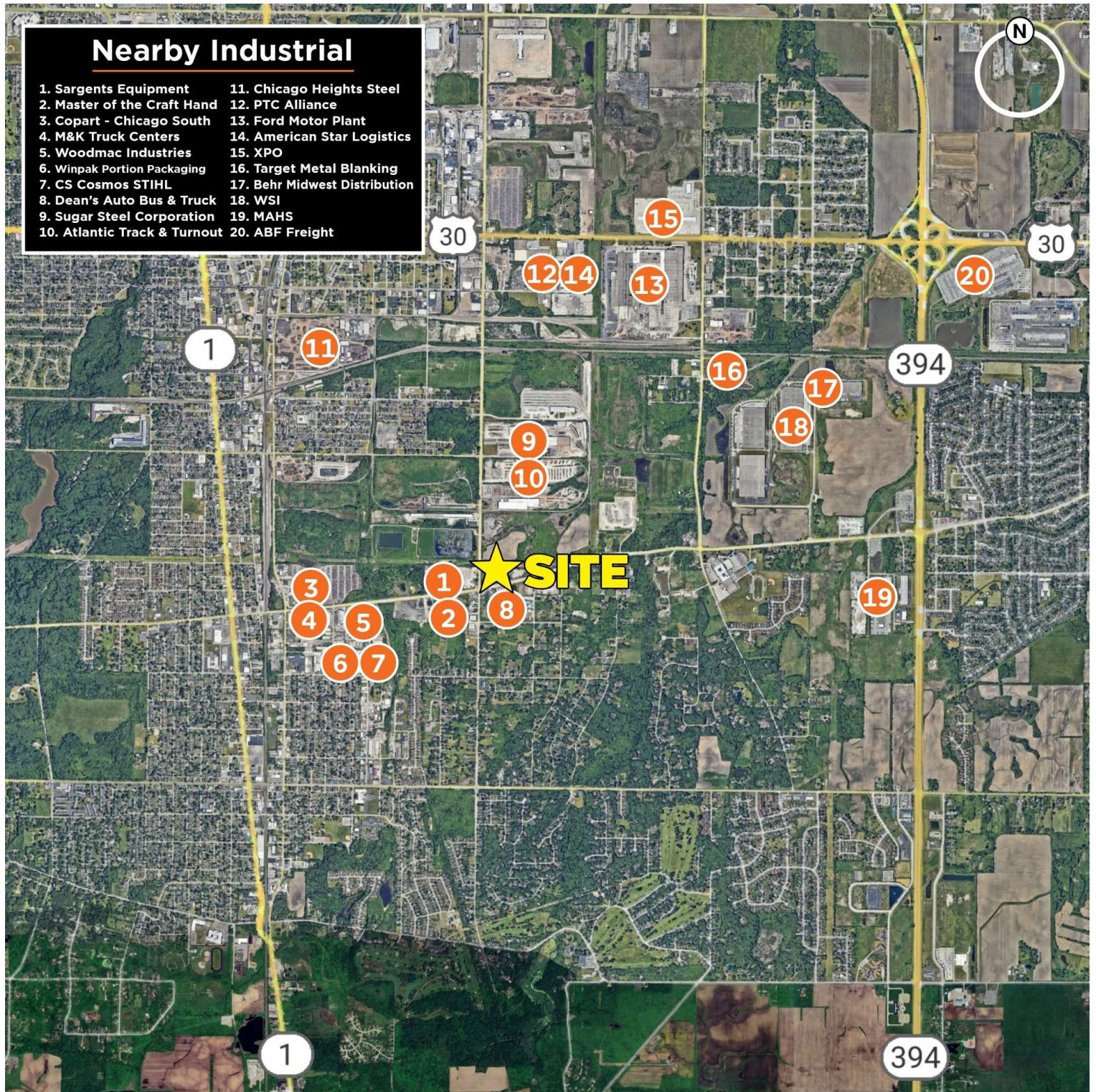

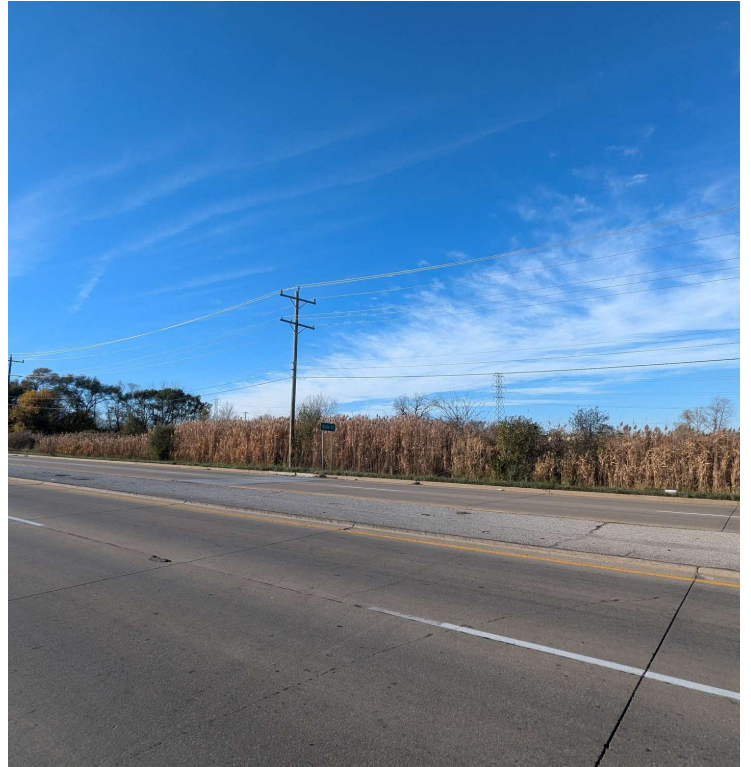
INDUSTRIAL CORRIDOR

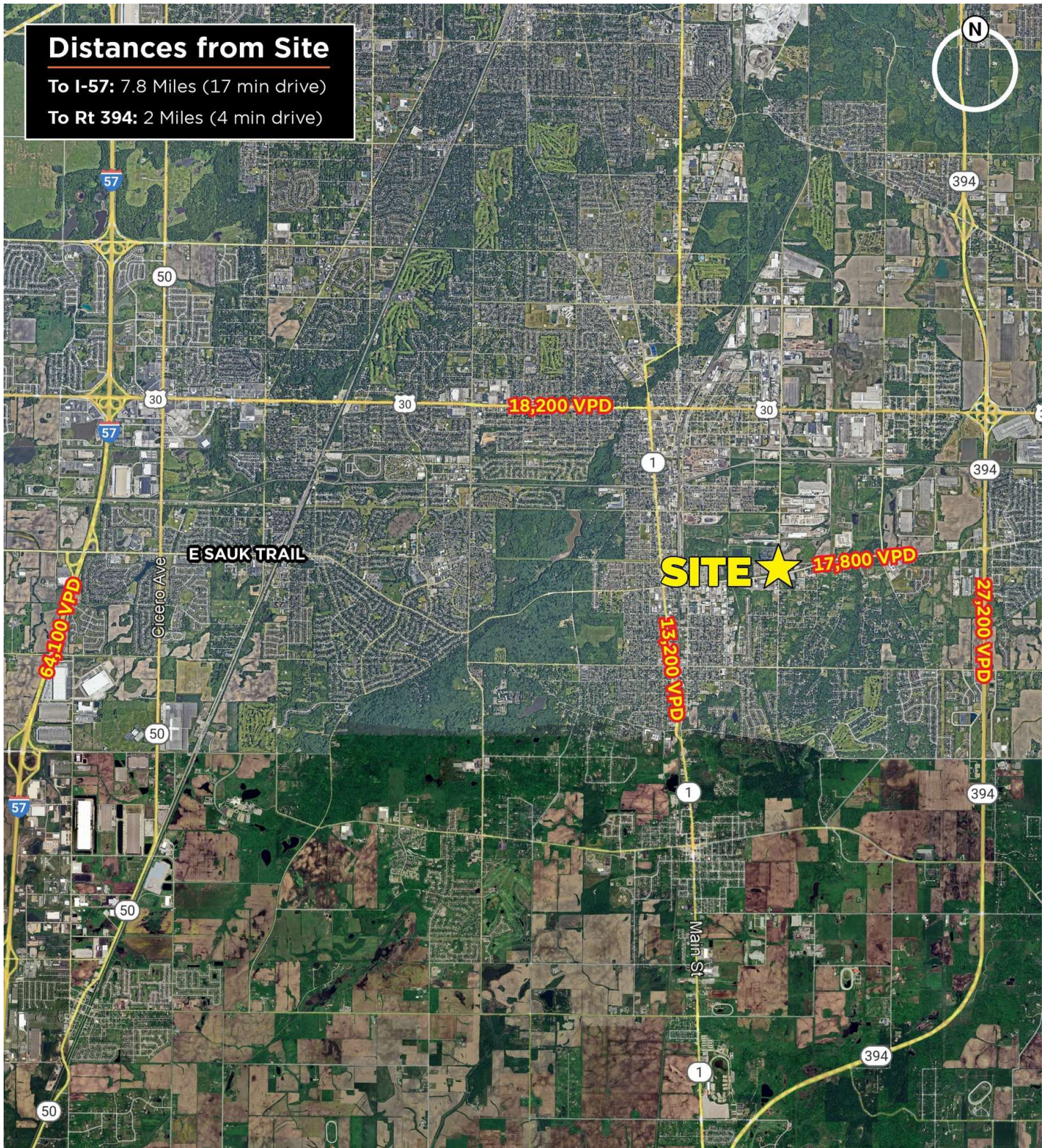
SITE LOCATION

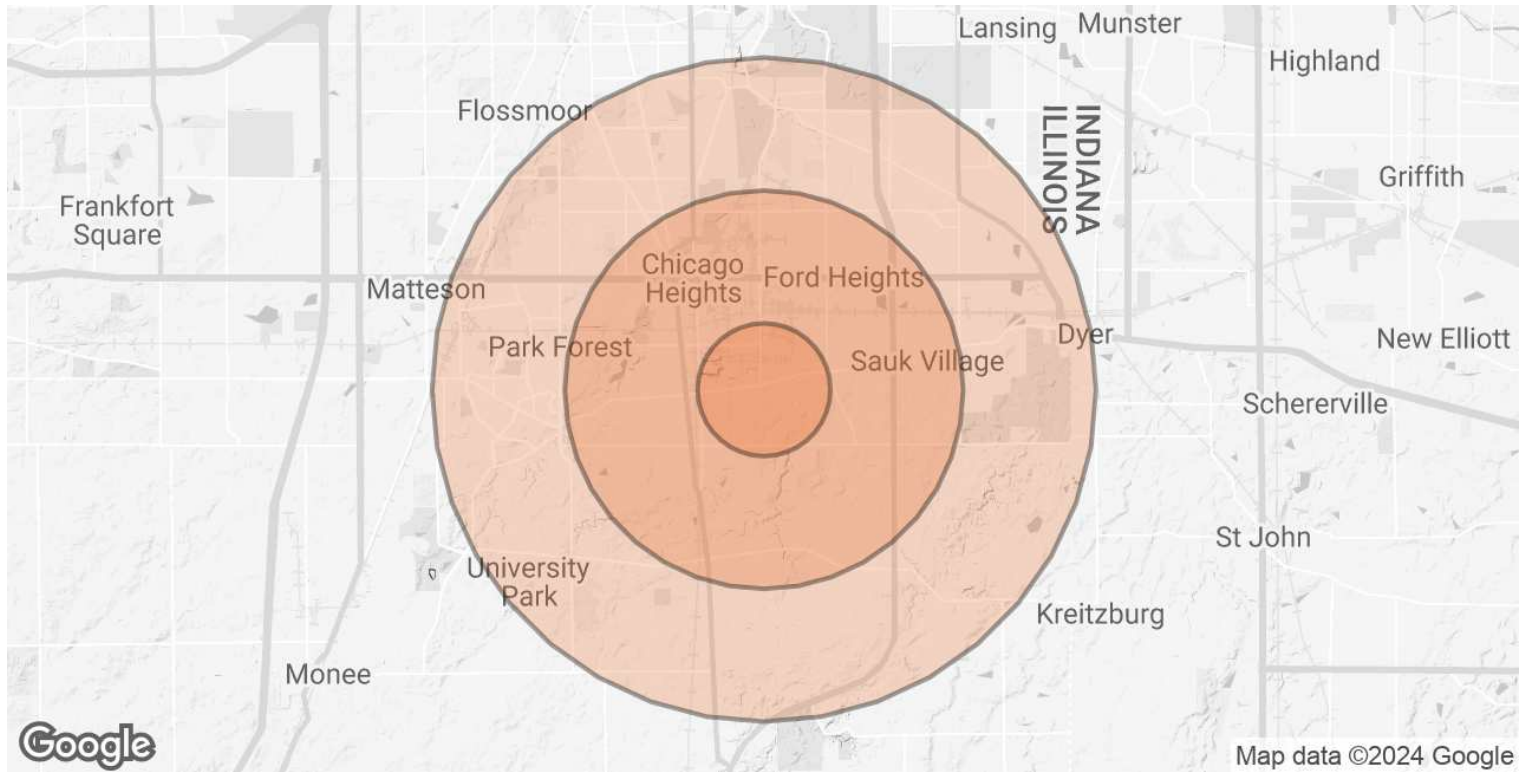
TRAFFIC LOCATION
