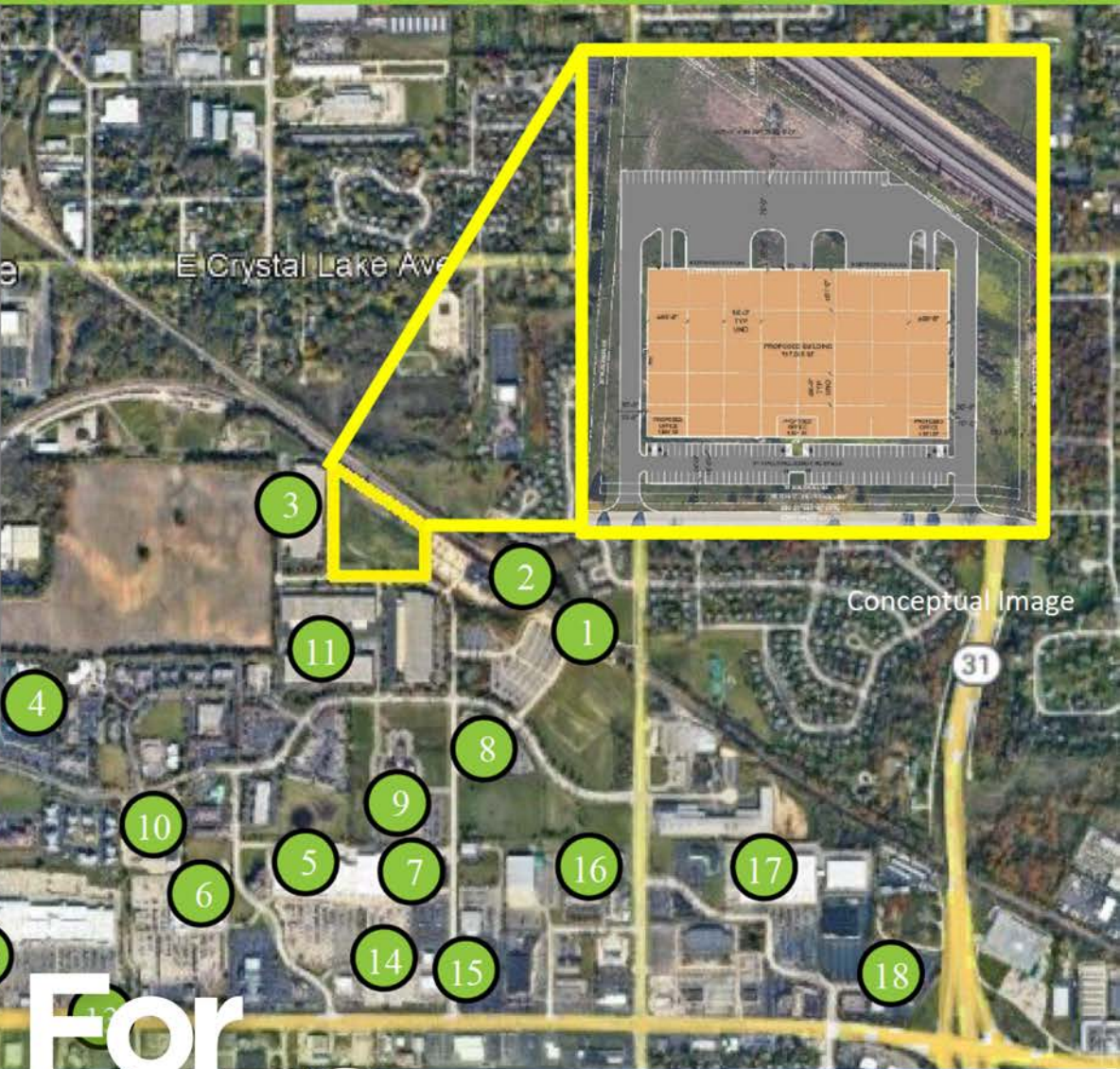

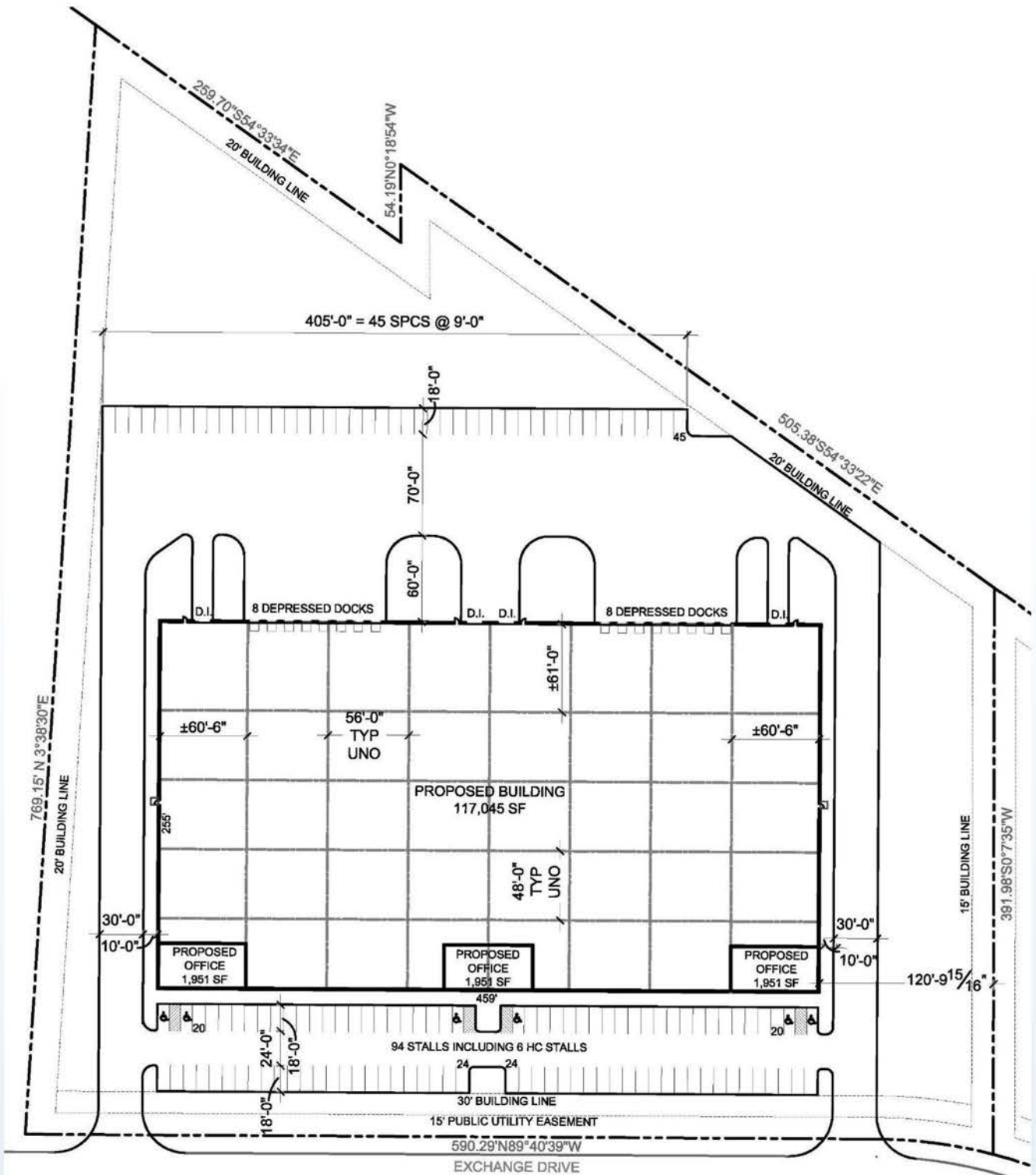

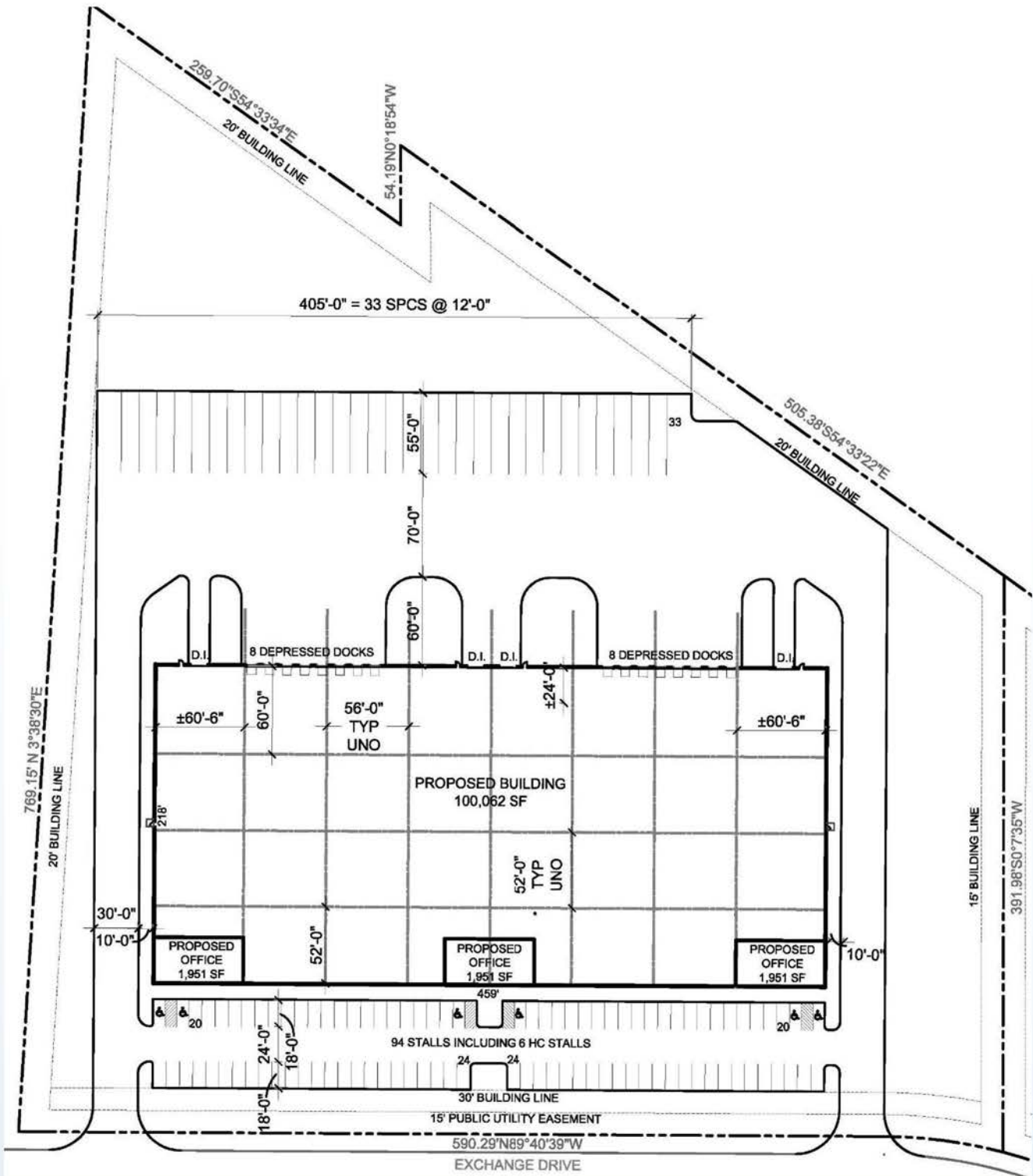
Site Plan

CONCEPT A: 117,045 SF (DIVISIBLE) FACILITY



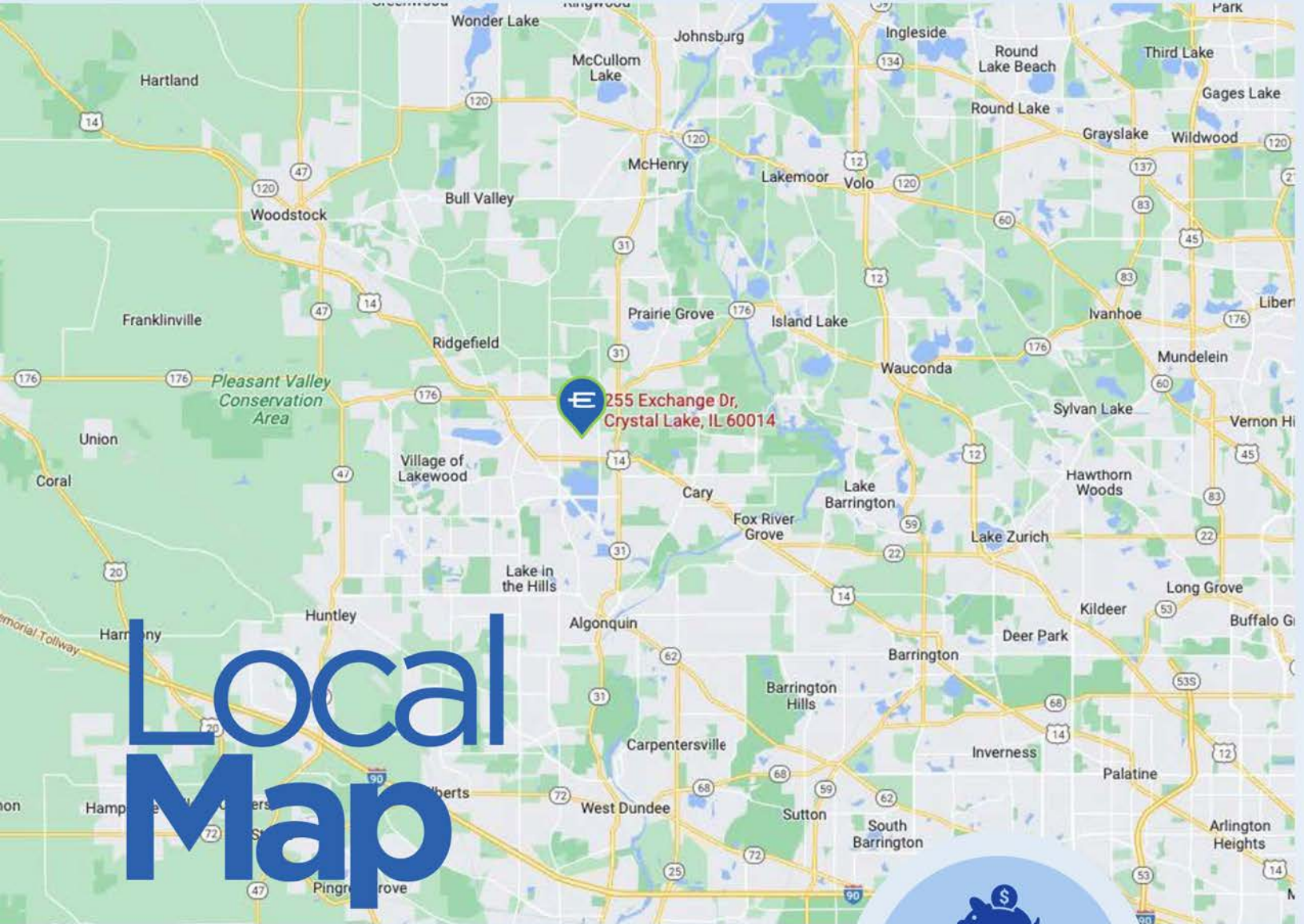
Site Plan

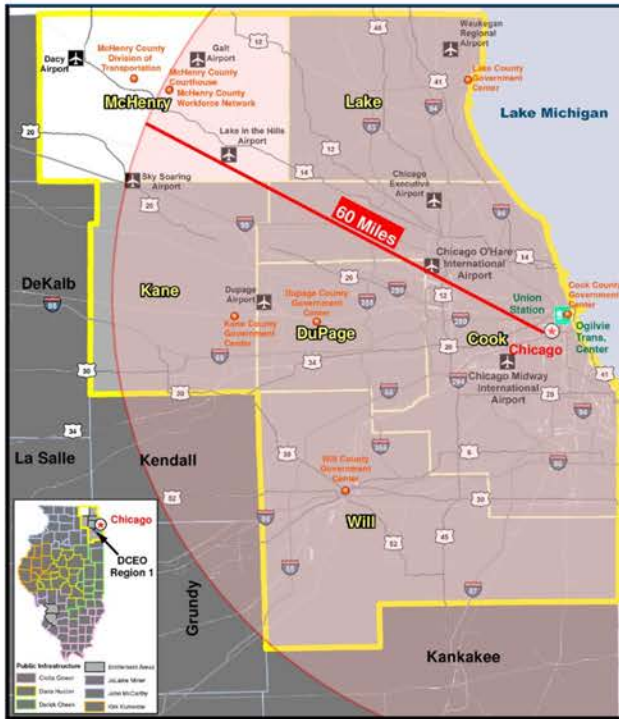
