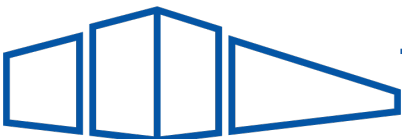
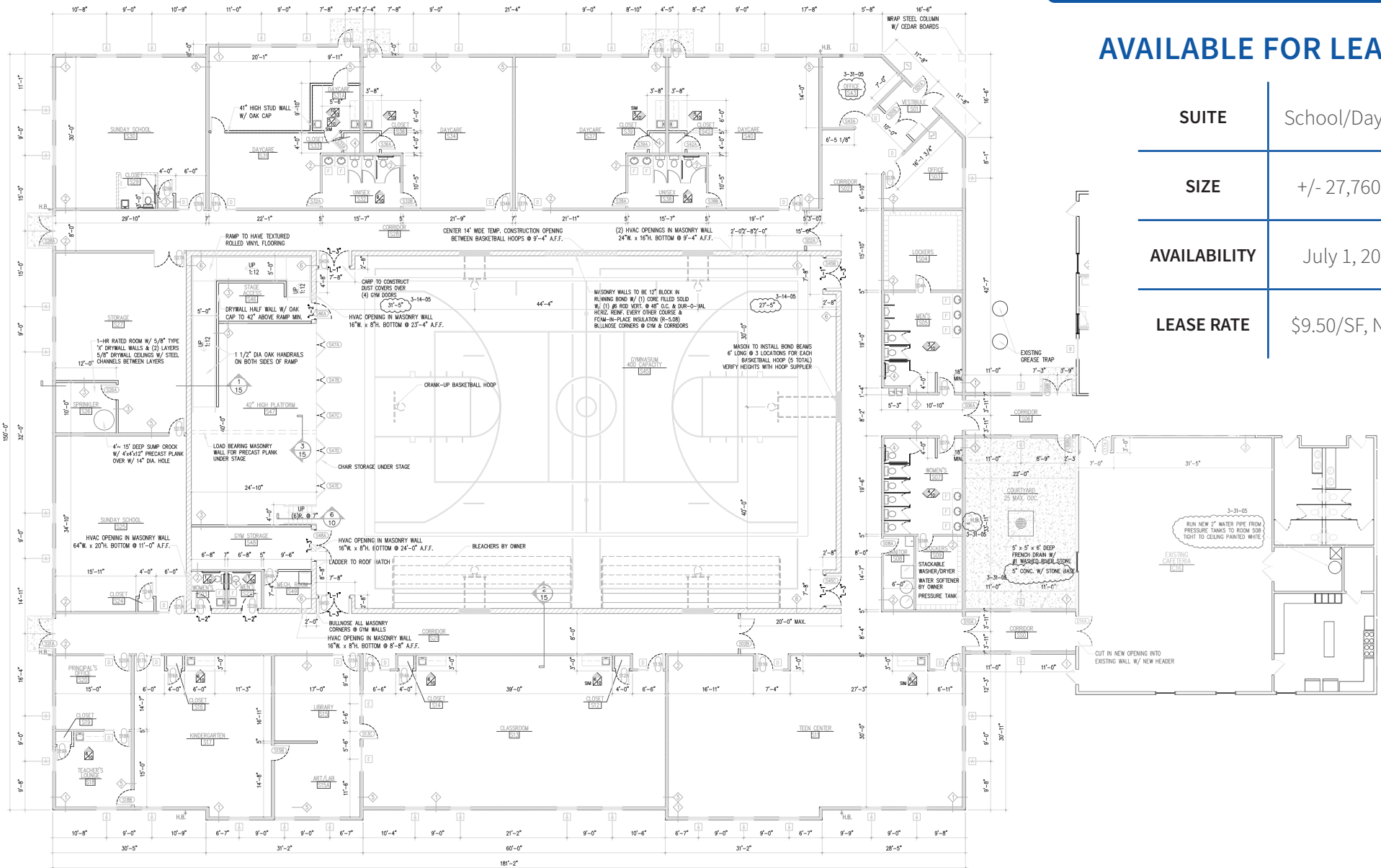


FLOOR PLAN

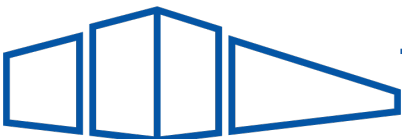

SITE AREA

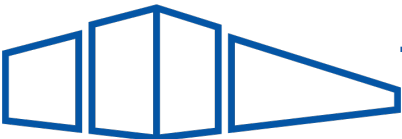
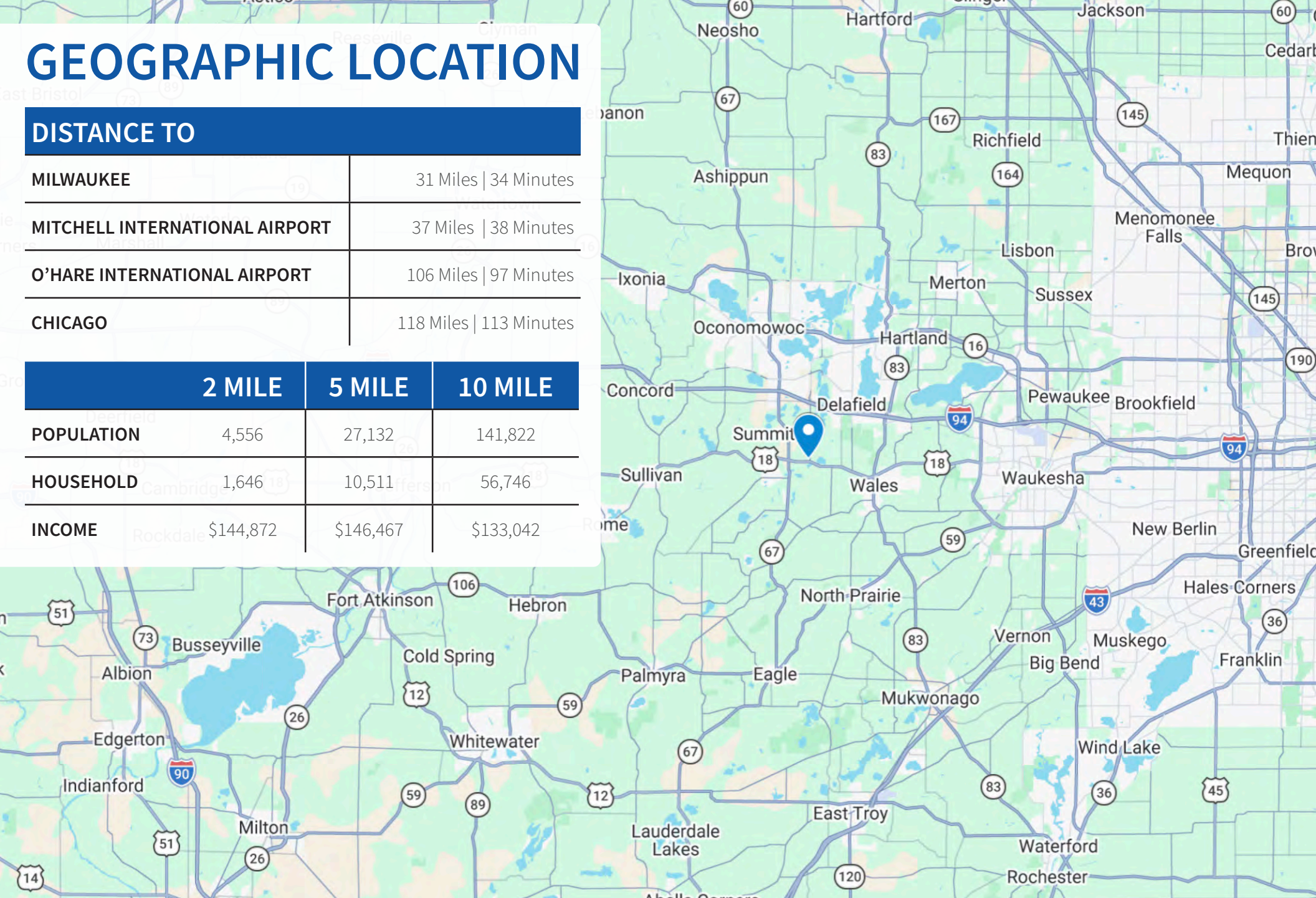
