## 1268.03 USE REGULATIONS.

- (a) <u>Uses Permitted by Right</u>. A use listed in Table 1268.03 shall be permitted by right as a principal use in a district when denoted by the letter "P" provided that all requirements of other municipal ordinances and this Zoning Code have been met.
- (b) <u>Conditional Uses</u>. A use listed in Table 1268.03 shall be permitted as a conditional use in a district when denoted by the letter "C", provided the Planning Commission first makes the determination that the requirements of Chapter 1272 have been met according to the procedures set forth in Chapter 1246.
- (c) <u>Accessory Uses</u>. A use listed in Table 1268.03 shall be permitted as an accessory use in a district when denoted by the letter "A". Such use shall be permitted as a subordinate building or use when it is clearly incidental to and located on the same lot as the principal building or use. Accessory uses are further regulated in subsequent sections of this Zoning Code.
