





About Columbia, SC

- As the state capital, Columbia is the center of South Carolina's government, housing the South Carolina State House and various state agencies. Columbia is often referred to as "The Capital City" because it serves as the political and administrative heart of South Carolina.
- Columbia has a diverse economy with key sectors in education, healthcare, manufacturing, government, and technology. It is home to major employers like Palmetto Health, SCANA (a utility company), and the University of South Carolina.
- As of the 2020 census, Columbia's population is around 133,000, while the metropolitan area has over 800,000 residents, making it the largest metro area in the state.
- Columbia is home to the University of South Carolina, the state's flagship public university, which was founded in 1801. USC is a major educational, cultural, and research institution in the city.
- Columbia is located at the confluence of the Saluda and Broad Rivers, which together form the Congaree River. This location played a key role in its early development, particularly in trade and transportation.
- In recent years, Columbia has experienced growth in its tech sector, with several tech startups and companies calling the city home.
- The city's location along the rivers makes it an excellent spot for outdoor activities like kayaking, fishing, and hiking. The nearby Congaree National Park offers miles of trails and rich wildlife.
- The USC Gamecocks are a major source of pride in the city, particularly in college football and women's basketball. Williams-Brice Stadium, home to the Gamecocks football team, can hold over 80,000 fans.









2024 Own vs. Rent - 1 Mile Radius


