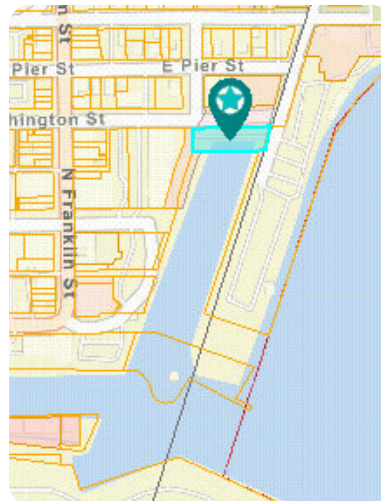

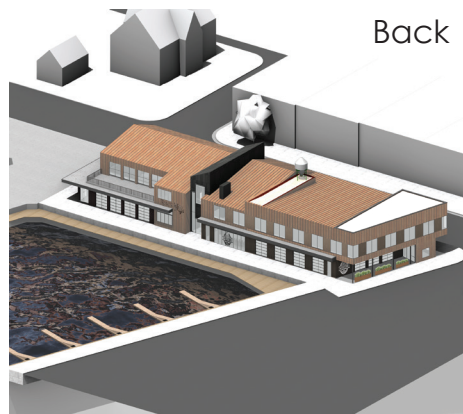
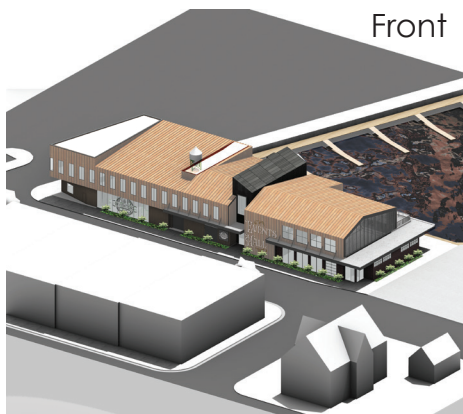
# Map & Amenities

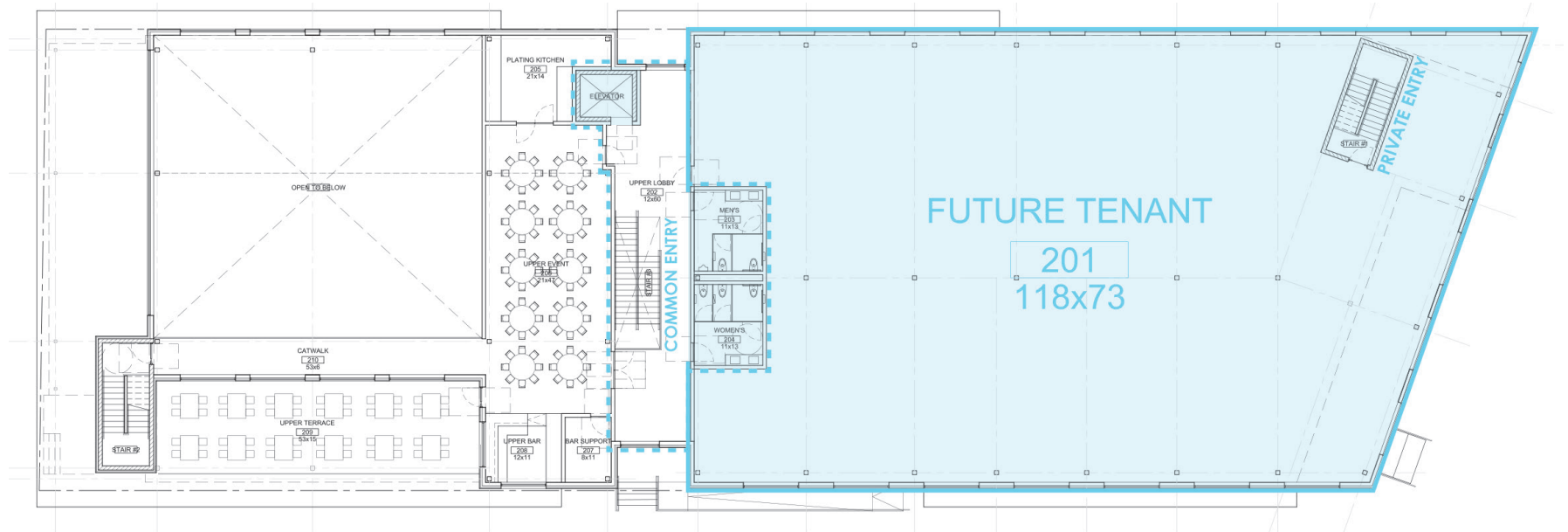
