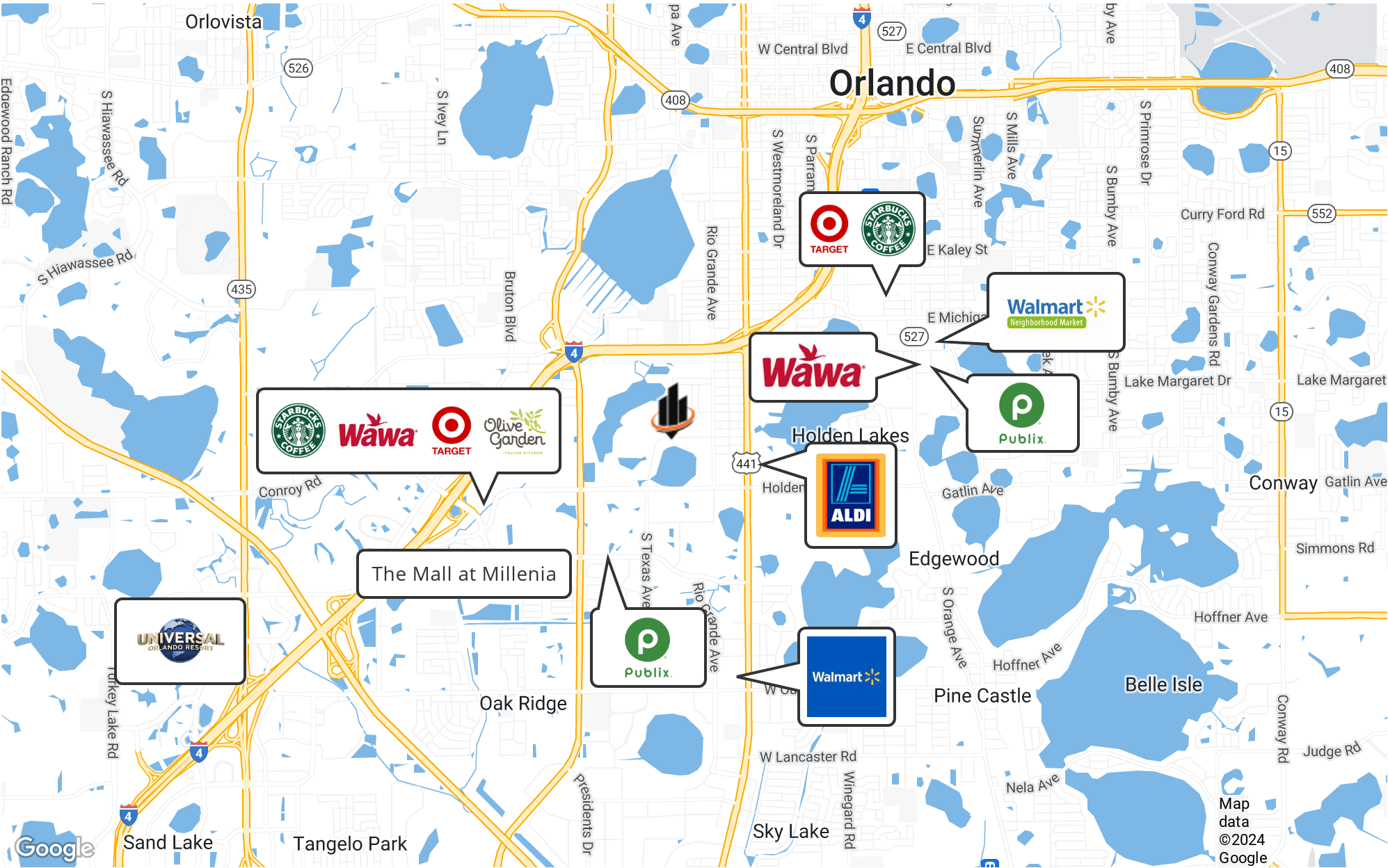

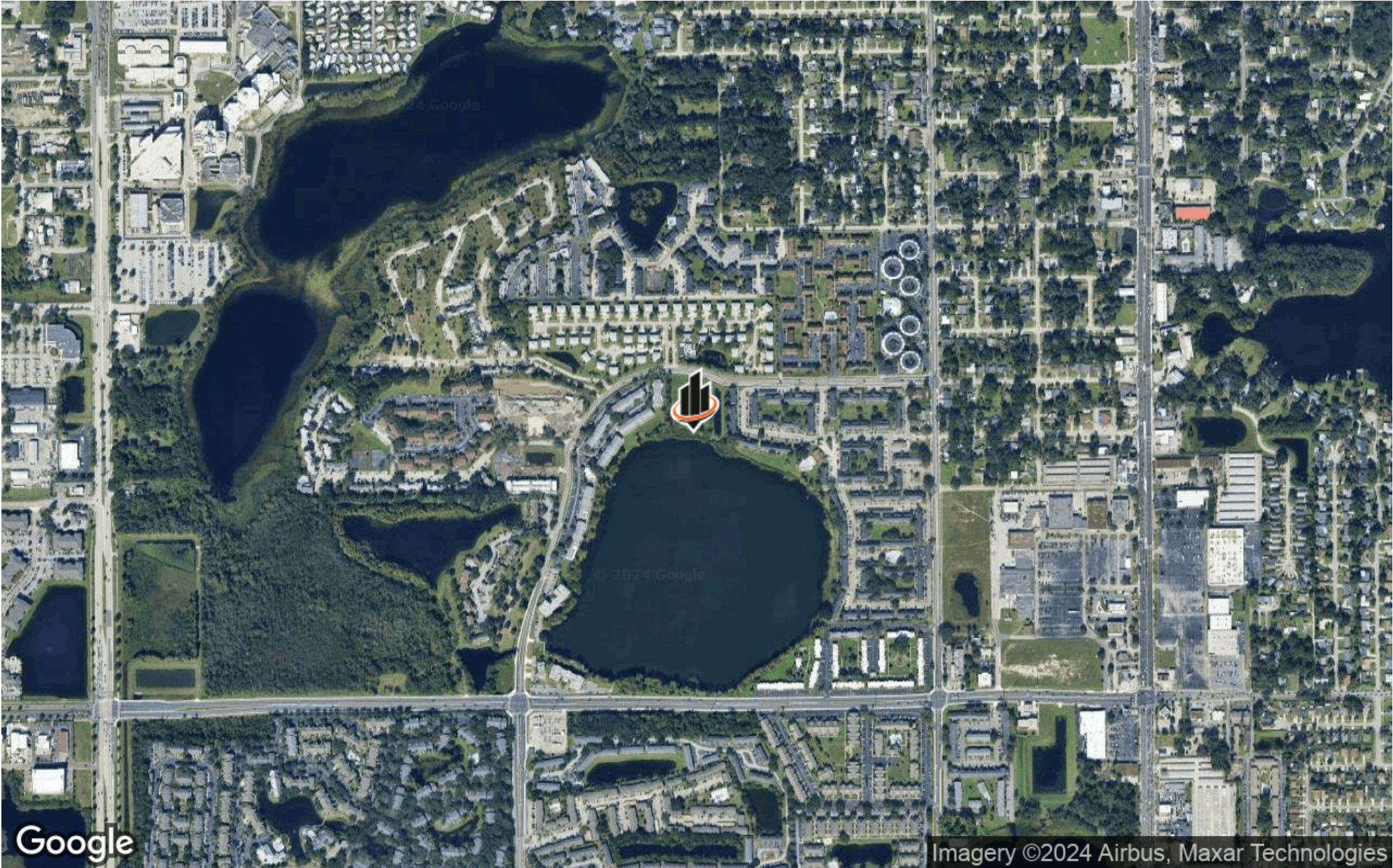
REGIONAL MAP

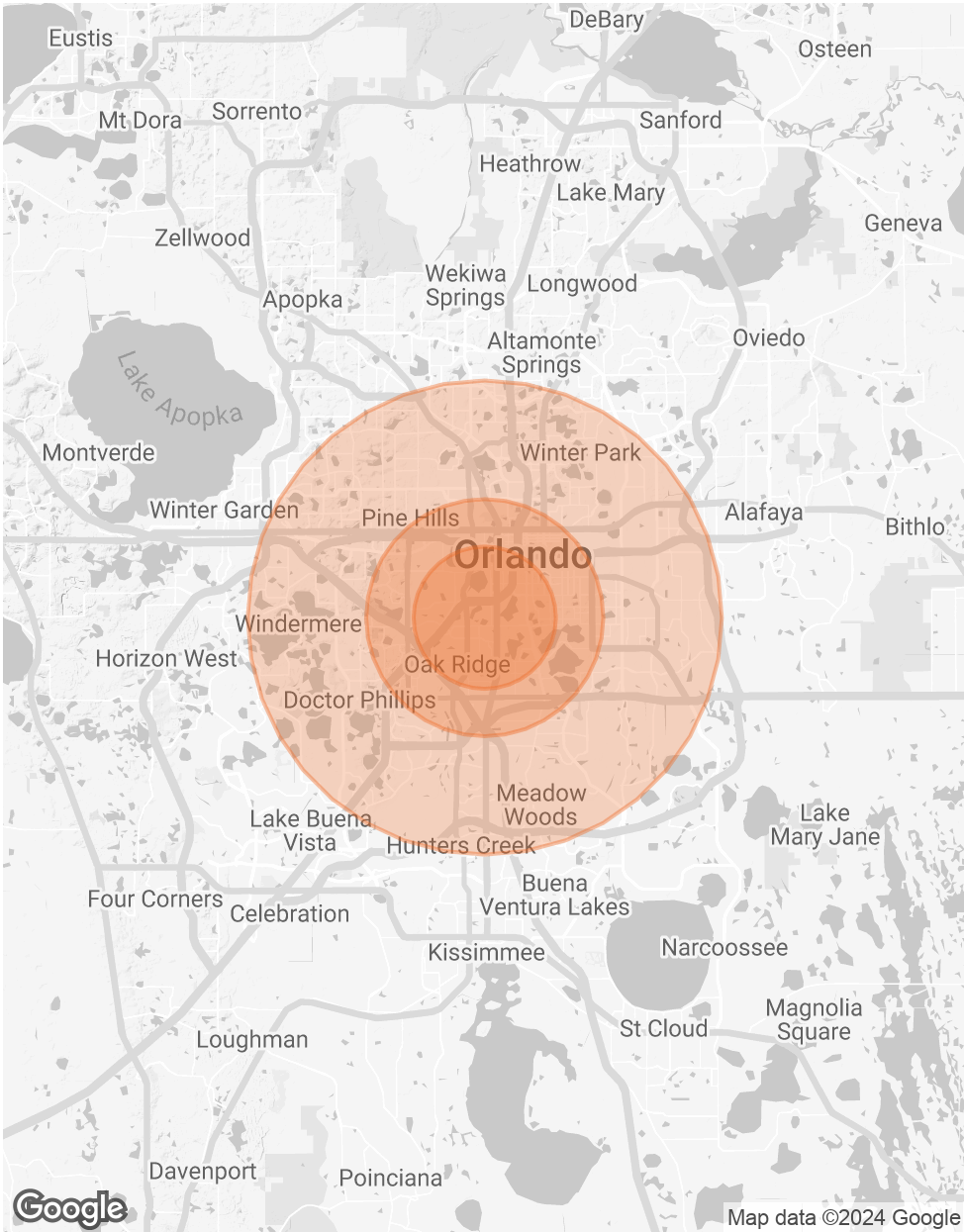
