- Dedicated parking lot

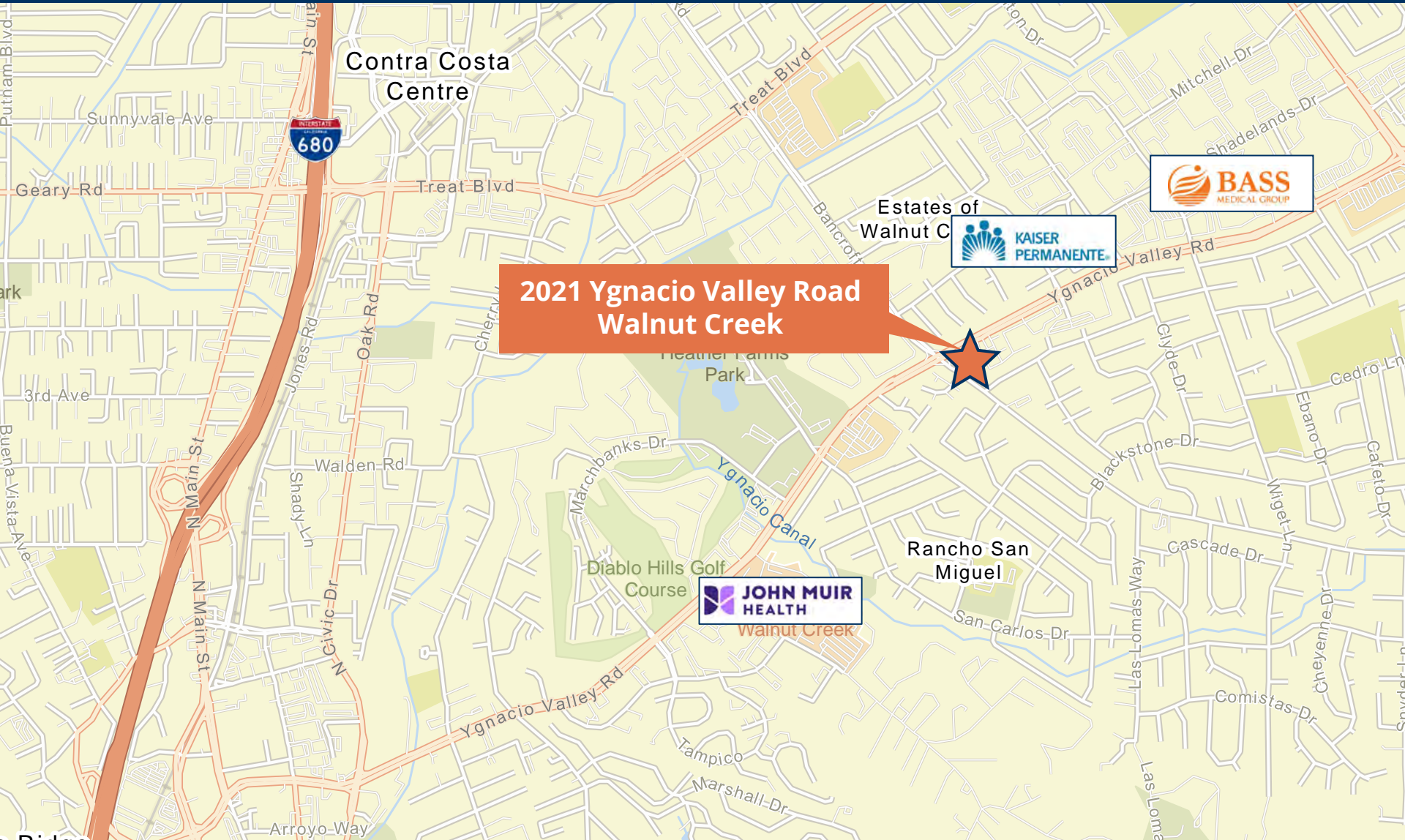

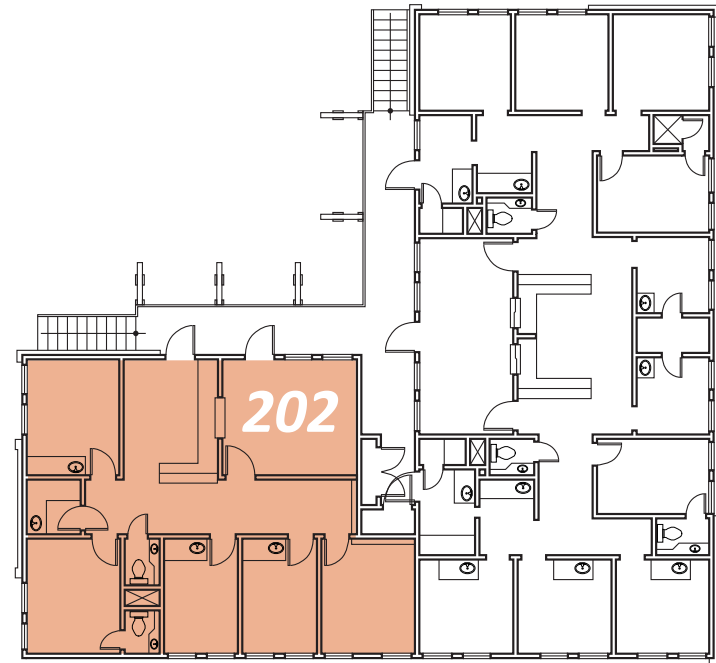
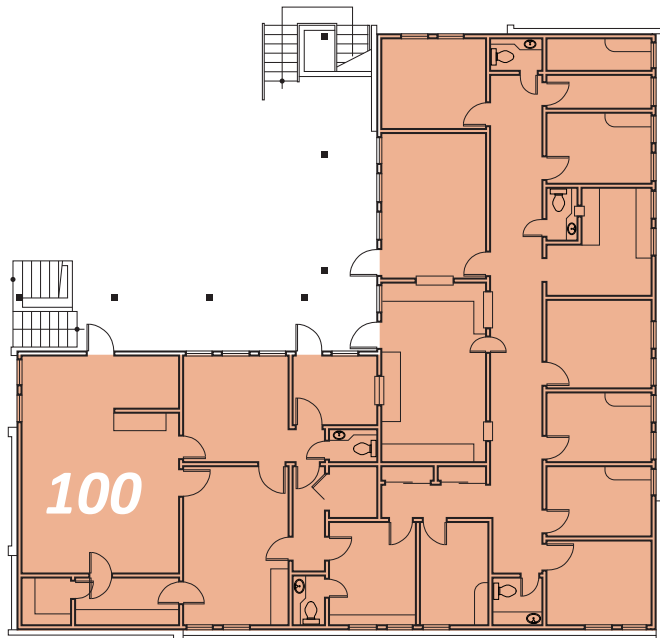

reception/waiting area, 5 restrooms

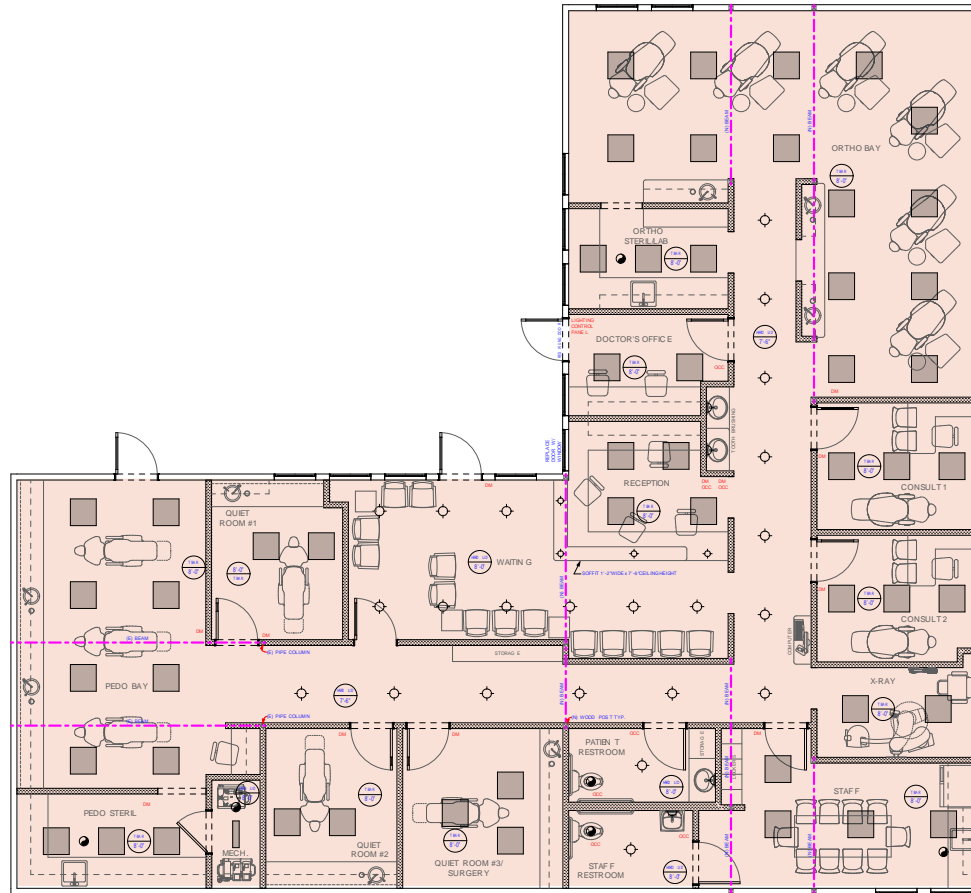
### SECOND FLOOR

reception/waiting room, 2 restrooms, lab

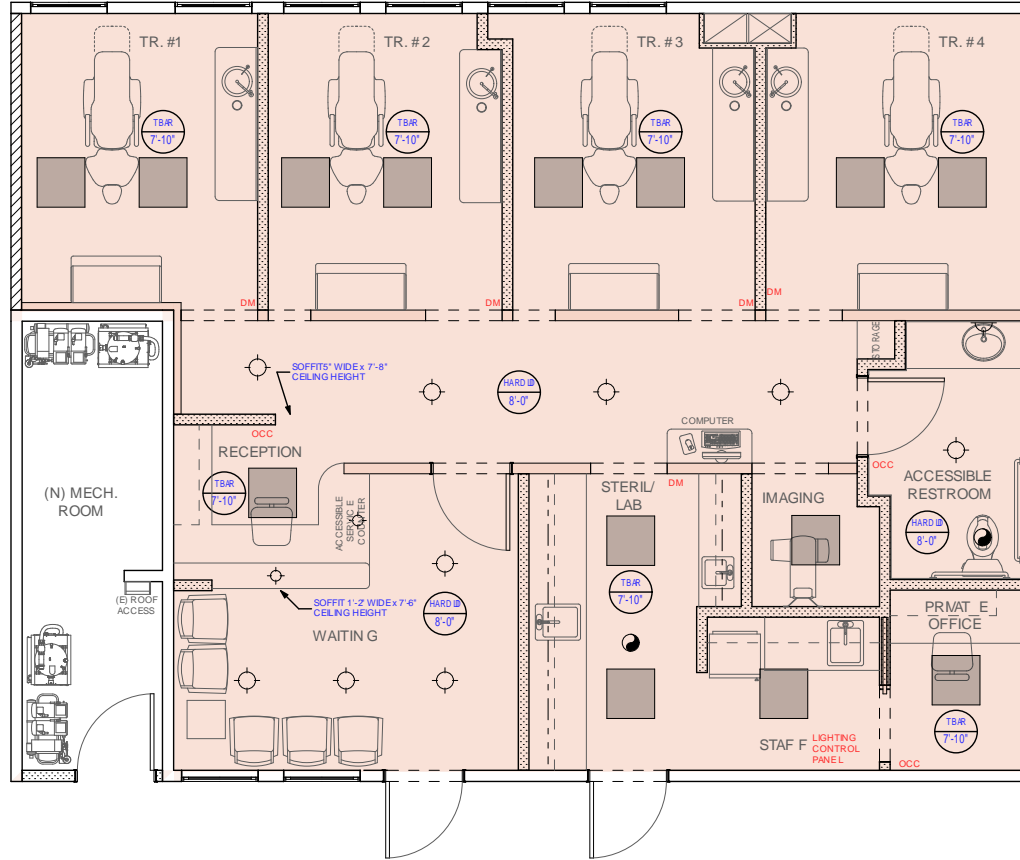
