




OVERVIEW

The Desert Sun Resort is a 33-room resort sitting on 1.67 acres of manicured grounds, featuring two large pools, jacuzzi, bar/café (seats 50), lighted tennis court, spa (two-room), gift shop, two fire pits, loggia, green event lawns, and water features.

- Operates with experienced staff of 20 FTEs and over 17-year absentee owner
- 22 hotel rooms renovated in 2020; 11 courtyard rooms renovated 2016; 5 suites with kitchenettes
- 192 solar panels installed in 2016 (owned)
- Full liquor license

Incredible grounds with opportunity for expansion.


VALUE-ADD OPPORTUNITY
