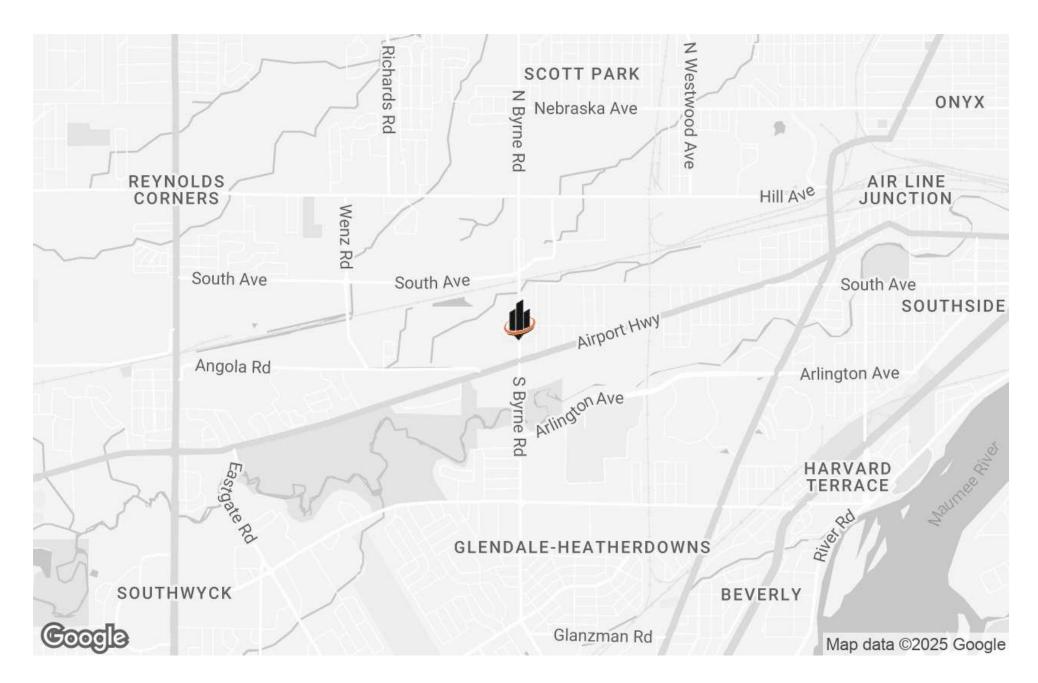


RETAILER MAP





LOCATION MAP



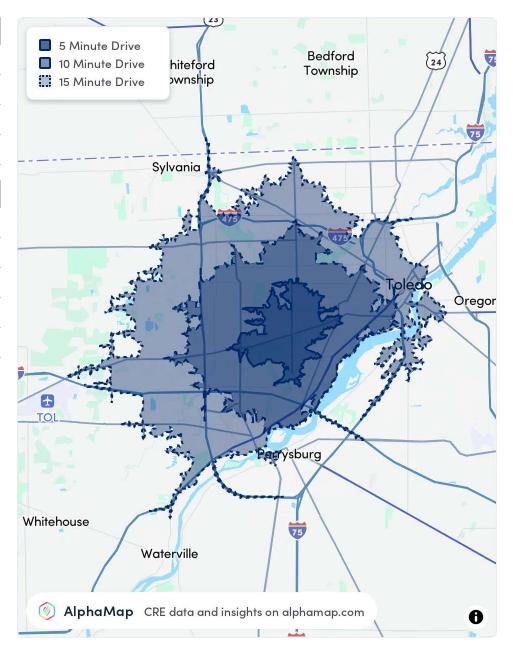
