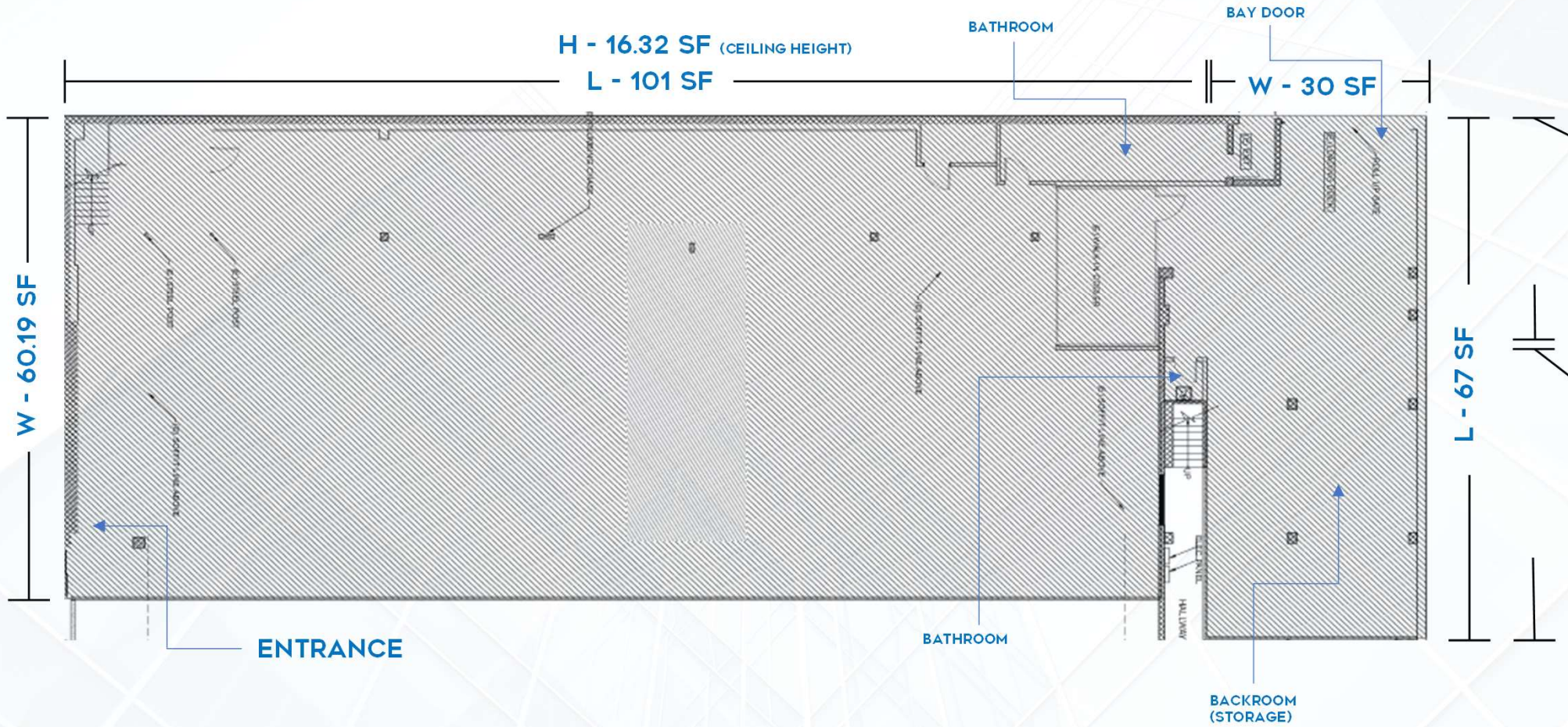

FLOOR PLAN

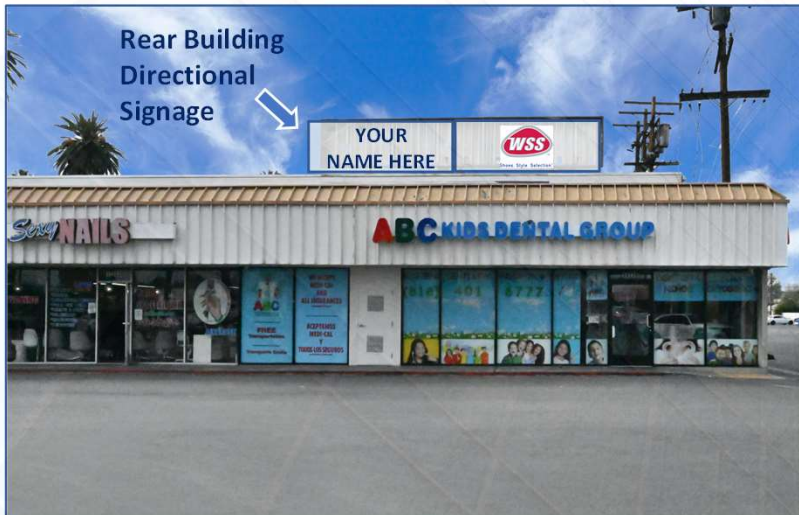

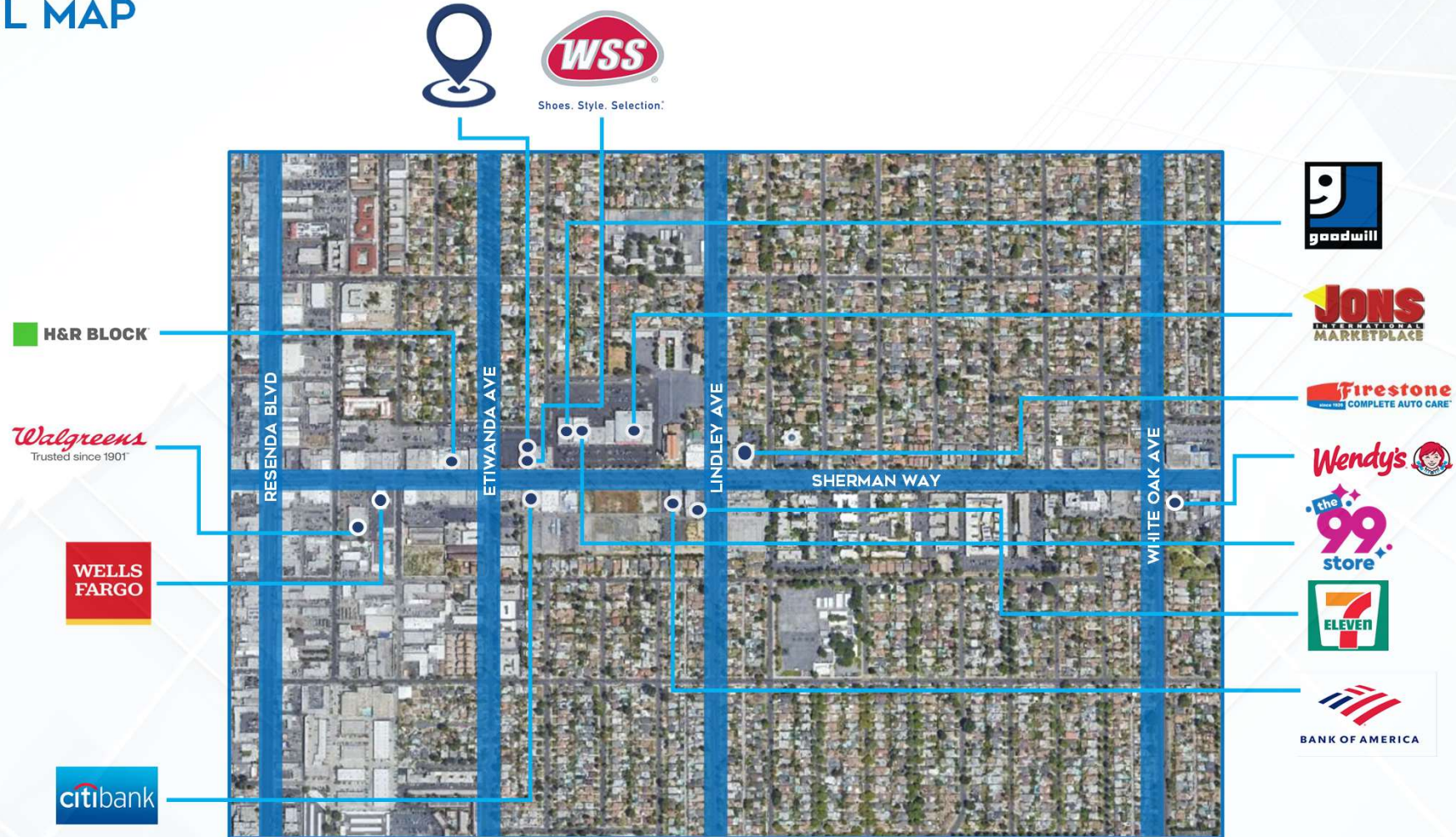

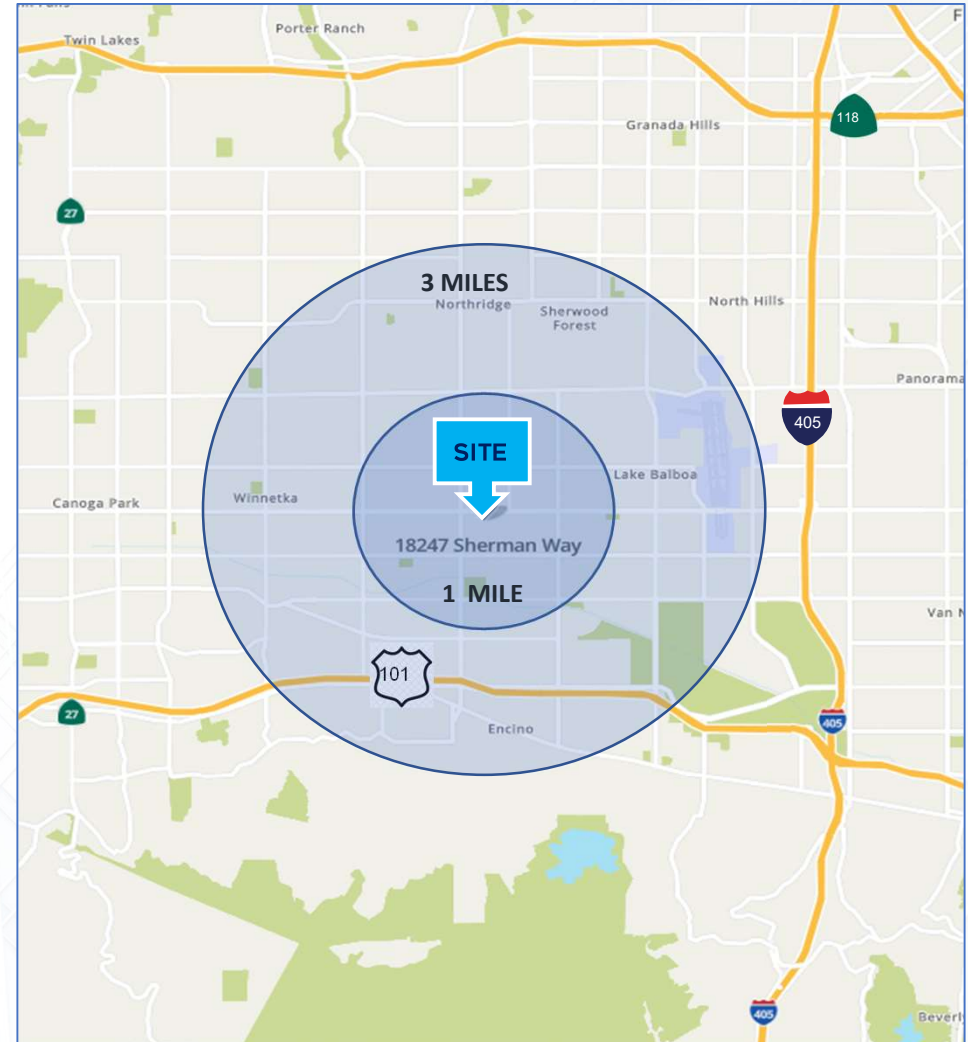


RETAIL MAP
