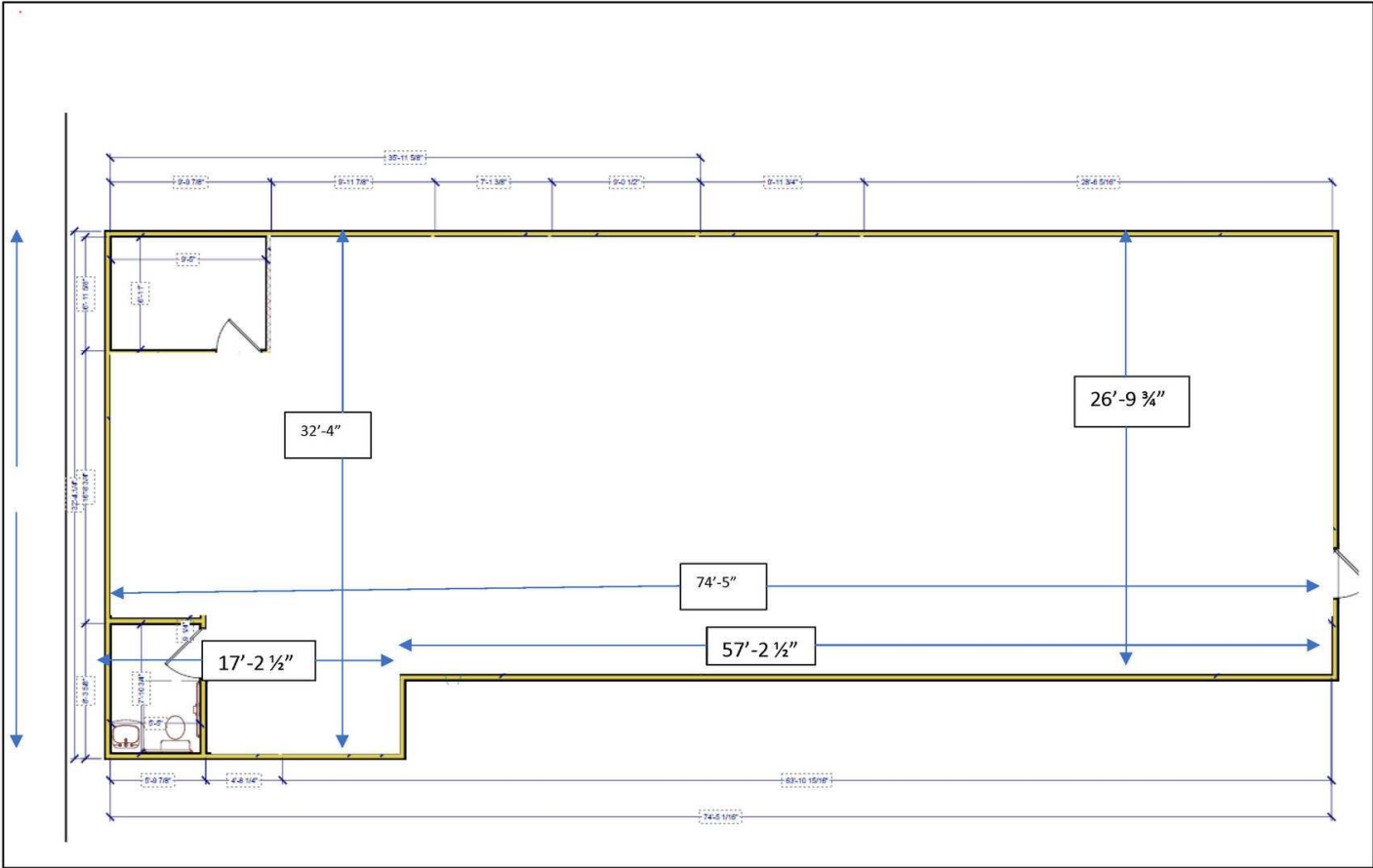

Floor Plan



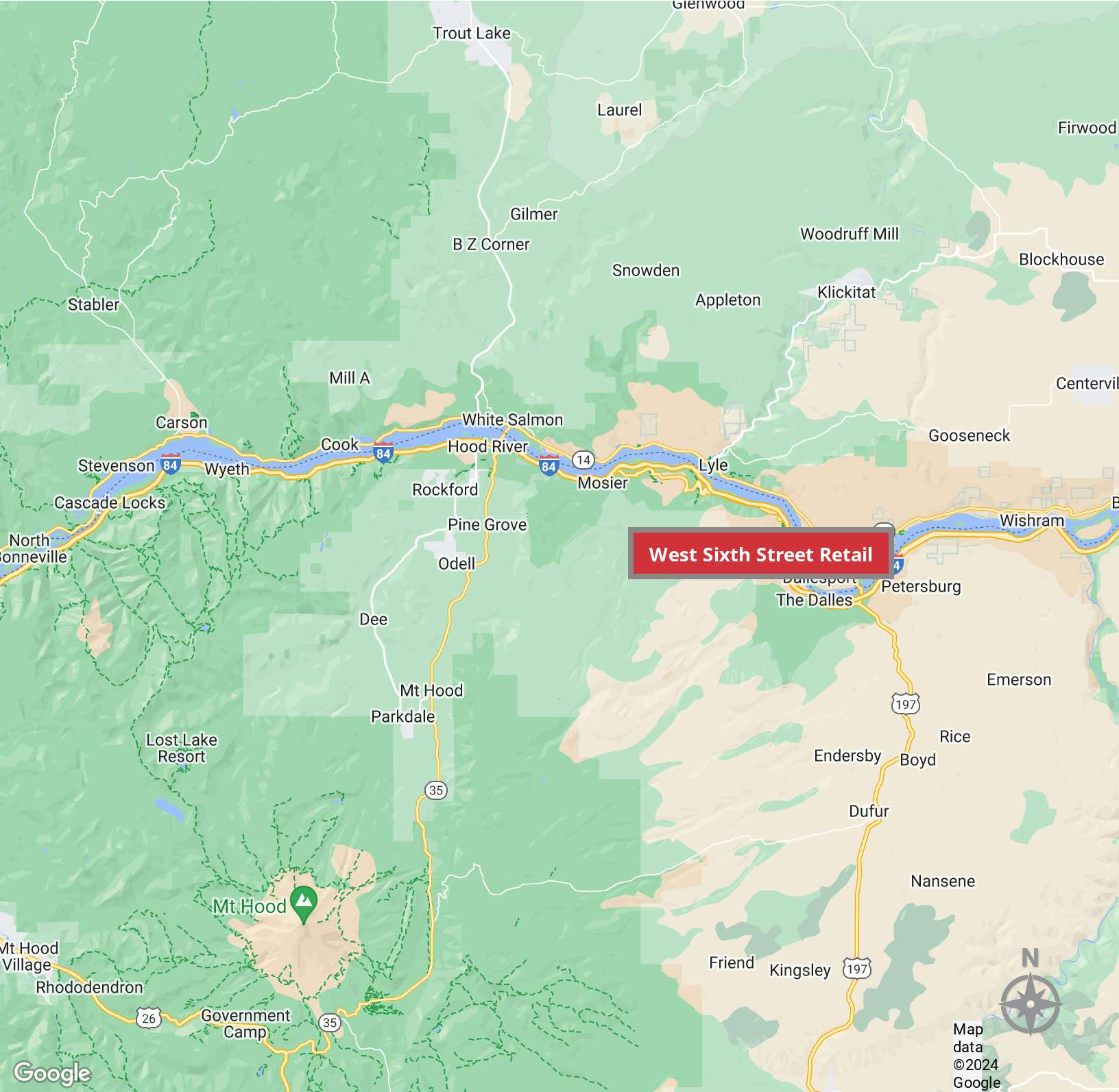

Currently, 60.1% of the 9,155 housing units in the area are owner occupied; 33.8%, renter occupied; and 6.1% are vacant. Currently, in the U.S., 57.9% of the housing units in the area are owner occupied; 32.1% are renter occupied; and 10.0% are vacant. In 2020, there were 8,952 housing units in the area and 6.4% vacant housing units. The annual rate of change in housing units since 2020 is 0.53%. Median home value in the area is \$378,910, compared to a median home value of \$355,577 for the U.S. In five years, median value is projected to change by 1.06% annually to \$399,341.
