Cartiergroup, LLC has reviewed the Environmental Site Assessment of 24 Brook Rd. in Amherst NH that was conducted in June 2004 by TF Moran, Inc. Federal and State Environmental records from the date of the 2004 report to present were reviewed for the site known as Woodlands of Amherst and consisting of approximately 127 acres. Records indicate that there are no environmental conditions on or near the subject property that would adversely affect the property. On July 27, 2020 Cartiergroup, LLC conducted a site visit to the property and reviewed the current conditions. A visual review of the site noted that some clearing of trees has taken place since the last report. A satellite map review indicated that took place around 2014-15. The area is heavily wooded and in its natural vegetative state. No signs of filling or dumping were noted. The small cabin that is located at the entry to 24 Brook Rd. is mainly bare wood. Prior to any demolition of this structure, care should be taken to evaluate the roofing tiles for asbestos containing materials (ACM's) as well as any flooring and old building materials located within the structure. Given the conclusion of no evidence of recognized environmental conditions based on the 2006 Phase I assessment and the updated research efforts of Cartiergroup, LLC to date, Cartiergroup, LLC is confident that there is no environmental change at the property that would adversely affect the property.
