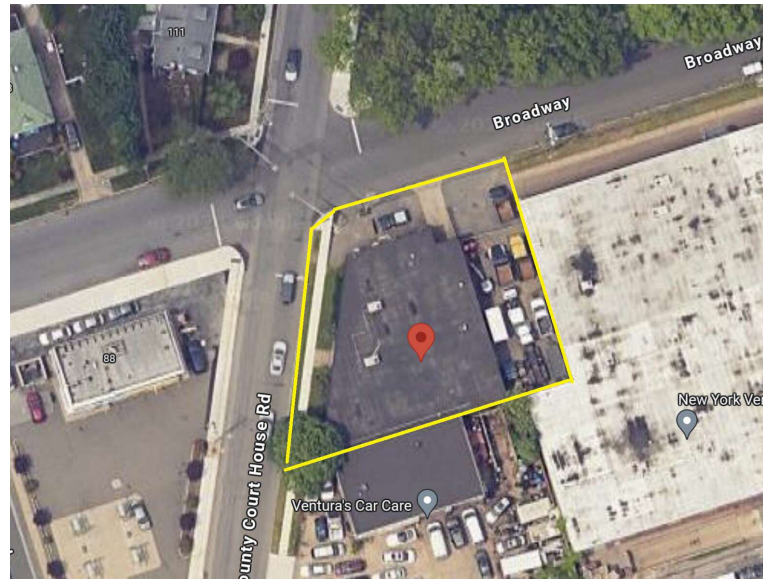

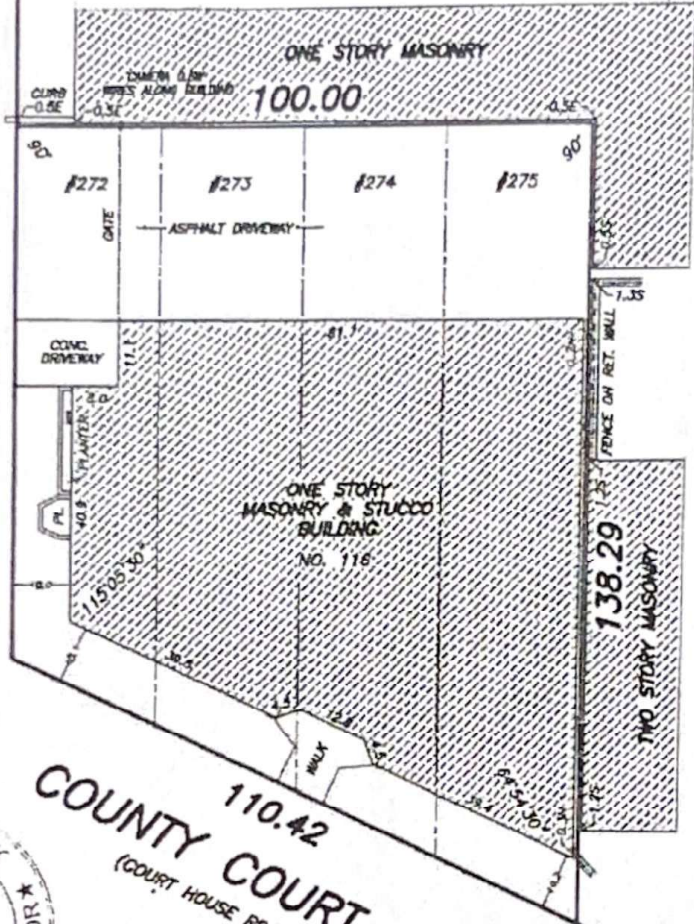
# MAP OF PROPERTY SITUATED IN GARDEN CITY PARK NASSAU COUNTY, N.Y.
