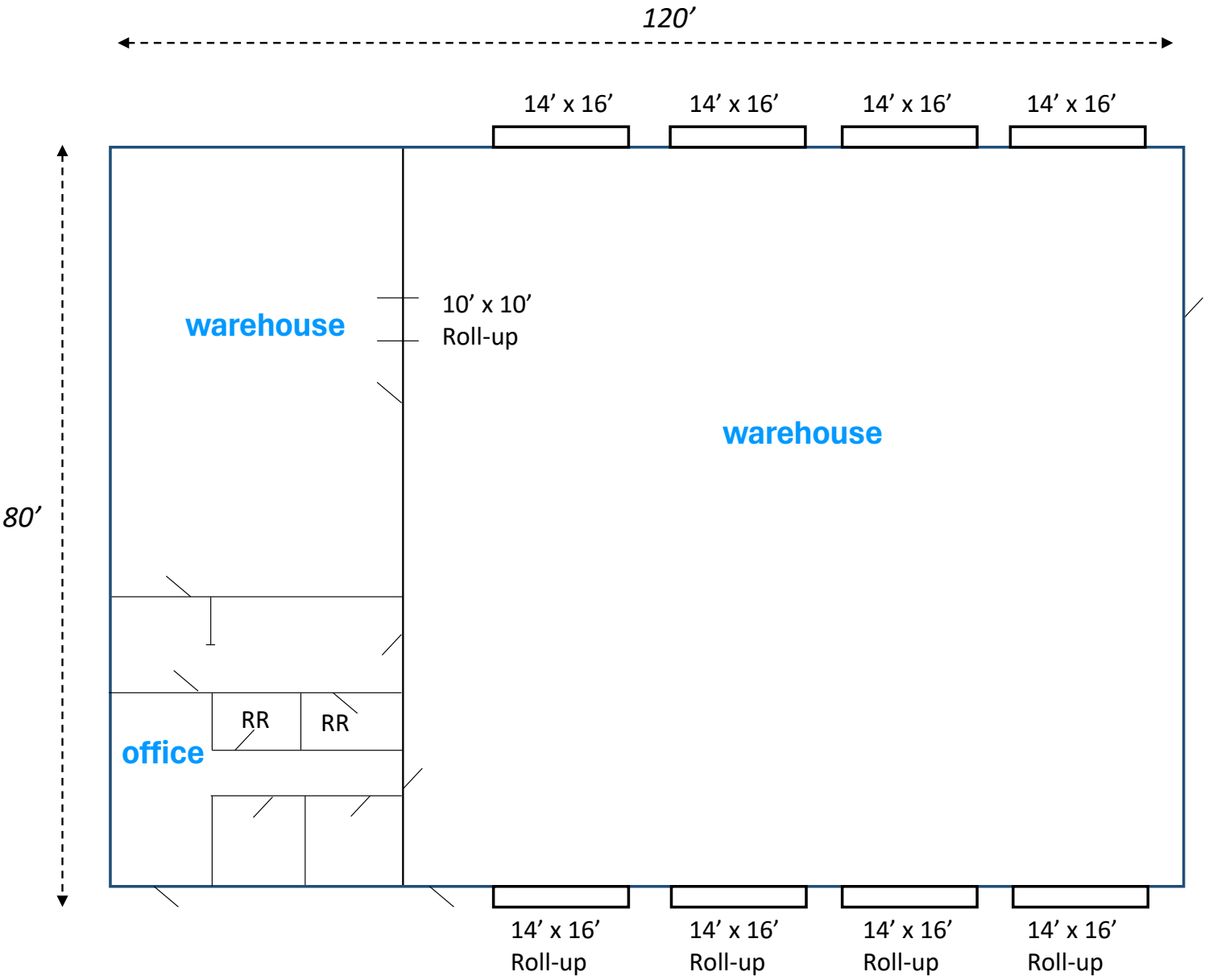
PROPERTY HIGHLIGHTS
