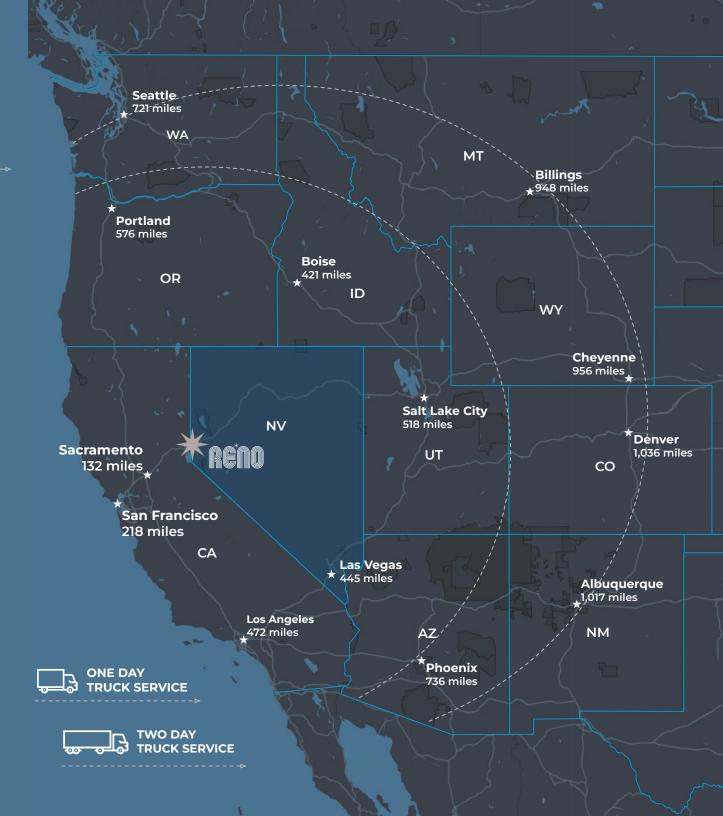
## **TRANSPORTATION**
