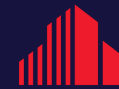

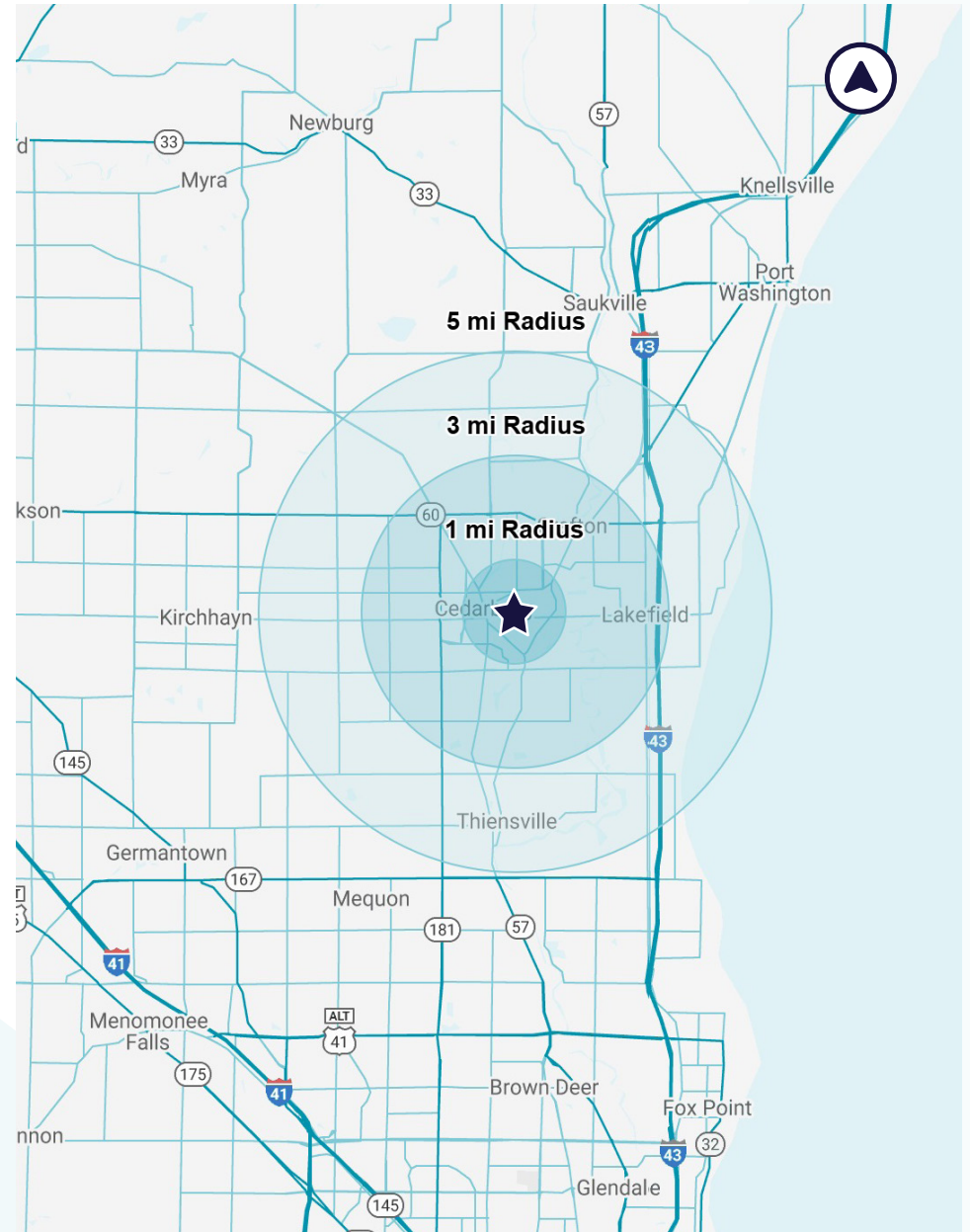

- (f) The duty to safeguard trust funds and proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals. Other property held by the Firm or its Agents.
- (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

This disclosure is required by section 452.135 of the Wisconsin statutes and is for information only. ### DEFINITION OF MATERIAL ADVERSE FACTS
