

## ABOUT THE ORANGE COUNTY NY

Orange County, situated in southeastern New York State, lies within the scenic Hudson Valley region. Originally established in 1683, it was redefined to its present boundaries in 1798 and named in honor of William III of Orange. According to the 2020 U.S. Census, the county has a population of 401,310, with Goshen as its county seat.

The county includes numerous towns and villages, such as Chester, Cornwall, Goshen, Monroe, New Windsor, Warwick, and the village of Florida. It is within the Kiryas Joel-Poughkeepsie-Newburgh metropolitan statistical area, which forms part of the larger New York–Newark–Bridgeport combined statistical area.

Orange County offers a variety of services and attractions. The county government provides resources in arts and entertainment, behavioral health, and community news. Additionally, the Department of Motor Vehicles operates offices in Goshen, Middletown, and Newburgh.

Orange County has experienced economic growth in recent years. In 2023, visitor spending reached approximately \$1.2 billion, reflecting a 7.6% increase from the previous year. Additionally, the county generated \$239.8 million in sales tax year-to-date in 2024 and is projected to generate \$412.3 million for the year.
