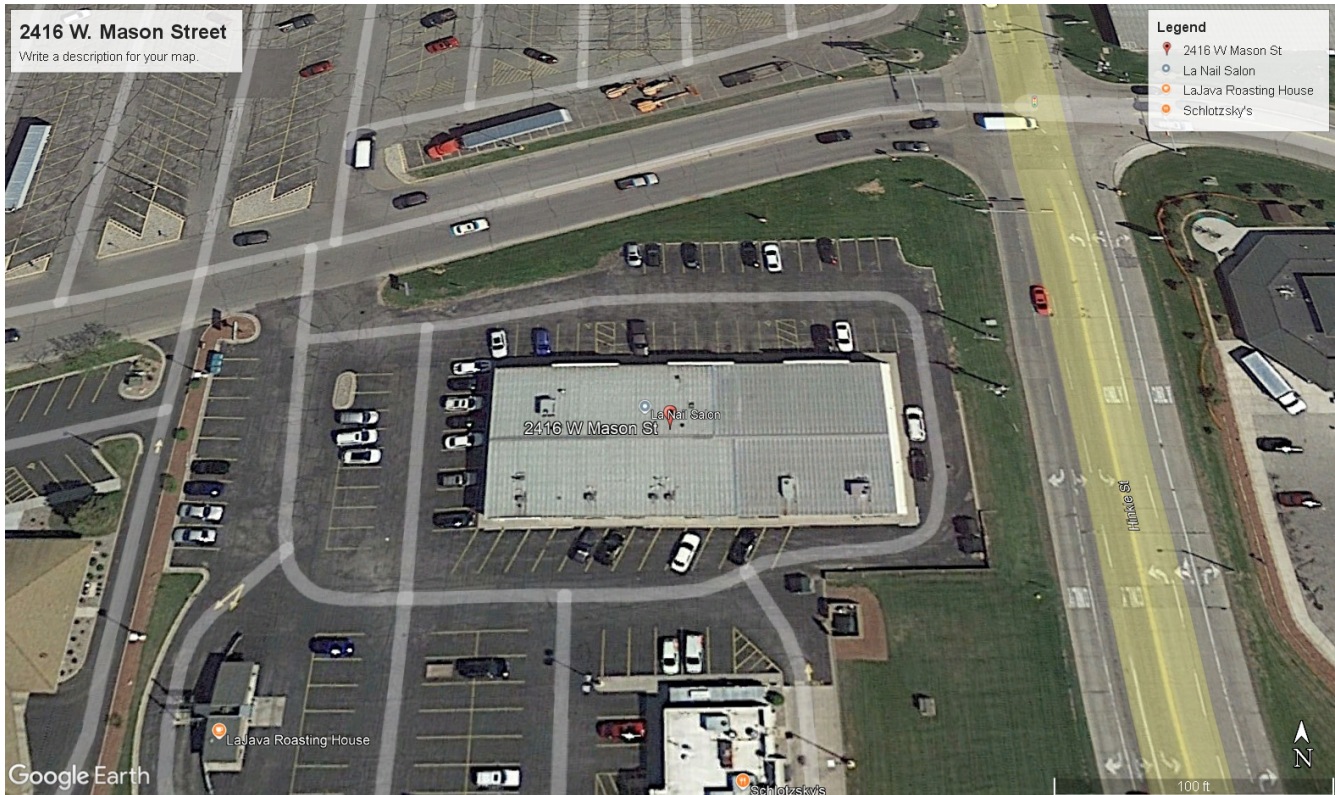

NEIGHBORHOOD MAP



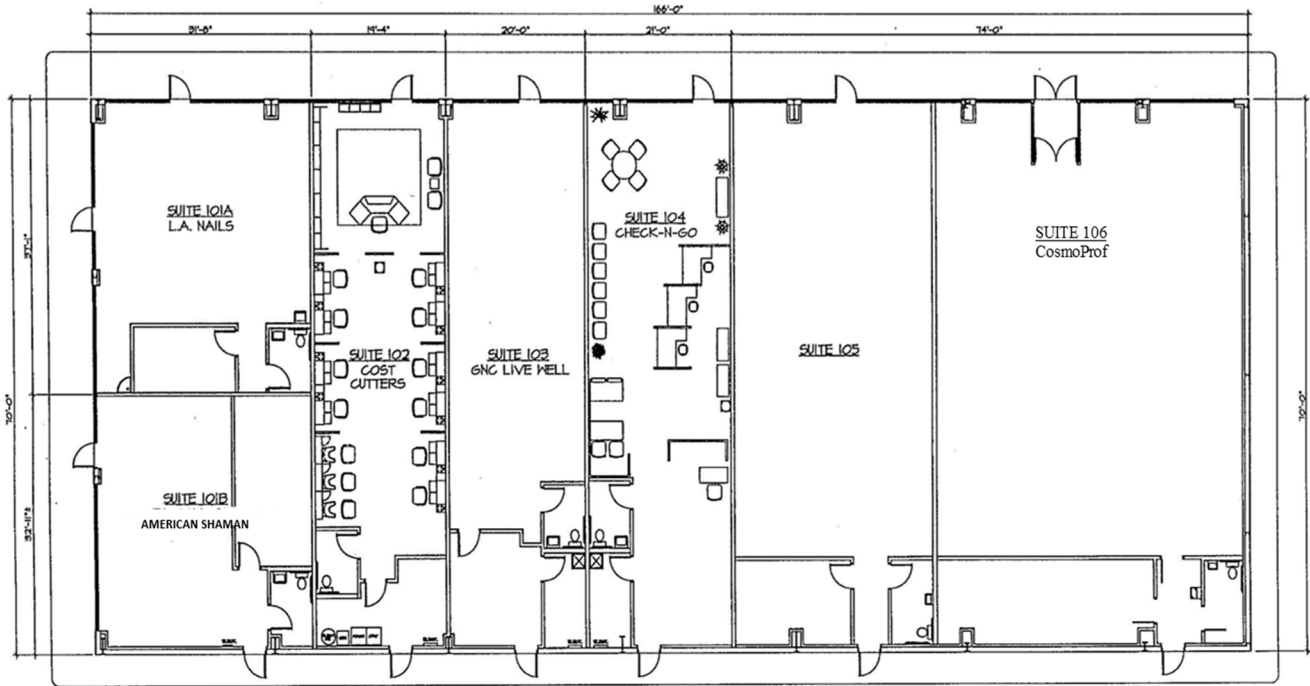

STATE OF WISCONSIN BROKER DISCLOSURE
