This parcel is a portion of Government Lot 1 of Section 32, Township 33 North, Range 6 East of the Boise Meridian, Idaho County, Idaho. and is more particularly described as follows:

COMMENCING at the northeast corner of said Government Lot 1, a found brass cap monument;

Thence South 0° 11' 11" West along the east boundary of said Government Lot 1 a distance of 628.36 feet to a found 5/8 inch diameter rebar on the north boundary of Tax 40;

Thence North 69° 20' 44" West along said north boundary a distance of 22.76 feet to the **TRUE POINT OF BEGINNING**, a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence South 19° 27' 27" West a distance of 68.20 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence North 79° 53' 22" West a distance of 97.94 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence South 14° 00' 06" West a distance of 167.12 feet to a point on the south boundary of Tax 40, being the northerly right-of-way for U.S. Highway 12 as described in the Warranty Deed recorded as Inst. No. 412825, a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence traversing the boundary of said Tax 40 as follows:

North 86° 04' 32" West a distance of 385.32 feet to a found 5/8 inch diameter rebar;

North 3° 38' 18" West a distance of 390.06 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

South 87° 30' 07" East a distance of 191.06 feet to a found 5/8 inch diameter rebar;
