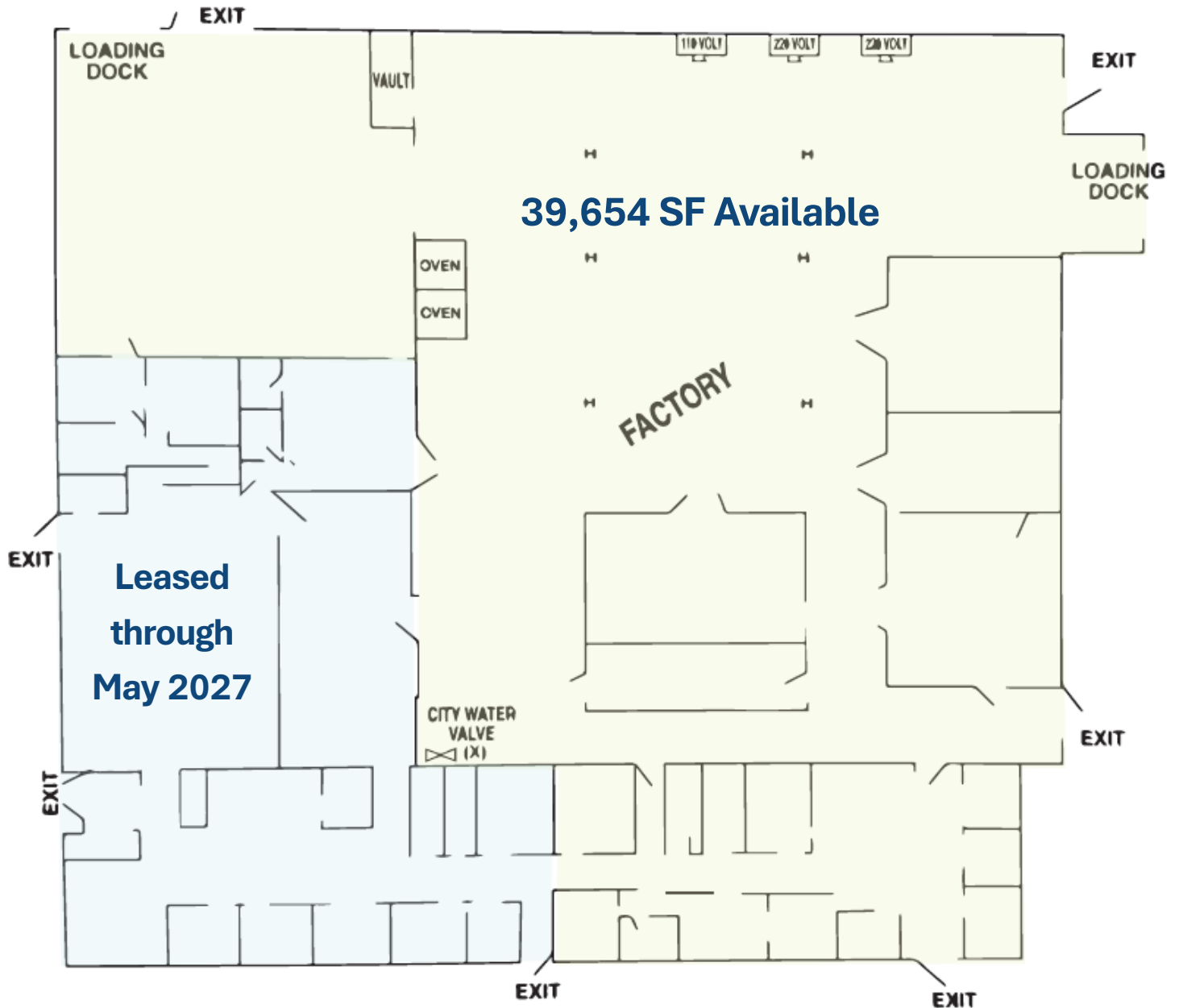

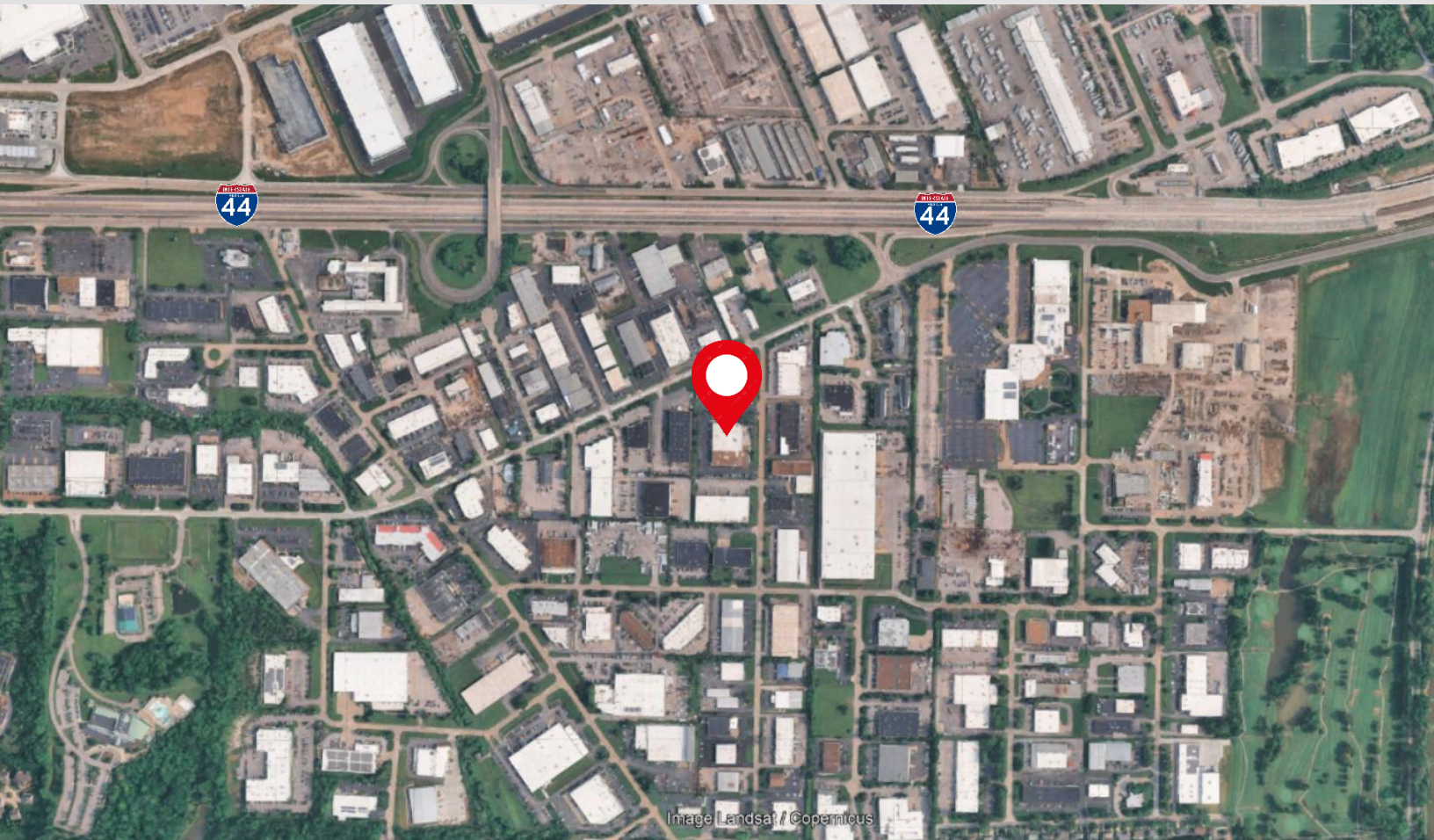
Floorplan
