

Liberty City

Liberty City is one of the most culturally rich parts of Miami, and a place that tourists are unlikely to visit. for now.

The neighborhood carries a story as real and honest as american history itself. Rooted in a sense of family and community, but carrying the weight of racial connotation, inherently giving it a rich sense of culture, vibrance, and a search for liberty and expression.

Legend says Martin Luther King recited an early version of his speech "I Have a Dream" at the historic Hampton House. The Hampton House Motel was an oasis for African-American leaders, activists, performers, and professional athletes, including Dr. Martin Luther King Jr., Sammy Davis Jr., Duke Ellington, Nancy Wilson, Louis Armstrong, Jim Brown, Malcolm X, and Muhammad Ali.

Once described as the "Jewel of Black Miami," the Hampton House Motel was a unique and important site. The Hampton House was among the most modern and upscale facilities available to Blacks in Miami before desegregation. And in an era when hospitals, schools, and beaches were segregated, the Hampton House was open to people of all races. Furthermore, it was a center of local and national political, civic, and cultural activity. One only needs to speak to people who visited the hotel during its years of operation to understand how much the swirl at the Hampton House captured and inspired imaginations.

Whereas Overtown was the entertainment district in the Jim Crow Era, Liberty City was the gathering point for civil rights minds of the time.

Few places around the nation carry the cultural significance of Liberty City, making this area ripe for a revitalization driven by its local culture and history.
