This mixed-use owner-user opportunity in the dynamic SoMa District of San Francisco presents a contemporary setting for both commercial and residential occupancy.




Initial Development Concept

Approved plans include a sustainable 5-story office building featuring eco-friendly Cross Laminated Timber (CLT) and a glass facade, creating a light-filled workspaces.

The 55-foot tall structure could yield 17,360 square feet with 3,300 square feet for commercial retail designed to become a restaurant and 11,740 square feet for office use. Parking will be included for ten bicycles.


