CAMPGROUND STAFF

Lost Valley is staffed seasonally by over fifty young men and women who commit six weeks of their summer to serving youth with quality programs in a wide variety of outdoor activities and new skills.

WATER

Lost Valley Campground & Reservation has two (2) large storage tanks providing gravity fed water throughout, part of the extensive water distribution system. There are on-site wells for both irrigation & portable water.

Two (2) wells, a 75 gpm and a 25 gpm

1M gallon water storage, consists of two (2) 425K gallon tanks and one (1) 60KK tank, balance in the piping

4" and 6" main lines

Head pressure from tanks feeds water system at approximately 40 psi for potable water & fire protection

Approximately 40 psi

±2 acre lake fed by well/solar pump

Water has been state tested and approved

Historic Agua Cliente Creek crosses the property diagonally along the valley meadow

A HIDDEN GEM IN CALIFORNIA'S COUNTRYSIDE

Warner Springs is unique blend of tranquility, natural beauty, and a close-knit community.

Greater Warner Springs is a rural back-country area, and set of springs, of San Diego County, in the North Mountain Sub-Region, that lies in a valley at the foot of the east side of Palomar Mountain. Juan Jose Warner received the 26,689-acre Rancho San Jose Del Valle Mexican land grant in 1844, and renamed the area Warner Springs. Warner established a trading post that served travelers between New Mexico and Los Angeles, thus instilling Warner Springs in California's history and future.

Warner Springs is the wild turkey capitol of this part of the world for hunters, and an important part of the Pacific Crest and California Hiking trails. It is associated with two National Historic Landmarks, the Oak Grove Butterfield Stage Station and Warner's Ranch, both connected to the Butterfield Overland Mail stagecoach line. Warner Springs is also popular for gliding due to the topography of the area, most commonly the Peninsular Ranges.



JULIAN, CA

Julian is a historic gold mining town located approximately one hour east of San Diego and roughly one hour and thirty minutes south of Lost Valley Campground.

Famous for its apples and superb apple pie, Julian has become the

center for visitors who wish to stay in the mountains, but take day trips to the nearby casinos, the Anza-Borrego Desert State Park and the coast.

Julian is known as "the B&B capital of Southern California" with its romantic atmosphere. Julian is also quickly becoming a great destination for families, hikers, weddings and corporate retreats.

Specialty shops line the historic streets of Julian, with unique attractions ranging from wineries, to gold mines, to a wolf preserve.

ANZA-BORREGO DESERT STATE PARK

Located just two hours east of San Diego's beaches and one hour thirty minutes of Lost Valley Campground, Anza-Borrego Desert SP is California's largest state park. It protects 600,000 acres of desert terrain, including dramatic badlands, cool palm oases, twisting slot canyons, and cactus-studded slopes.

Ricardo Breceda's 130 enormous metal sculptures. They depict prehistoric animals that once roamed this land, such as a saber-tooth cat, as well as an assortment of mythical creatures, including a 350-foot-long serpent.

SCHOEPE SCOUT RESERVATION




Countless camping excursions are just a few of the once-in-a-life adventures waiting for you at Schoepe Scout Reservation at Lost Valley, in Warner Springs.
