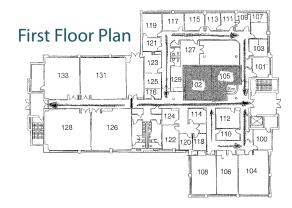

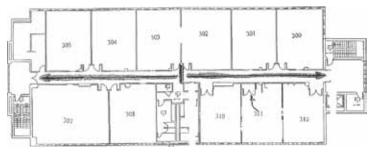
FLOOR PLANS

Third Floor Plan

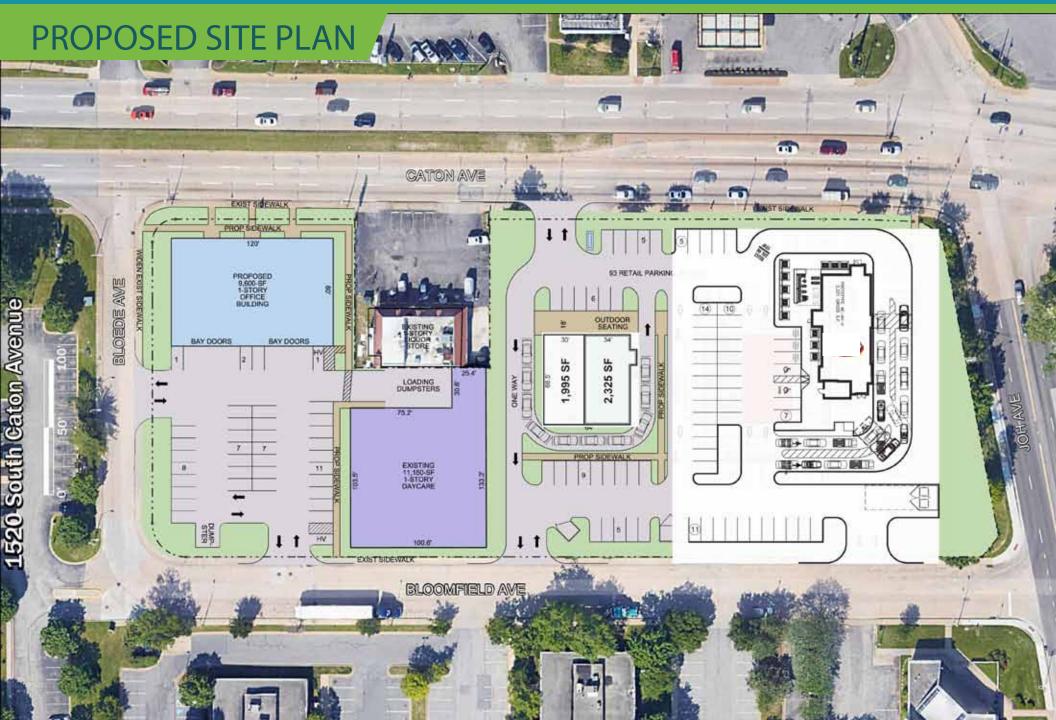

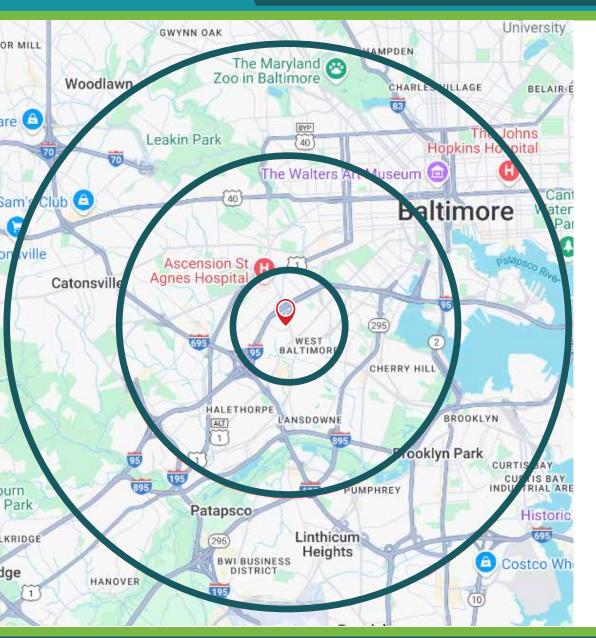

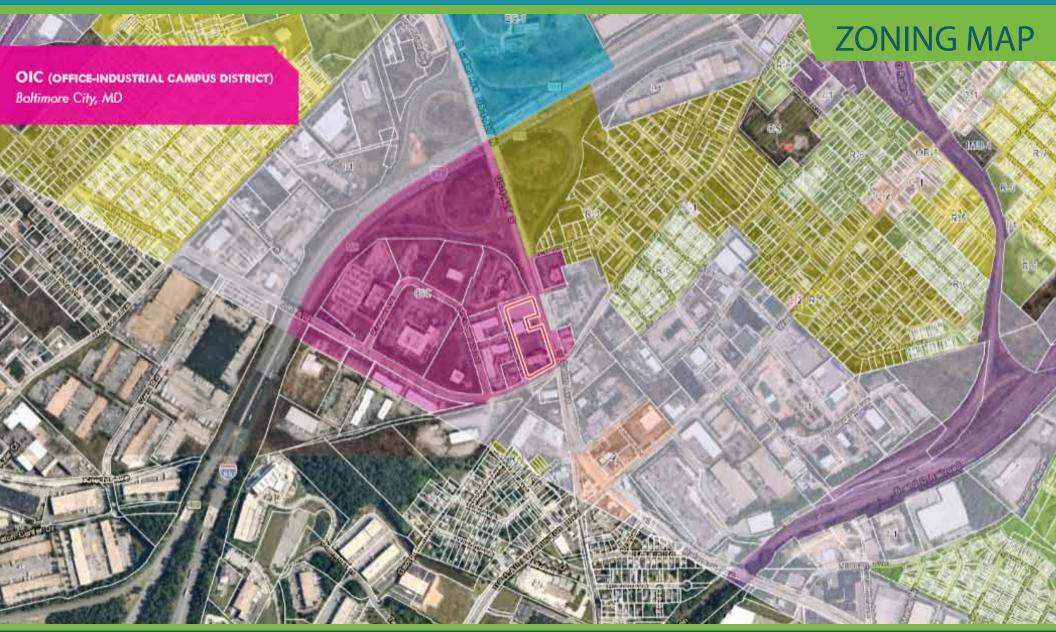
