1210 Fourier Drive offers a rare opportunity to acquire a ±27,910 SF, well-maintained office asset on 2.44 acres in Madison's West submarket. Built in 1995 and renovated in 2013, the vacant building provides immediate flexibility for owner-occupants or investors pursuing office, education, biotech, or childcare uses. The property features approximately 104 parking stalls and a floorplan conducive to multiple re-use strategies.

Offered at \$2,500,000 (\$89.57/SF), the asset presents an attractive basis with clear upside. To support a smooth and efficient transaction, the Seller has a previous Property Condition Assessment (PCA), Environmental Site Assessment (ESA), building plans, and a survey available for Buyer review.





State of Wisconsin - Disclose to Non-Residential Customers

Prior to negotiating on your behalf the brokerage firm, or an agent associated with the firm, must provide you the following disclosure statement:
