Site Plan

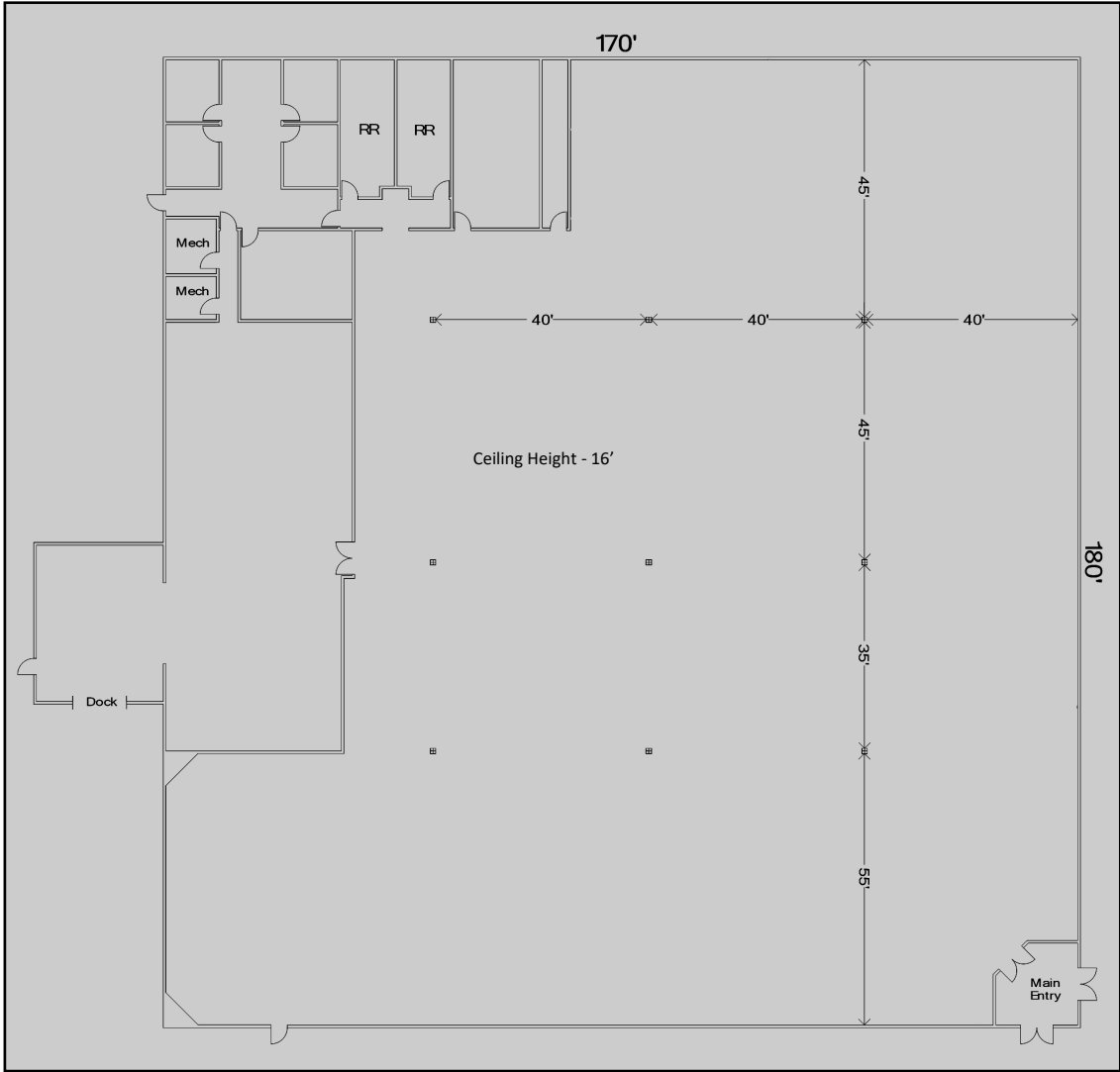

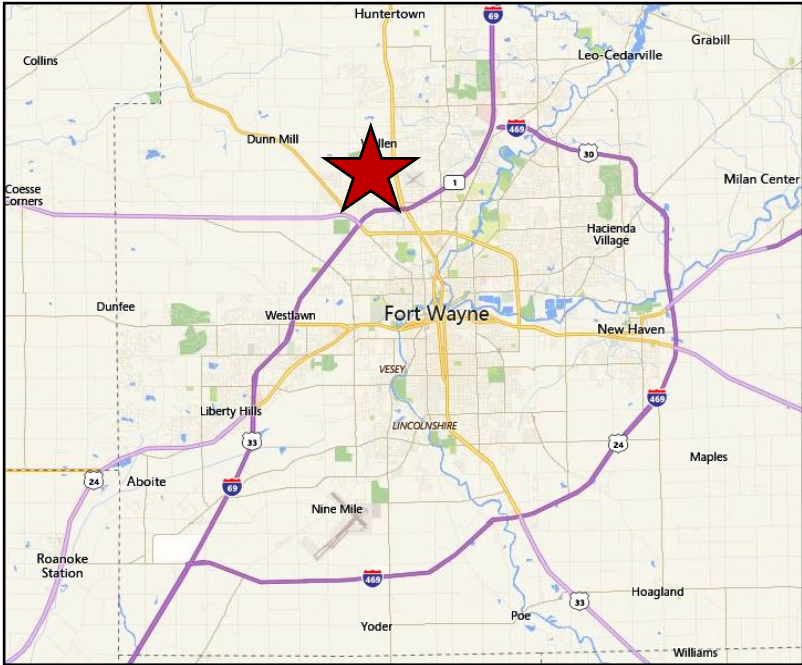
Floor Plan

LOCATION OVERVIEW

FORT WAYNE-ALLEN COUNTY, INDIANA

Fort Wayne-Allen County is an economic engine in the Northeast Indiana region, located between the Chicago, Detroit, and Indianapolis metro areas, along the border of Ohio. With over 250,000 residents, Fort Wayne is the **second largest city in the state of Indiana**.

The Fort Wayne Metropolitan Statistical Area (MSA) is now comprised of **only Allen and Whitley Counties** as of 2018, and has an estimated total population of approximately **406,633 residents**, according to U.S. Census Bureau population figures. The Fort Wayne-Huntington-Auburn Combined Statistical Area (CSA) has a reported population of approximately 570,000.

The Fort Wayne metro boasts a **broadening range of economic industries**, including finance and insurance, manufacturing, healthcare, craftsmanship, distribution and logistics. Employment rates are rising, with over **1,800 new jobs** and \$81 million in new annual payroll as of 2018, while unemployment rates dropped to an average of 3.1 percent in 2018, well below the current national average of 3.8 percent.

Fort Wayne and Allen County see approximately **6.5 million visitors annually**, who spend an estimated **\$741 million** in retail, lodging, entertainment purchases at attractions, festivals, and parks throughout the county. Tourism generates **\$94 million** in local tax revenue and sustains over **14,000 jobs**. Notable attractions include one of the **nation's top ten zoos**, the Fort Wayne Children's Zoo, as well as the Allen County War Memorial Coliseum, the Genealogy Center of the Allen County Public Library, a hands-on Science Center, automobile museum, and more.

Currently, over **40,000 college students** are enrolled in Allen County educational institutions, such as Purdue University Fort Wayne, Indiana University Fort Wayne, Ivy Tech Community College, and Indiana Wesleyan University. Over **200,000 students graduate annually** from area tier 1 and tier 2 research universities to enter the growing Fort Wayne work force.

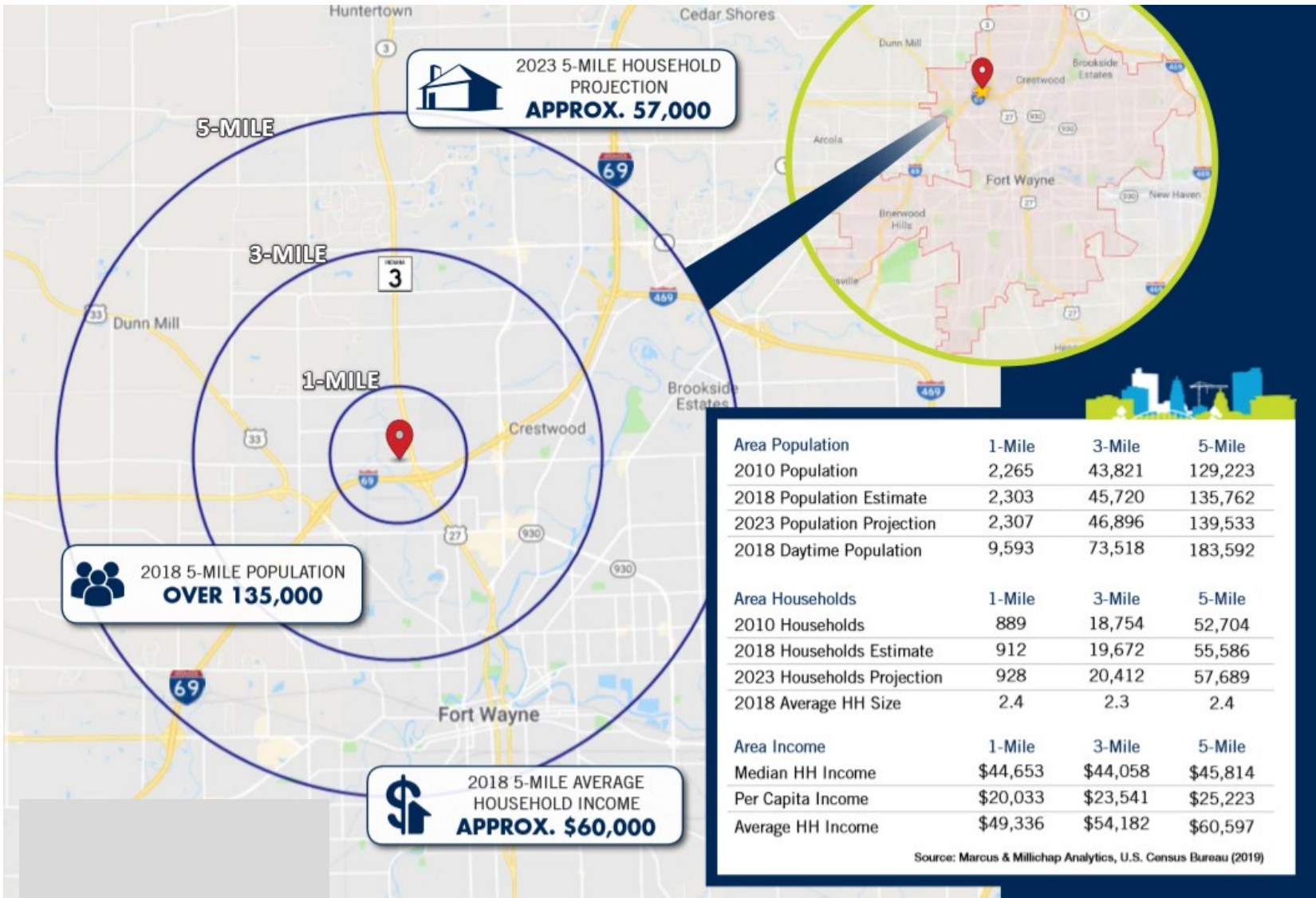
