





ALUMINUM EDGE W/ GRAVEL DRIP STRIP





- 1. CONTRACTOR SHALL MAKE A SITE VISIT PRIOR TO BIDDING TO EXAMINE EXISTING CONDITIONS FOR THEMSELVES. CONTRACTOR TO FAMILIARIZE THEMSELVES W/ DESIGN DOCUMENTS NOTES & DETAILS AND THE MASSACHUSETTS
- DEPARTMENT OF PUBLIC WORKS STANDARD SPECIFICATIONS FOR HIGHWAYS AND BRIDGES, CURRENT EDITION. 2. CONTRACTOR SHALL NOTIFY / COORDINATE WITH THE CITY OF MARLBOROUGH. PRIOR TO PLANT MATERIAL
- 3. CONTRACTOR SHALL COORDINATE WITH THE CITY OF MARLBOROUGH.
- 4. PRIOR TO THE PRE-CONSTRUCTION MEETING THE CONTRACTOR SHALL CONTACT DIG SAFE @ 1-888-344-7233 TO HAVE THE EXISTING UTILITIES MARKED.
- 5. ALL CONTRACTORS SHALL INSPECT SITE PRIOR TO BIDDING TO VERIFY EXISTING CONDITIONS FOR THEMSELVES. 6. THE CONTRACTOR SHALL SUPPLY ALL PLANT MATERIAL IN QUANTITIES SUFFICIENT TO COMPLETE
- THE PLANTING SHOWN ON THE DRAWINGS. SEE SPECIFICATION. 7. ALL PLANT MATERIAL SHALL CONFORM TO THE MINIMUM GUIDELINES ESTABLISHED BY "THE AMERICAN
- STANDARD FOR NURSERY STOCK", PUBLISHED BY AMERICANHORT 2014, AND AS AMENDED. 8. ALL PLANTS TO BE BALLED IN BURLAP OR CONTAINER GROWN, NO PLASTIC BURLAP.
- 9. ALL PLANTS TO BE APPROVED BY THE LANDSCAPE ARCHITECT. 10. STAKE LOCATION OF ALL PROPOSED PLANT MATERIAL FOR APPROVAL OF LANDSCAPE ARCHITECT
- PRIOR TO COMMENCEMENT OF PLANTING. 11. THE LANDSCAPE CONTRACTOR SHALL GUARANTEE ALL PLANT MATERIALS FOR ONE (1) FULL YEAR
- FROM DATE OF ACCEPTANCE. 12. HEAL ALL CONSTRUCTION SCARS WITH NATURALIZED GRASS, LAWN OR MULCH AS INDICATED BY
- DRAWINGS AND / OR AS DIRECTED BY LANDSCAPE ARCHITECT.
- 13. "DRY ROOTS" SHALL BE ADDED TO ALL NEW TREE PLANTING PITS. ALL NEW LOAM SHALL BE TESTED AND AMENDED AS STATED IN THE LOAM REPORT. PROVIDED BY LOAM SUPPLIER.
- 14. LANDSCAPE CONTRACTOR SHALL SUBMIT A WATERING SCHEDULE PROGRAM FOR THE (60) DAY MAINTENANCE PERIOD FOR REVIEW BY THE LANDSCAPE ARCHITECT & THE OWNER FOR ALL PROPOSED
- PLANT MATERIAL.
- 15. PROTECT EXISTING PLANT MATERIAL WITHIN CONSTRUCTION LIMITS. PROVIDE WATERING
- PROGRAM FOR ALL PROPOSED / EXISTING PLANT MATERIAL DURING CONSTRUCTION.
- 16. ALL TRANSPLANTED PLANT MATERIAL IS OWNED BY THE CONTRACTOR AND SHALL BE PREPARED FOR TRANSPLANTING FOR EACH SPECIES AT THE APPROPRIATE SEASON. THE CONTRACTOR SHALL REPLACE ANY TRANSPLANTED PLANT MATERIAL THAT DIES WITH THE SAME SIZE AND SPECIES OF PLANT MATERIAL. THE NEW PLANT MATERIAL SHALL BE MAINTAINED & GUARANTEED AS NEW PLANT MATERIAL.

(VALLEY GREEN SEED, LTD. WILMINGTON, MA.) LANDSCAPE/UTILITY MIXTURE FOR SUN/SHADE: ENCHANTED PERENNIAL RYEGRASS CREEPING RED FESCUE GOLDRUSH KENTUCKY BLUEGRASS

- B. PLANT BEDS 1 -0" LOAM DEPTH IN THE PLANTED AREA WITH 2" MULCH.
- C. ISOLATED PLANTED ISLANDS 1' 0" LOAM DEPTH
- D. NEW ENGLAND WETMIX (WETLAND SEED MIX) 4" ROLLED THICKNESS, MIN.
