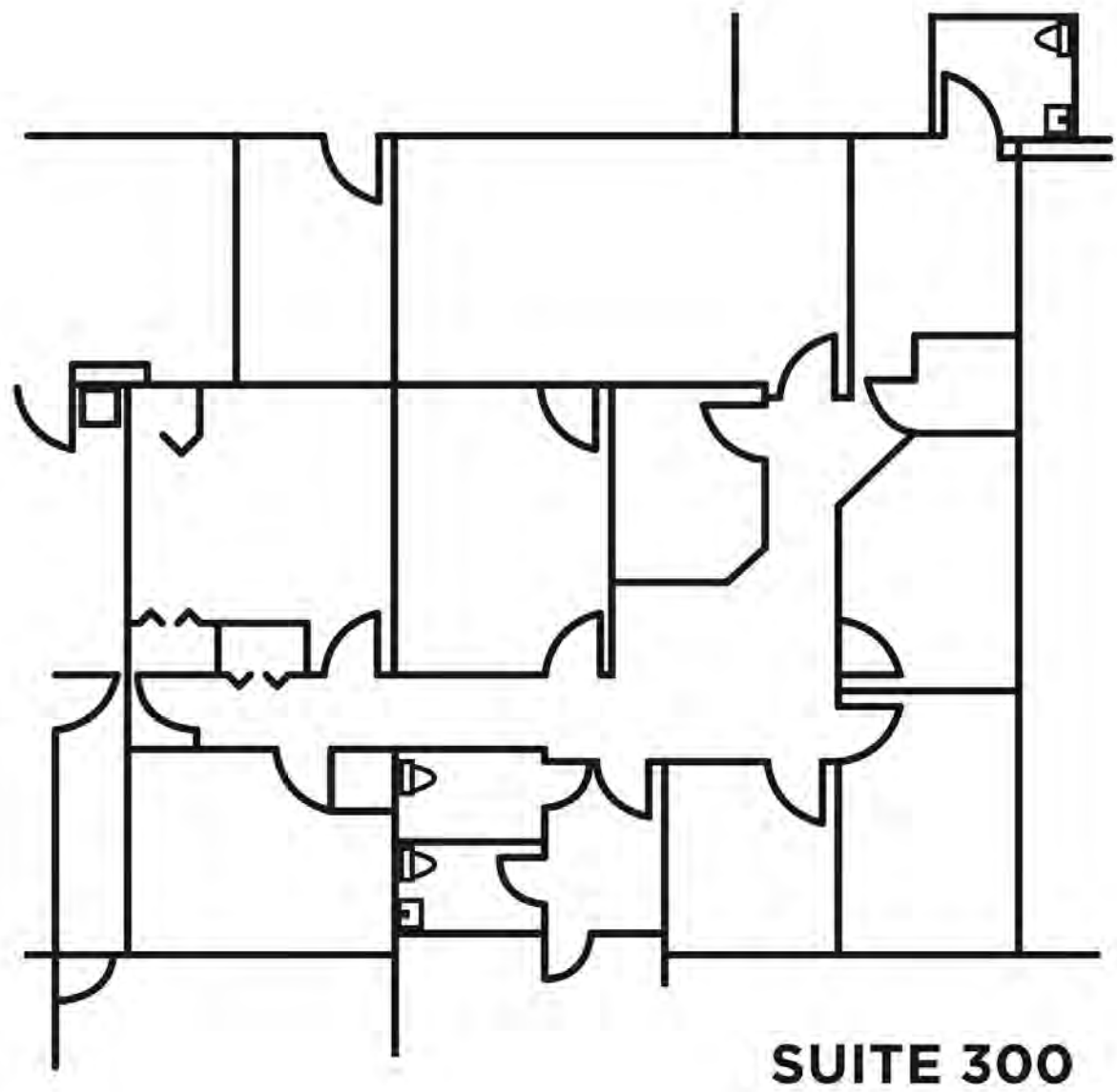

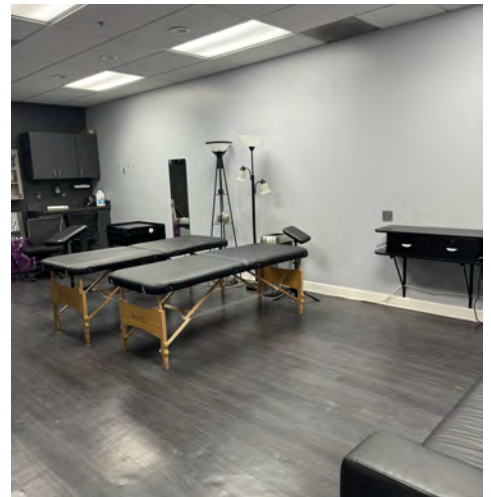
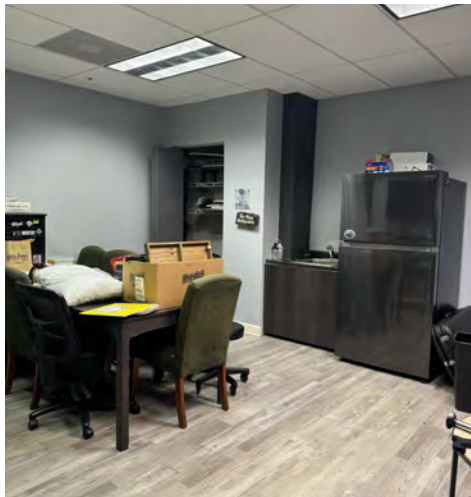
FLOOR PLAN
