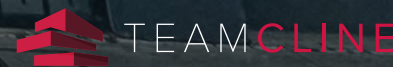

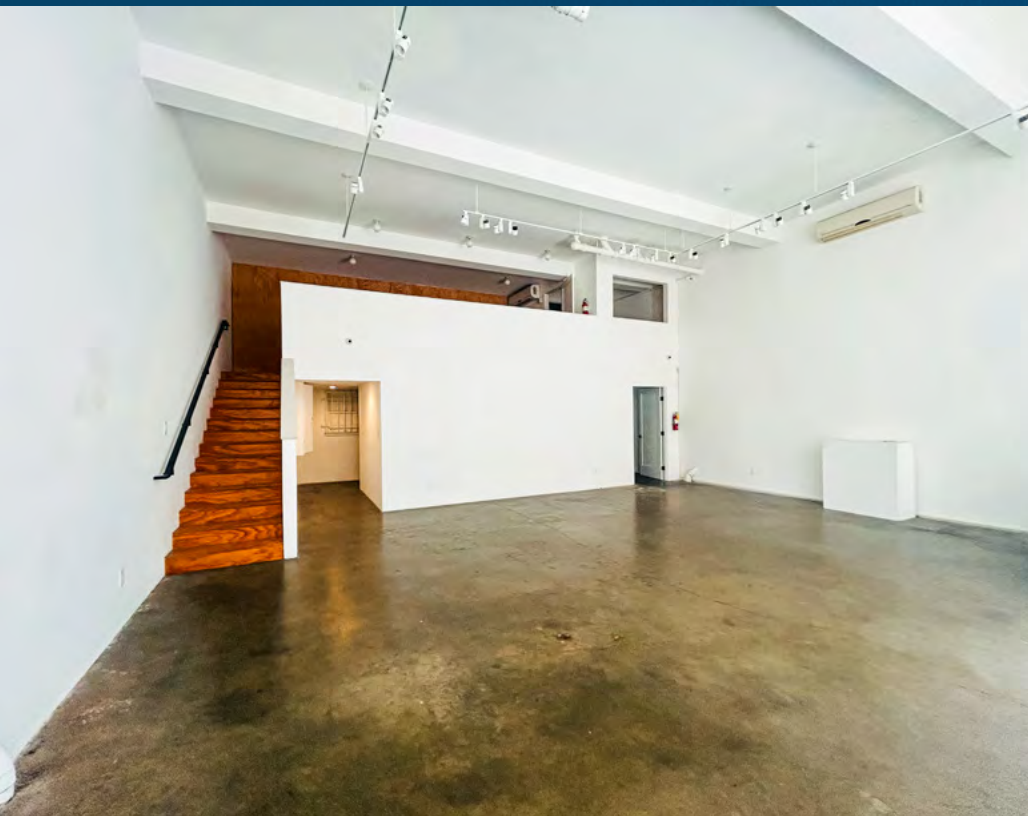

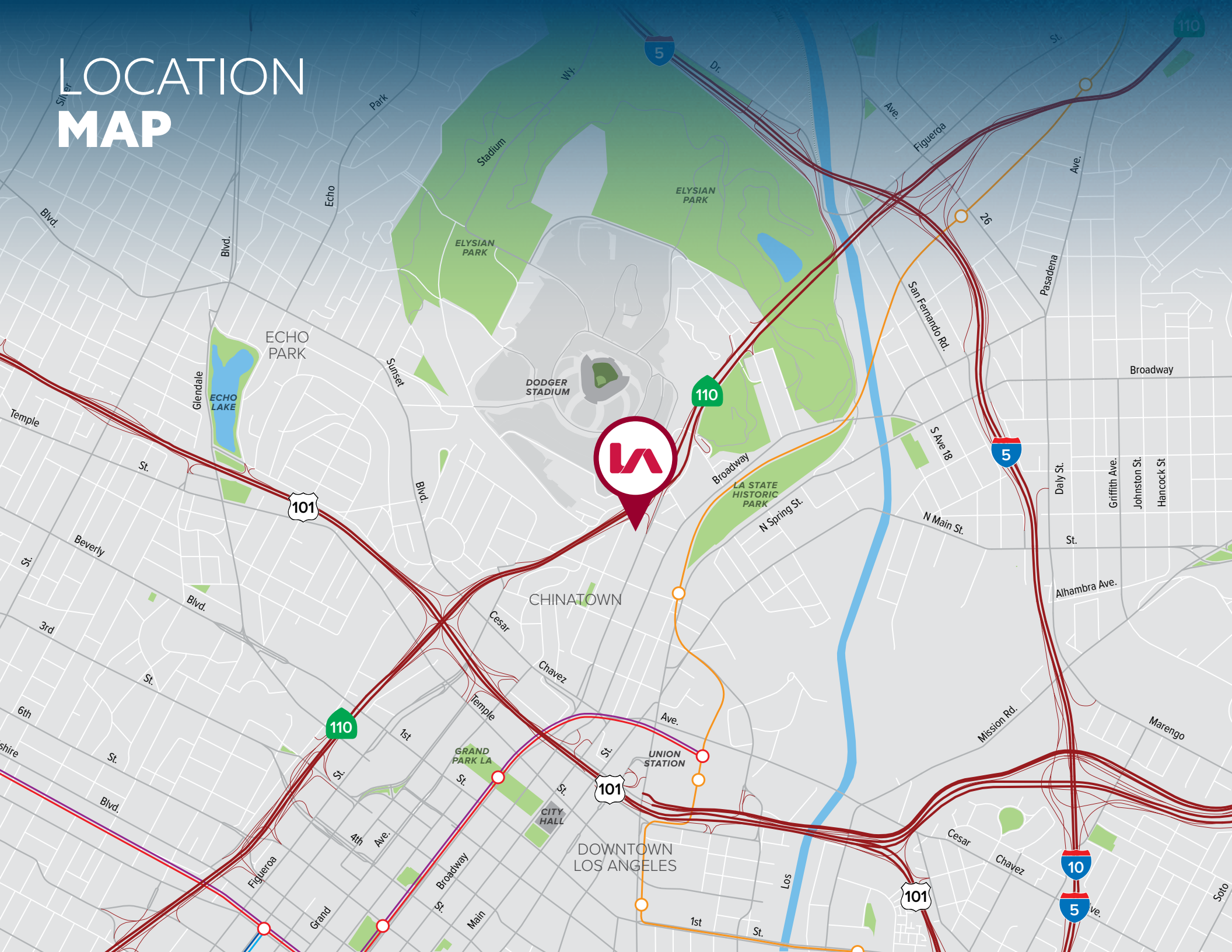
PROPERTY AERIAL





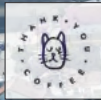


LOCATION MAP
