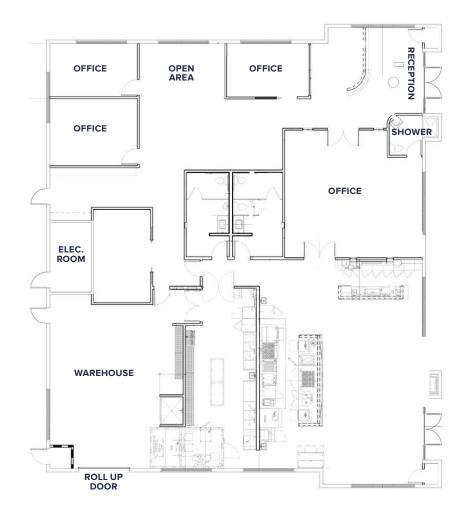
FLOOR PLAN

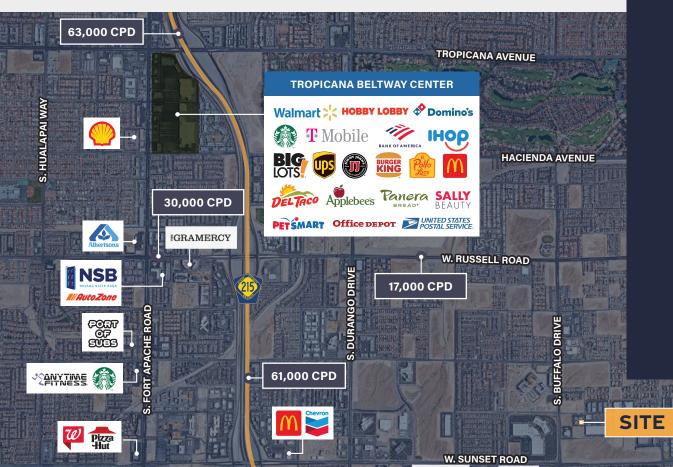

shops in the immediate area.



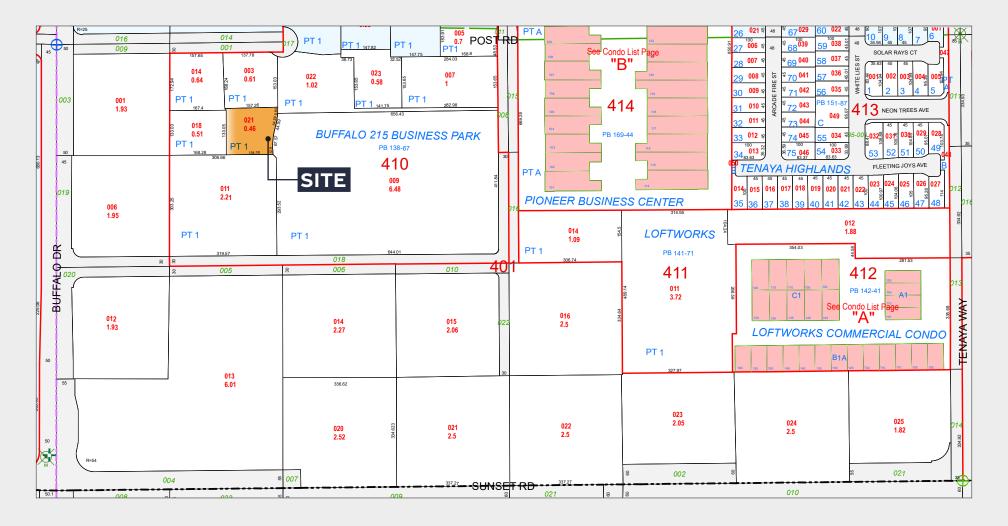
