

#### Location

The subject property is located in the southeast section of Allapattah, and is bordered by Wynwood on the eastern side, and the Miami Health District to the south. Ideally situated just blocks away from Interstate-95, the property benefits from being centered in a dense industrial/commercial neighborhood, that is surrounded by a myriad of major retailers and employers. Major employers in the area include Jackson Memorial Hospital and University of Miami Health System.
