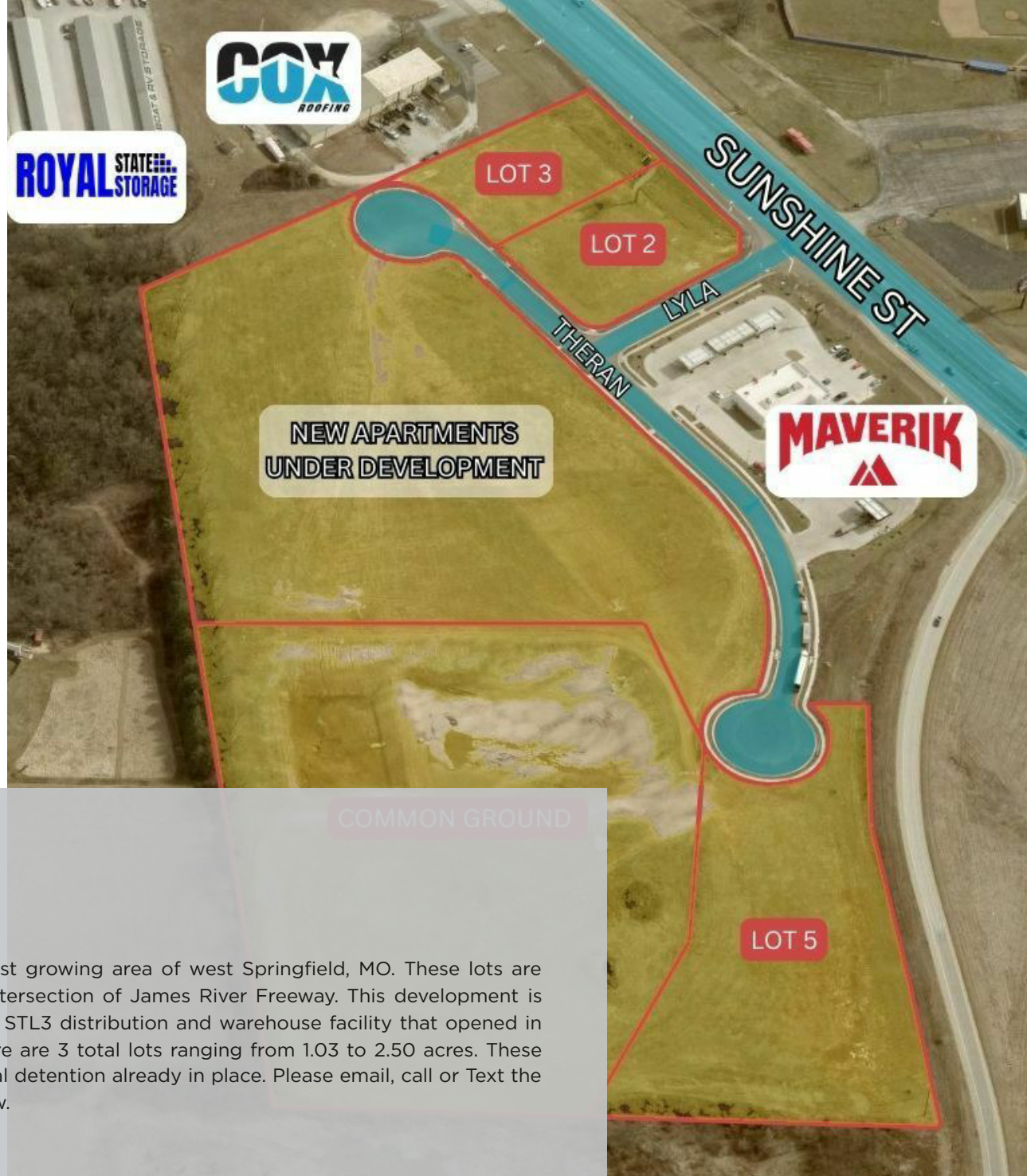

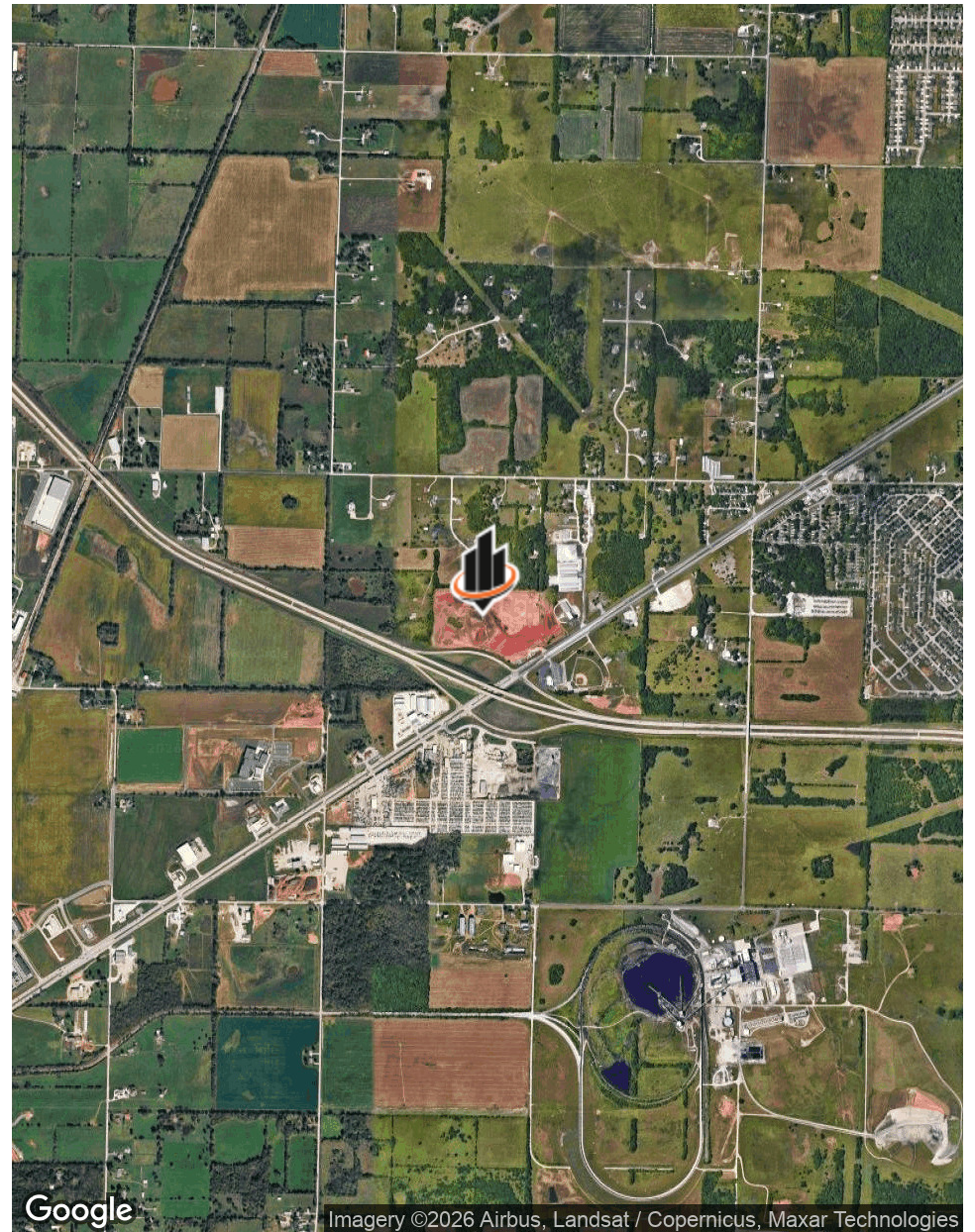
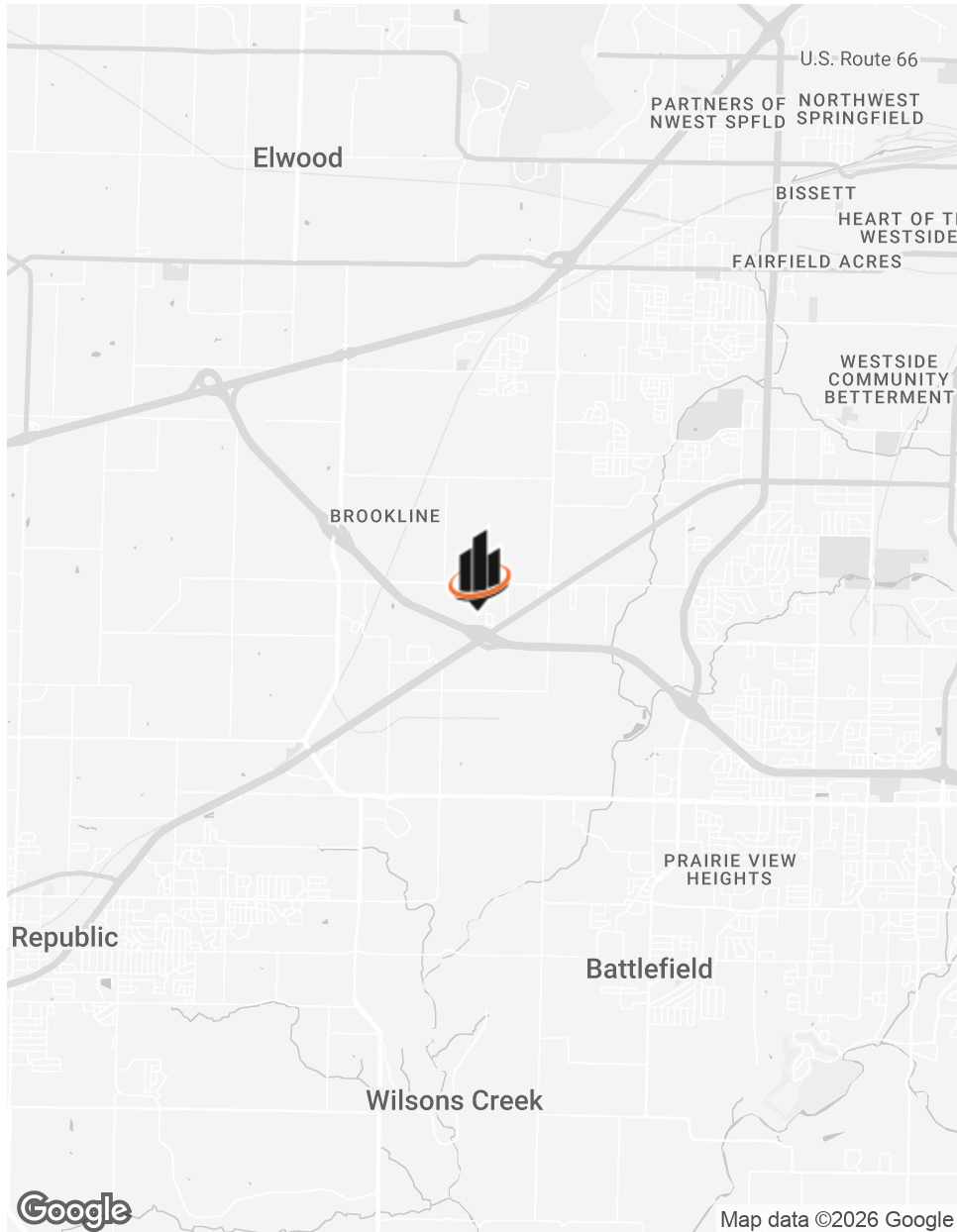

LOCATION MAP

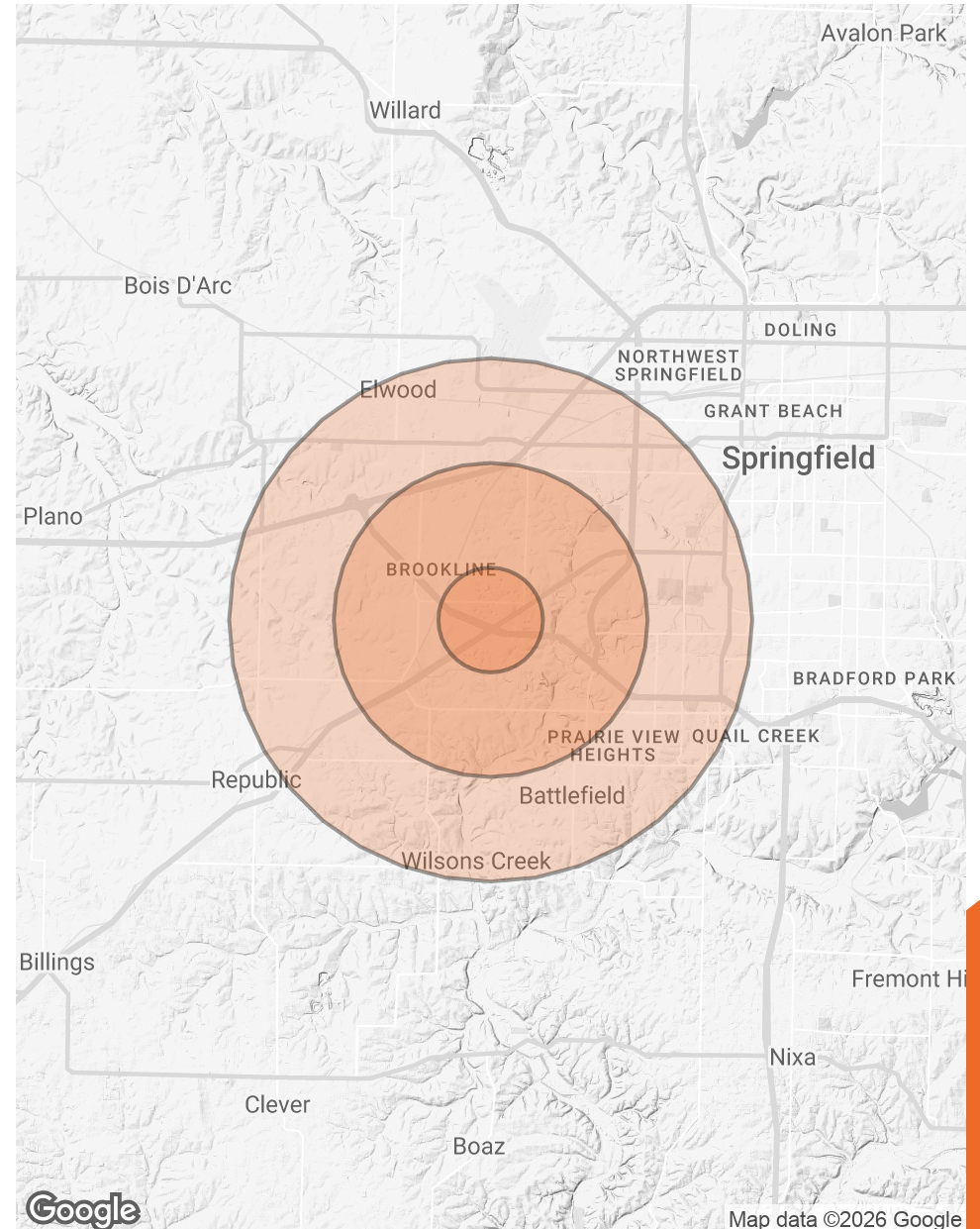
