The site offers functional improvements with on-site parking and loading areas, providing efficient circulation and accessibility for a variety of industrial users.

LOCATION DESCRIPTION

1401–1421 N. Clovis Avenue is located in northeast Fresno along Clovis Avenue, a major north–south arterial serving the city’s industrial and commercial corridor. The property is positioned at the NWC of Clovis Avenue and Lamona Avenue and is surrounded by a mix of light-industrial, warehouse, and service-oriented commercial uses. The location offers good visibility and convenient access to regional roadways, including nearby connections to Highway 180, making it well suited for industrial, flex, or commercial operations.



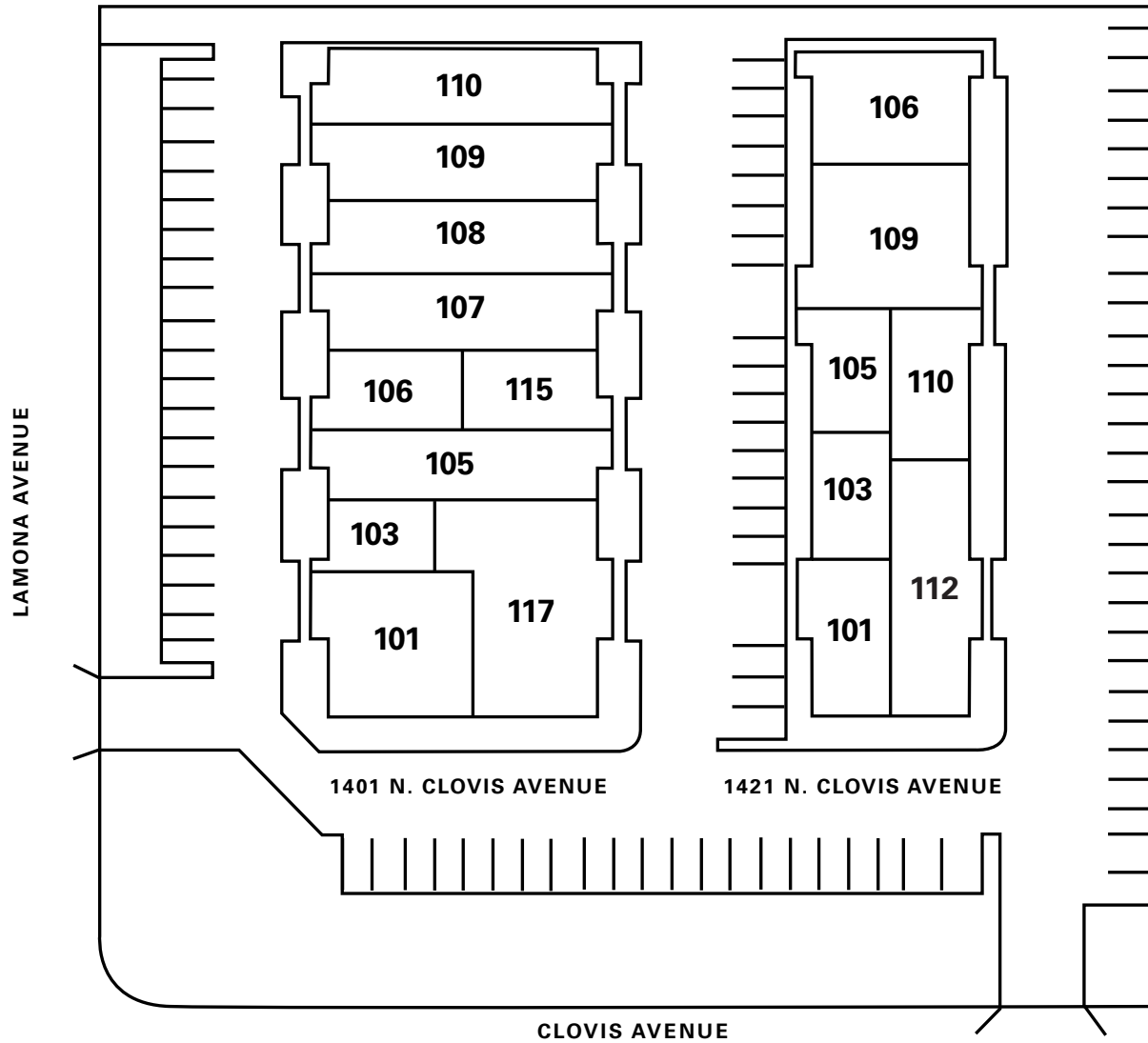

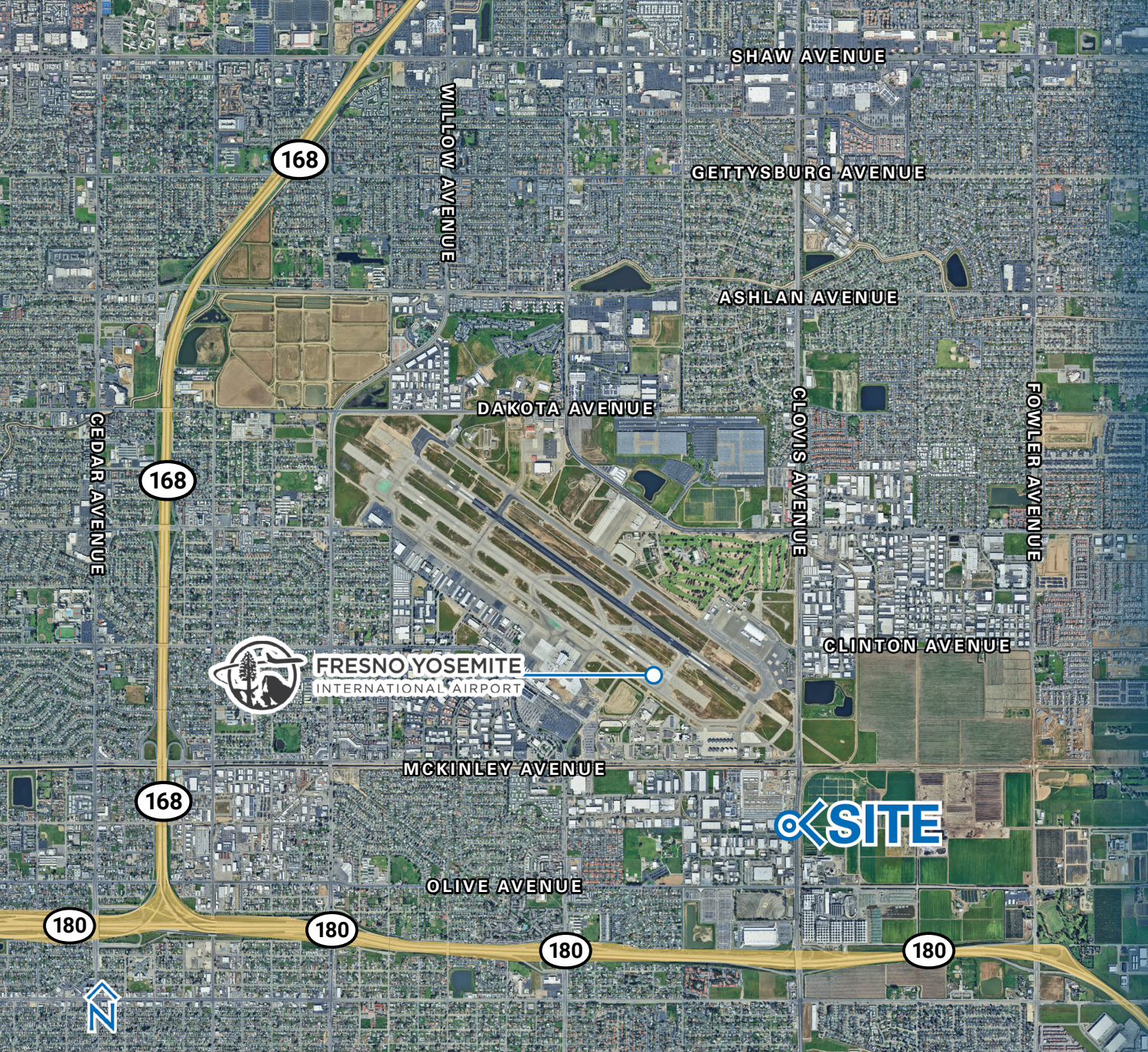
