

Uintah County, Utah

Located in eastern Utah, Uintah County makes up the Vernal Micropolitan Statistical Area.

Demographics

In 2021 Uintah County had an estimated a population of 36,676 people with a median age of 31.0 and a median household income of \$65,799. In the next 5 years the population is expected to grow by nearly than 1,700 people, a 4.6% increase, or almost 1.0% per year.

The median property value in Uintah County is \$197,000, and the homeownership rate is 75.9%. Most people commute by driving alone, and the average commute time is 18.7 minutes. The average car ownership is 2 cars per household.

Uintah County Workforce

The economy of Uintah County employs 14.9k. The largest industries are Mining, Quarrying, & Oil & Gas Extraction (2,427 people), Retail Trade (2,154 people), and Educational Services (1,464 people).

The highest paying industries are Utilities (\$78,211), Mining, Quarrying, & Oil & Gas Extraction (\$73,005), and Agriculture, Forestry, Fishing & Hunting, & Mining (\$70,466).

Compared to other counties, Uintah County has an unusually high number of residents working as Construction & Extraction Occupations (2.01 times higher than expected), Transportation Occupations (1.64 times), and Installation, Maintenance, & Repair Occupations (1.49 times).

Uintah County Economy

The local economy, once based on agriculture and mining, has diversified, and energy extraction and tourism are now major industries as well. In order to move oil out of the region, a new railroad is proposed to be constructed into the basin.

The extraction of natural resources including oil, natural gas, phosphate, and gilsonite constitute primary economic activity of Uintah County. There is some agriculture in Uintah County, primarily focusing on raising cattle and sheep, and cultivating alfalfa.


Recreational attractions bring many visitors to the area, some of those include Dinosaur National Monument, Starvation Reservoir State Park, Flaming Gorge National Recreation Area, Raven Ridge and Fantasy Canyon.

A significant portion of west Uintah County is taken up by the Uintah and Ouray Indian Reservation. The Ute Tribe's headquarters is in Fort Duchesne. Much of the rest of the county is land managed by the Ashley National Forest and the Bureau of Land Management. There is relatively little private land in Uintah County.
