South Main Street: 7,600

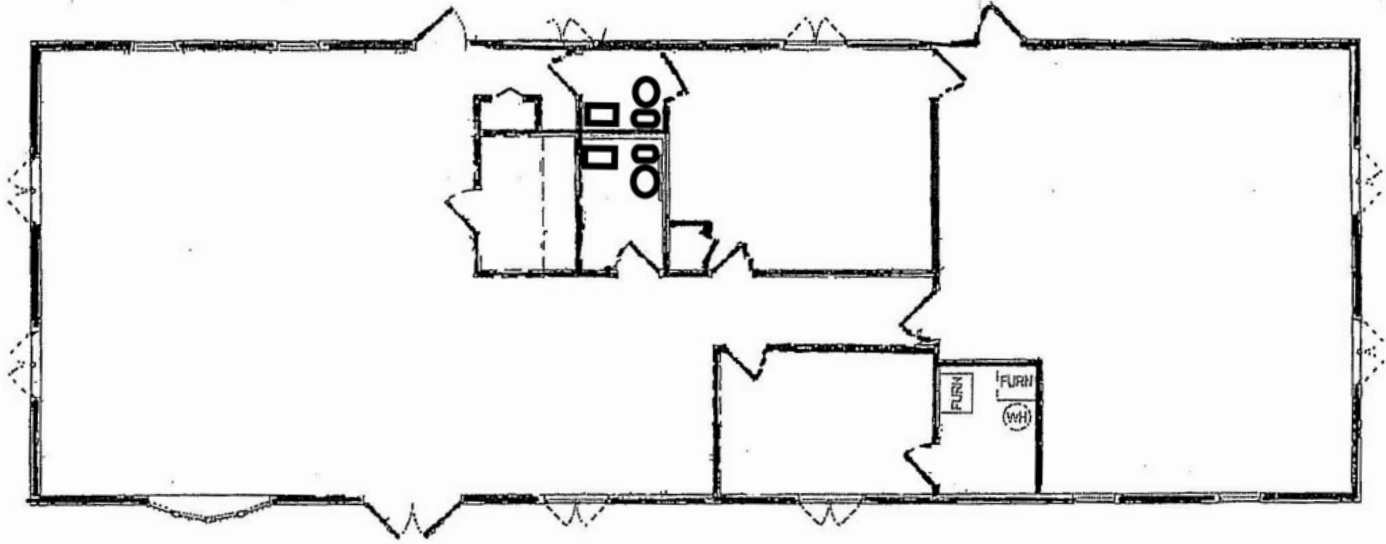

STATE OF WISCONSIN BROKER DISCLOSURE
